Khaleda attends son's chehlum

BNP Chairperson Khaleda Zia yesterday attended a special prayer and milad mahfil to observe chehlum of Arafat Rahman Koko at her Gulshan office in the capital.

Surrounded by her relatives, Khaleda prayed for the salvation of her son's departed soul with tears rolling down her cheeks, members of the BNP chief's media wing said.

They joined the prayers from Khaleda's office room on the first floor.

Koko, 42, died of heart failure at his rented house in Kuala Lumpur of Malaysia on January 24. He along with his wife and two daughters had been living there since 2008.

Widow of Koko and her two daughters came to Dhaka on January 27 to attend his funeral.

On February 2, his wife returned to Kuala Lumpur as their daughters were continuing their studies at an internationally reputed school there.

One relative of Koko was present in the chehlum, said a member of the media wing yesterday.

No leaders and activists of BNP or

its front organisations were seen trying to gather in front of Khaleda's office to attend the chehlum due to fear of police harassment and arrest.

Eminent jurist Rafique-ul Huq and expelled BNP leader Maj (retd) Akhtaruzzaman were the only persons outside the party who participated in

They separately called on the BNP chief at her office room.

the chehlum.

Police and special branch officials allowed 16 students and teachers of two madrasas to attend the chehlum after noting down details of their addresses and recording their video images.

Around 60 people, including four BNP leaders who have been staying inside Khaleda's office since January 3, also attended the chehlum.

The programme began at the ground floor of the office around 11:30am with recitation from the Holy Quran and ended after Asr prayers.

Mufti MM Ashraful Islam, a teacher of Mohammadpur Madrasa, conducted the munajat.

Later, foods (tehari) were distributed among the participants and people available outside the office.

9 cops closed in Kurigram for torturing lawyer

Nine policemen, including two subinspectors, were closed to district police lines yesterday afternoon for allegedly torturing a lawyer on the premises of Kurigram Chief Judicial Magistrate's Court on Tuesday.

The nine are Court Sub-inspector Moshiur Kabir, SI Wahiduzzaman Molla of Kurigram Sadar Police Station and seven constables.

Constable Emdadul Haque of Dhaka Metropolitan Police on December 14 last year had sued one Maidul Islam Nayan of Kurigram for kidnapping his wife Joshna Akhtar Manisha and looting valuables worth Tk 6 lakh from his house, said advocate Fakhrul Islam, general secretary of Kurigram Bar associa-

tion. Nayan surrendered before the court on January 1. Manisha, 31, on that day told the court that she married Nayan after divorcing Emdadul. The divorce papers were placed before the court, said Manisha's counsel Enamul Haque

Chowdhury Chad. The court sent Nayan to jail and ordered police to send Manisha to the safe home in Rajshahi. Nayan later secured bail from the court.

Police on Tuesday produced Manisha before the court. The magistrate freed Manisha but police tried to detain her on the court premises.

As her lawyer advocate Touhidul Islam Rasel protested the incident, cops assaulted him and took him to Kurigram Sadar Police Station in the afternoon, according to lawyers.

Incensed at the police action, lawyers boycotted court proceedings and demanded immediate released of Rasel. Police later freed Touhidul.

The abstention from court proceedings by lawyers continued yesterday. Members of the district Bar held a protest rally in the court area.

Murshedul Karim Mohammad Ishtesham, officer-in-charge of Kurigram Sadar Police Station, said the incident was a misunderstanding.

Kurigram Public Prosecutor Abraham Lincoln said the decision of the police administration has been positive. The lawyers will discuss their next course of action in a meeting tonight (last night), he added.

"She [Khaleda] won't abide by the

court order and won't appear before the court ... These are tarnishing the image of the court, and as a result none will abide by the court in future, and the country will go in that direction," she added.

she did not go to court.

Hasina said the BNP-Jamaat's ongoing movement had no backing of the

people and noted that she had talked to some former MPs of BNP and they informed her that they did not support the destructive activities, including killing and bomb attacks by the BNP-

His family had deserted it a good six years ago. But repeated requests from his family, ominous threats from a neighbour, a raging sun, torrential rain, numbing cold -- nothing could move him so much as an inch from the place where he was born and brought

remained mentally challenged for the most part of his life. So may be he is not even aware that his actions have staved off several attempts to grab this land over the past few years! May be he has never understood the value of this land in terms of money. Or may be a birthplace is not just a place to him; may be it has rather an aura of sanctity in his world.

Meanwhile, Jewel's family got the stay order cancelled in 2011. The Daily Star has gone through the court documents that confirm that Jewel's family has owned this property for over a century now. The grabber's appeal to review the cancellation of the stay

order was also turned down. But threats continued to be meted

over the phone. Nothing changed even after Jewel's siblings filed half a dozen general diaries and cases against the neighbour. So Jewel's family finally gave up on the land.

Chinese, Indian envoys hold meeting

New Chinese Ambassador to Dhaka Ma Mingqiang yesterday had a meeting with Indian High Commissioner Pankaj Saran.

The diplomatic circle in Dhaka considers the meeting held at the Indian envoy's residence around 10:30am critical in the current context of local politics.

Details of the 90-minute-long meeting could not be known immediately, but it is learned that the envoys of the two influential countries discussed the ongoing political

situation. Sources said they discussed the atest developments of a diplomatic move of 16 envoys to reduce the gap between the two major parties and forge a consensus between

The sources added the Indian and Chinese diplomats renewed their respective countries' position not to interfere into the internal matters of any country and expressed the hope that people of Bangladesh would resolve their problems peace-

The two envoys also expressed concern at the escalation of political violence, which has caused many deaths, casualties and destruction of public property.

Asked about the meeting, a spokesman of the Chinese embassy told The Daily Star that it was a courtesy call. A diplomat of the Indian High Commission also said, "It was a routine courtesy call by the

Chinese ambassador." The Chinese ambassador presented his credentials to President Abdul Hamid on February 2.

A local leader of Jubo League, youth front of the ruling Awami League, was gunned down by unidentified criminals at Mirikpur Bazar under Sadar upazila of Laxmipur early yesterday.

Locals discovered the body of Arifur Rahman Farhad, 30, joint convenor of Bangakhan Union unit of Jubo League, in a sawmill, and informed the police.

Nurul Amin Master said unidentified men called his son, Farhad, out of his home around 3:00 am. Following information received

from the locals in the morning, they rushed to the sawmill and found Farhad's body there. On learning about the incident, Laxmipur police rushed to the spot

and recovered the body.

swath of maritime boundary, the government has decided to buy or build eight OPVs, it said. Of the six ships to be purchased for BSC, three are oil tankers valued at \$36.20 million per tanker and three bulk carriers valued at \$25.30 million

per carrier, according to the shipping ministry proposal. These ships are being procured under Chinese concessional loans financed by Chinese Exim Bank at 2 percent interest rate and under a repayment period of 20 years with a five-year

grace period. At present, BSC has a fleet of only eight ships, the average age of which are over 30 years, said the proposal.

No ship was added to the fleet since 1991 due to high prices.
