SINKING OF PINAK-6

### SC stays owner's Bail

The Supreme Court yesterday stayed for two weeks a High Court order that granted bail to Abu Bakkar Siddique, owner of Pinak-6 launch, which capsized in the river Padma last year, in a case filed for negligence. Abu Bakkar cannot get

released from jail following the SC order, Deputy Attorney General Khandaker Diliruzzaman told The Daily Star.

The order came following a petition filed by the government seeking stay on the HC order.

Justice Hasan Foez Siddique, chamber judge of the Appellate Division of SC, also asked the government to submit a leave-toappeal petition before the SC against the HC order in two weeks.

Pinak-6, which had a capacity of carrying only 85 passengers, sank in the river with more than 250 passengers on August 4 last year. A total of 48 bodies were recovered and 62

remained missing. Jahangir Zia, traffic inspector at Mawa river port, filed the case on August 5 saying that the launch carried passengers more than its capacity for profit.

Following a petition

filed by Abu Bakkar, the HC on March 2 this year granted him six months' interim bail and also issued a rule upon the government to explain why the petitioner should not be granted regular bail in the case.

The Supreme Court yesterday stayed for one more week a High Court verdict granting bail to Mahtab Uddin Chowdhury Minar, the prime accused in Fulgazi upazila chairman Ekramul Haque killing case.

The four-member apex court bench headed by Chief Justice SK Sinha also asked the government to submit a leave-to-appeal petition with it against the HC judgment in a week.

An HC bench on March 2 granted the bail to Minar in the murder case following a petition.

Ekram, 45, former president of the upazila unit of Awami League, was shot and burnt to death in his car in Feni town's Academy area on May 20 last year. Ekram's brother Rezaul

Haque Jasim filed the murder case with Feni Model Police Station the same day, accusing Mahtab and 30 to 35 unnamed people.

A standard policy creating an environment conducive for women to work in is required to encourage their participation in the country's workforce, said discussants yesterday.

Commitment of top management and leaders is also required to ensure equality and promote a gender-sensitive culture at organisations, they said. The views came at a roundtable on "How to

ensure a conducive working environment for women" organised by The Daily Star, Standard Chartered Bank and British Council in The Daily Star Centre of the capital. "It is also the responsibility of leaders to search

and groom women who can reach the top," said

Rokia A Rahman, chairman of Mediaworld and

president of Bangladesh Federation for Women Entrepreneurs. She said very few women are seen at the top

management in any organisation. Moderating the programme, Shaheen Anam,

executive director of Manusher Jonno Foundation, said, "The percentage of women in the workforce, both in formal and informal sectors, has increased from 8.4 percent in 1983 to 34 percent in 2010."

The society is still not supportive enough as there is no level-playing field for women to work in, she said.

Abrar Anwar, chief executive officer, SCB mentioned their flexible hours, scope to work from home, maternity support and day care centre in line with the central bank's regulations as features that encourage women to work there.

Sheepa Hafiza, head of Gender, Justice and Equality, Brac suggested performance assessmen of directors of organisation should include their contributions to creating a gender-sensitive environment and promotion of equality. Sheepa also cited granting paternity leave and

earning during maternity, which her organisation allows, as good practices. Aasha Mehreen Amin of The Daily Star said ensuring gender equality is not only the job of

allowing women to draw their provident fund

leaders in an organisation; gender sensitiveness needs to trickle down every department. Mahfuz Anam, editor and publisher of The Daily Star, said the media in general has been

## DoE fines 3 factories, brick kiln Tk 40 lakh

The Department of Environment (DoE) yesterday fined three factories and a brick kiln a total of Tk 40 lakh in Dhaka, Gazipur and Narayanganj for polluting the environment.

East West Suiting Mills Ltd at Ashulia, outside the capital, was fined Tk 13 lakh for not renewing its environmental clearance certificate and directly releasing untreated liquid waste into water body. Washing factory, Summer Dress Ltd, located in Gazipur's Mirzapur, was fined Tk 1 lakh for operating without installing an effluent treatment plant (ETP).

The authorities of Metro Steel and Re-rolling Mills Ltd, in Narayanganj's Siddhirganj, was fined Tk 22 lakh for running the factory without environmental clearance certificate and polluting the air by not installing air treatment plant (ATP).

Besides, Maa Brick Field was fined Tk 2 lakh for conducting operations through traditional method.

During the hearings held at DoE headquarters in the capital, representatives from the factories and brick kiln made their apologies to DoE Director (monitoring and enforcement) Md Alamgir and pledged to take preventive measures to avoid recurrence of their offences, said a press release.

## Mechanised harvesters make farmers happy

Potato growers in Rajshahi have started using mechanised harvesters, instead of the conventional method, in order to save money, reduce labour requirement and increase production.

According to sources concerned, the potato-harvester driven by power tiller has recently been developed in Regional Wheat Research Centre (RWRC) in Rajshahi.

Golam Rasul, a farmer of Dayengrhat village under Paba upazila of the district, said potato harvester meets up the labour shortage by speeding up the harvesting process.

On an average, it can harvest potato from around 10-12 bighas of land in a day depending upon the operator's skill.

It takes three persons to harvest with the machine while in the conventional method eight persons are needed for per bigha of land and therefore the harvesting cost is also saved by at least 60 percent.

Babar Ali of Shayampur village told the BSS that there is an acute labour shortage in potato growing areas during peak harvesting period. Manual potato harvesting is a slow, time consuming and costly process.

Potato growers always face risks of bad weather especially during harvesting time.

Sometimes, unpredictable rain causes huge damages. So, potato harvester can cover many areas within a limited period and escape bad weather, uncertainty and labour dependency.

Farmers have already started using this harvester in their own fields in Rajshahi area during the current harvesting season.

They can be benefited as it lowers the production cost as well as labour requirement.

Agriculture Engineer Dr Israil Hossain, chief scientific officer of RWRC, Rajshahi, told the BSS that the harvester is a light machine and easily enters the small farmers' fields and a single person can drive the

machine. He said the fabricating cost is around Tk 35,000 and there is no need of specialised training for driving the machine.

Many of the farmers told the BSS that the production is higher than that of the previous seasons.

At present, the farmers are harvesting around 100 bags of potato (each bag contains 90 kg) from per bigha of land and there is no apprehension of incurring loss.
