BARAPUKURIA GRAFT CASE Judgment date for Khaleda's challenge deferred to March 15 STAFF CORRESPONDENT

The High Court yesterday deferred the date for delivering verdict to March 15 on a petition filed by BNP Chairperson Khaleda Zia for quashing the proceedings of Barapukuria coalmine corruption case against her.

The order came after Khaleda's lawyer Zainul Abedin prayed to the court to shift the date saying that they would place arguments on this matter.

Earlier on March 5, the court had fixed March 10 for delivering the judgment after hearing arguments from Khurshid Alam Khan, a counsel for the Anti-Corruption Commission which filed the case on February 26, However, Khaleda's

lawyers were not present before the court on that

The ACC filed the case, accusing Khaleda and 15 others of causing a loss of Tk 159 crore to the state exchequer by awarding a contract for the operation of Barapukuria coalmine to a Chinese company abusing power.

Following a petition filed by Khaleda, the HC on October 16, 2008 stayed the case proceedings and also issued a rule upon the government and the ACC to show cause as to why the proceedings against her in the case should not be quashed.

Teenage girl 'raped by former neighbour' in capital STAFF CORRESPONDENT

A 13-year-old girl was

allegedly raped by her former neighbour in her house in the capital yesterday afternoon.

Victim's mother, who is a day labourer, alleged that her daughter was alone at home when Zakir Hossain, 40, a rickshaw puller, raped her after gagging her.

Being informed by

other neighbours, the mother returned home to find her girl bleeding. She rushed her to a local clinic from where she was shifted to Dhaka Medical College Hospital as her condition deteriorated.

Badda police, who were informed about the incident by the DMCH camp police in the evening, did not confirm the rape allegation as forensic exam is scheduled to be held today. Police said Zakir is absconding.

14-party backing for Mohiuddin questioned by 2 other aspirants

The Chittagong unit of the Awami League-led 14-party alliance in a meeting yesterday proposed to back former city mayor ABM Mohiuddin Chowdhury in the upcoming mayoral election but two other prospective aspirants said such a proposal did not count because the party chief Sheikh Hasina was the ultimate decision maker.

At the meeting, where the name of Mohiuddin, also coordinator of the alliance in Chittagong and president of the city AL, was proposed unanimously, says a press release.

At least four AL leaders including Abdus Salam, finance secretary of

Chittagong city AL; AZM Nasiur Uddin, general secretary of the unit; and Nurul Islam BSc, vice president of the unit, may seek the party blessings in the mayoral vote, which has to take place within 180 days before July 25, 2015.

Both Salam and Nasir said AL President Sheikh Hasina could decide who would win party backing.

Salam, also chairman of the Chittagong Development Authority, said the 13-party could decide on the candidates they would back but not the one to be supported by AL.

Moreover, many top AL leaders of Chittagong were not present at that meeting, he said. He said the 14-party meeting decision would create misun-

derstanding in the party leaders and affect the organisation. He, however, said, "I think the decision will not impact the decision of central AL regarding the backing of mayoral candidate."

The signatories are: Farida Akhter of Nayakrishi Andolon and Narigrantha Prabartana, Dr Vandana Shiva of Diverse Women for Diversity, India and Dr Mira Shiva of Initiative for Health, Equity and Society, India.

Women are the primary growers of foods to ensure nutrition throughout history, said the statement. "We will not allow a further degradation of our food systems and knowledge systems. We will not sacrifice our seed and food sovereignty for corporate control and profits," it added.

Mahsin Ali, a freedom fighter operating under Bir Shrestha Captain Mohiuddin Jahangir, said his mother had told him that Chutu, whom she knew beforehand, and two other men torched their house.

From Ebadat Biswaser Tola, the 78-yearold witness and fellow freedom fighters saw Mahidur and Chutu and two others, Moazzem and Gafur, set fire to Bilat Mandol's house in Kabirajtola and stand by as it burned down on October 13, 1971. The eighth prosecution witness also told
