'Jihadi John' apologises for bringing shame on family

Mohammed Emwazi has reportedly apologised to his family for the shame he has brought on them, but has expressed no regret for murdering Western hostages.

Emwazi, who has been identified as the Isis executioner known as 'Jihadi John', expressed remorse for the "problems and trouble the revelation of his identity has caused," according to the Sunday

He sent his apology via a third party from Syria to his family, who have been forced into hiding.

However, Emwazi has not apologised for the barbaric murders he committed on camera of several hostages, including the British aid workers David Haines and Alan Henning.

Experts believe his apology may have been made for self-interested reasons, as Muslims who dishonour their parents are thought to be more likely to go to hell.

Emwazi's father, Jasem, who has fled to Kuwait, was reported to have called his son a "terrorist" and "dog' last week. Yet he appeared to have backtracked from these remarks, questioning whether his son was in fact "Jihadi John," as there is "no

Emwazi, a computer science graduate from the University of Westminster, is believed to have escaped from Britain in early 2013 by hiding in a freight lorry on a Channel ferry, before travelling on to Turkey and then Syria.

He was identified last month as Mohammed Emwazi by the Washington Post. Born to Iraqi parents, Emwazi and his family moved to Britain in 1994, after the Kuwaiti government rejected their application for citizenship.

UK police defend actions over teenage girls who flew to Syria

British police on Saturday denied accusations that they had failed to pass on crucial information that could have allowed families to stop three teenage girls from traveling to Syria to join Islamic State militants.

Shamima Begum and Amira Abase, both 15, and Kadiza Sultana, 16, who all attended the same London school, were reported missing on Feb. 17. They flew to Turkey that day and police believe they subsequently made their way to Syria.

Dozens of Britons, mostly young men but also some young women, have joined Islamic State, causing much angst back home about how they were being radicalized and what could be done to stop them.

Police officers had spoken to the girls in the weeks preceding their departure as part of an investigation into the disappearance of one of their school friends, an unnamed 15-year-old girl,

who had left for Syria on Dec. 6.

"The teenagers were all being cooperative, they were all being treated as potential witnesses and there was nothing whatsoever to indicate that they themselves were planning to travel to Syria," the police said in a statement.

complained to British media in the past two days that they had not been told about the first girl who had gone to Syria. "The police neglected us, the school neglected us. It would have definitely

Several relatives of the girls have

alarmed me ... 100 percent I would have stopped her. They did not warn us, they did not contact us at all," Hussen Abase, father of Amira, told the Guardian newspaper. Relatives complained in particular

that police had handed the girls letters, intended for their parents, requesting that the girls continue to cooperate with the investigation into their friend's departure for Syria.

Texting makes spelling

Prof David Crystal, an honorary professor at Bangor University, said those who text regularly were found to be "concentrating their minds" on the relationship between sounds and written words.

The linguist, who has written more than 100 books on the English language, pointed out a new generation is "constantly" reading and writing online.

"People say text messaging will harm your spelling. No...It helps you to spell better," he said at the Emirates Airline Festival of Literature in Dubai.

"This is because it focuses your mind on the connection between sound and letters.

"The best texters are the best spell-

"People say young people don't read and write any more. They may not necessarily read... Shakespeare or Charles Dickens, but have you ever

seen a teenager not reading? "Young people read probably more than I did when I was that age."

He said the digital age had not necessarily heralded a "linguistic revolution" in the way critics had predicted and said the "moral panic" of the potential change has not been justi-

Prof Crystal's studies have found around 2,000 new words developed as a result of the digital age, including terms such as blog and twittersphere.

He said additions have so far not had a major, or negative, impact on the English language, which has more than one million words.

The linguist said many abbreviations such as "c u l8r" are not commonly used by modern teenagers.

Prof Crystal also claimed that hashtags, used on Twitter, are simply a new method of managing and classify-

ing information and are likely to stay. His comments dispel previous claims abbreviated language was worsening teenagers' grasp of the English language.

Qualified woman can't claim maintenance

A family court has observed that a well-qualified woman cannot claim maintenance from her husband. "The wife who is well-qualified and claiming maintenance by sitting idle is not entitled to get maintenance. The wife is not entitled to advantage of her own wrong, she cannot harass the husband on the count of maintenance though she is capable to earn," the court said while dismissing a dietician's plea to seek a monthly maintenance of Rs 2 lakh from her divorced husband.

In the petition filed in 2013, the woman alleged that throughout their marriage, the husband and his family members had ill-treated her and harassed her both physically and mentally for bringing less dowry. She further alleged that they demanded Rs 50 lakh as dowry, gold and a luxury car from her parents.

The woman claimed that due to this, she was forced to live separately from April 2011 and had to move in with her parents. She also said that she had no source of income and is totally dependent on her parents.

The woman said that the man is a successful businessman and the family's business was also operational in Dubai. "They are running their business jointly and earning an income of more than Rs 15 lakh per month," the woman claimed.
