

Political crisis turns literally malodorous at Khaleda's office

DNCC removes garbage piled up for over 2 months on request; law enforcers list items

After over two months, household waste collecting in BNP Chairperson Khaleda Zia's Gulshan office in the capital was taken out yesterday in seven sacks, the contents of which law enforcers went through and listed.

Called in from the office, two Dhaka North City Corporation (DNCC) staff took an hour from 1:00pm to take the garbage away.

It was mostly empty bottles of water and aerosol, papers, disposable plates, broken chairs and dry leaves, Shamsuddin Dider of Khaleda's media wing told The Daily Star. Law enforcers did not comment on the list.

The government had kept Khaleda confined to the office for over two weeks since January 3. Afterwards, Khaleda stayed back with some 60 person including party leaders and office and security staff.

Though the police barriers outside were removed and only some members of Special Branch remained, the waste removal process apparently stopped amidst the restrictions and police presence centring the office.

The office staff told The Daily Star that the environment inside the office had become unbearable for the huge pile of garbage and mosquitoes breeding in it.

HASAN ALI'S WAR CRIMES TRIAL

Another relative of martyred Hindu man points him as killer

A family member corroborated a martyr's son's account over Syed Hasan Ali shooting dead her brother-in-law and his neighbour, and Hasan's fellow Razakars on his instructions looting the martyr's house, including the martyr's wife's ornaments and five cows, and forcing the families with threats of dire consequences to bury the bodies instead of cremating those as per Hindu funeral rites in Kishoreganj during the 1971 Liberation War.

Gouri Rani Chakrabarti, the 75-year-old 20th prosecution witness, testified that one of the five Razakars, the Pakistani occupation army's auxiliary force, who came to their Chikni village residence in Tarail upazila on October 8, 1971 hit her with a rifle when they remained silent on being asked where Jibon Krishna Chakrabarti was.

They tricked her and Jibon's wife Milon Rani Chakrabarti into paying Tk 300 for his release and said it could not be done without Hasan's orders, before taking him to the neighbour Kamini Ghosh's residence, she said.

Returning from hiding only to be abducted

Family says JCD man taken away by persons claiming to be law enforcers; Rab claims he is a criminal but they did not pick him up; police also deny involvement

Three-year-old Zaira Rahman Tridha wants her father back.

Going into hiding for around two months, as the family claims, on "security grounds", Anisur Rahman Talukder Khokon, a Jatiyatabadi Chhatra Dal member and former organising secretary, went to visit Tridha and her five-month-old sister Nidha at his Adabar residence in the capital on Thursday around 8:00pm.

Hours later, seven to eight persons claiming to be law enforcers picked him up and since then he has been traceless, said his wife Shah Israt Ajmyer.

"I want my father. Bring him to me," Tridha said holding a large photograph of Khokon at a press conference in the house yesterday.

Anxiety and fear has gripped the family as law enforcers deny having anything to do with the incident.

"After searching every possible place, we looked for him at the local police, DB (Detective Branch of police) and Rab offices but

they could not give any clue," said Khokon's younger brother Aituk Rahman.

"If my husband committed any offence, he may be tried under the country's existing laws. Why are they not disclosing his whereabouts, even to his family," said Israt.

Israt said she was unsure about the abductors' identity till Sunday, when she witnessed in television and read in the newspapers of Rapid Action Battalion's (Rab) allegation at a press conference on bomb recovery that Khokon was patronising and financing arsonists.

This made her believe that the abductors were Rab members.

"At around 10:00pm, he was working on the ground floor while I was busy with my two daughters on the first floor," she said, adding that they went away before she could come down.

While coming down the stairs, she stated to have heard the abductors claiming to be law enforcers.

MAHAJABIN MURDER CASE Husband's bail stayed by SC

The Supreme Court yesterday stayed till April 1 a High Court order that granted bail to Humayun Sultan, son of former Awami League lawmaker Khan Tipu Sultan, in the murder case of his wife Shamarukh Mahajabin.

The four-member bench of the Appellate Division also asked the government to file a leave-to-appeal petition against the HC order of bail with the SC by that day.

The bench passed the order in response to a petition filed by the government on March 4 seeking a stay on the HC order, Assistant Attorney General Sadhan Kumar Banik told The Daily Star.

Twenty six-year-old Mahjabin was found dead at the Dhanmondi residence of her in-laws in the capital on November 14 last year.

Humayun and his parents claimed Mahjabin committed suicide but her father Md Nurul Islam alleged she was murdered by her husband and her in-laws.

On the same day, Nurul filed a murder case with Dhanmondi Police Station naming Tipu, former lawmaker from Jessore-5 constituency, the prime accused.

Tipu and his wife Jasmin Ara Begum are now on bail in the case.

Mahjabin and Humayun got married in April, 2013. She did her MBBS from Holy Family Red Crescent Medical College.
