### National grid likely to get 560MW more power from April UNB, Dhaka

National grid of the country is likely to get about 560MW of power from April 30 as two base load plants of Summit Group are getting ready for commissioning commer-

The plants are 335MW combined cycle unit of Summit Meghnaghat Power and 341MW simple cycle unit of Summit Bibiyana II plant.

According to official sources, the Summit Group has informed the state-owned Power Development Board (PDB) that it will be able to commercially commission its Meghnaghat Power Plant's combined cycle unit by April 30 this

The simple cycle unit of Meghnaghat plant has been in operation for last few months, producing over 200MW. A progress report sub-

mitted to the Power Division shows that Summit has completed 99 percent of its civil and engineering works till end of January 2015. PDB's project director

for Meghnatghat plant Samir Uddin informed the news agency that initially the commercial operation date (COD) was March 31. But due to problem in gas supply the date has now been rescheduled for April 30, he said.

"Now everything is on to keep the target unchanged and we're hopeful of getting COD as per schedule, he said.

Once the plant's COD is done and it starts running in full swing of capacity, the country will get about 335MW from the Meghnaghat project, said

the official. Besides, the Summit Group's 341MW Bibiyana II Plant's simple cycle unit is getting ready for commercial commissioning by

April 30 as well. As per the progress report, Summit completed 97 percent of its civil construction works and 83 percent of engineering works till end of January. The gas turbine and generator of the plants were set up and the mechanical and electrical works were

running. The 92 percent works of gas pipe line installation has been completed by this

PDB's project director for the plant Saiful Islam Khan said Summit had informed the authorities concerned to commission its simple cycle unit by

April 30. Officials said once the simple cycle unit was com mercially commissioned, the national grid would receive about 226MW from the project.



# Dilapidated Jatrabari road Women work unpaid 5 keeps vehicles away

DSCC to be blamed as it did not bother about repair after installing sewerage line

Taniya Akhtar, a class IV student of Jatrabari Girls High School, walks more than one kilometre every day to commute between her home and school.

However, she walks not because she wants to but because she is forced to as the half a kilometre stretch of road from Khanka Sharif to Boubazar in Jatrabari sees little to no rickshaws.

"The condition of the road between my school and home is so bad that no

rickshaws ply on it," she said. On the slim chance that a rickshawpuller agrees to carry passengers on the Chandan Kotha Road he does so with a great risk of accidents.

"An old woman was seriously injured last week when the rickshaw she was on overturned," said Muslim Mollah, a peon at the school.

The condition of the road began deteriorating after Dhaka South City Corporation started work to set up a sewerage line underneath the road, he

Though DSCC completed the work about six months back, they did not bother about repairing the road, said Mohammad Babul, a staff of Bismillah Biriyani which is on the

Due to the road's terrible state, many people have to suffer to reach Chandan Kotha Community Centre.

Mehedi Hasan, owner of Bismillah Biriyani, said they have to pay rickshaw-pullers double, and sometimes even triple, the fare to bring goods to the restaurant.

He said just about a year back, before the sewerage line was set up, thousands of vehicles, including rickshaws, used the road daily but now the number of vehicles plying the road is almost zero.

According to the rules, the city corporation is supposed to repair the road

after completing its work. Sub-Assistant Engineer of DSCC zone-5 Fariduzzaman said they have finished about 60 percent of the repair work.

The repair work has been delayed due to a shortage of funds, he said and hoped that they would be able to finish the work by the end of March.

Finds ActionAid-Brac research in North Bengal

Although men and women get the same amount of time for rest and sleep, women have to spend six hours for unpaid care work for their families while men do them for an hour only, found a research conducted in North Bengal.

Compared to men, women face more difficulties with allocating their time for unpaid care work and income-generating work, the findings added.

ActionAid Bangladesh and the Centre for Gender and Social Transformation (CGST) of the Brac Institute of Governance and Development conducted the study in 2013-2014 on pattern of time use of women and

Cooking, cleaning, washing, and taking care of the family were regarded as unpaid care work in the study that included 224 women and 121 men in Lalmonirhat and

Gaibandha. The unpaid works should be recognised and equally distributed among males and females, it observed.

At an event organised by ActionAid Bangladesh, and CGST at the senate bhaban of Dhaka University yesterday, Simeen Mahmud, CGST coordinator and the lead researcher, said if women could reduce the load of unpaid works, they would get the opportunity to increase their

income. UN Women Country Representative Christine Hunter mentioned that Bangladesh's labour law does not even recognise domestic helps as workers and people take advantage of that. The domestic works should be included in the GDP, she

added. Moderated by ActionAid Country Director Farah Kabir, the event was also attended by former senior research fellow of Bangladesh Institute of Development Studies Pratima Paul Majumder, and Director General of the Department of Women Affairs Shahin Ahmed Chowdhury.

# 6,538ha coastal land to be afforested

The government has undertaken a plan to bring 6,538 hectares of land and some areas in nine costal districts under the social afforestation programme during the current fiscal year, Environment and Forest Minister Anwar Hossain told the Jatiya Sangsad yesterday.

Replying to a question from treasury bench member Didarul Alam, he also said the government has undertaken "Climate Resilient Participatory Afforestation and Reforestation Project" financed by Bangladesh Climate Change Resilient Fund to ensure afforestation in the coastal

Of the land, 2,624 hectares would be brought under mangrove gardening, 2,305 hectares for buffer zone garden, 135 hectares for enrichment garden, 1,376 hectares for core zone garden, 98 hectares for nonmangrove garden, and the remaining portions for nipa tree garden and strip garden,

he said. Anwar Hossain also said the social afforestation programme would contribute to the national economy, maintaining balance in the ecology, environment, and biodiversity, and reducing risks of natural calamities and desertification.
