#### Arrest warrant for Tarique issued for maligning Bangabandhu

A Barisal court yesterday issued a warrant of arrest for BNP Senior Vice-Chairman Tarique Rahman in two cases filed for terming Bangabandhu Sheikh Mujibur Rahman a "big Razakar."

Barisal Metropolitan Magistrate Nusrat Jahan issued the arrest of warrant after the BNP leader, now in London, did not appear before the court yesterday as per its order passed on December 22 last year.

Nahid Serniabad, Govt. BM College unit joint convener of Bangladesh Chhatra League and Advocate Kaiyum Khan Kawsar, Barisal city unit convening committee member of Awami Jubo League, filed the cases.

The Dhaka University authorities yesterday suspended four Bangladesh Chhatra League (BCL) activists accused of harassment and assaults on journalists and students at TSC while a crowd was celebrating Bangladesh's victory over

England in the Cricket World Cup. The suspended are Ali Abbas of criminology, Taslim

Hasan Tuhin of sociology, Kamrul Hasan Sumon of peace and conflict, and Shahriar Nazim Shawn of disaster management and vulnerability studies, all first-year students and loyal to Maksud Rana Mithu, president of BCL's Haji Muhammad Mohsin Hall unit.

Four other students will be served show-cause notices, says a press release.

The decisions came in response to two separate complaints filed by DU Journalist Association (Duja) President

Masum Billah and a female journalist. She was among the women harassed during Monday's revelry. When some journalists and students protested, the BCI activists attacked them with bricks, injuring the Duja president, also DU correspondent of the daily Samakal, and Mehedi, a first-year student of mass communication and journalism.

They were treated in Dhaka Medical College Hospital.


## Rasel Chy wins

## Dhaka Wasa to start faecal sludge management

Dhaka Water Supply & Sewerage Authority (Wasa) is going to introduce Faecal Sludge Management (FSM) system using Vacutug machines under a public private partnership (PPP) initiative to increase hygiene coverage in the capital.

To this effect, Dhaka Wasa yesterday signed a Vacutug Lease Agreement with Gulshan Clean and Care under the PPP initiative at Wasa Bhaban in the capital.

Dhaka Wasa Commercial Manager Uttam Kuma Roy, WASH specialist of Unicef Shofiqul Alam, Water and Sanitation for the Urban Poor (WSUP) Country Manager themselves. Abdus Shaheen, and project manager of NGO Forum for Public ceremony, Dhaka Wasa officials Health M Nurun Nabi, among oth-

ers, were present at the ceremony. Unicef Bangladesh in collaboration populated Dhaka city.

Officials said environmental hygiene in Dhaka city is at stake due to the absence of modern FSM services for more than 80 percent households, causing prevalence of different types of intestinal and water borne diseases. Dhaka Wasa now can bring only 20 percent of households under the FSM service.

This agreement will allow households of the city to have access to Dhaka Wasa-supported professional emptying services, known as SWEEP. In most cases, pit latrines and septic tanks are manually emptied by informal service providers, posing health risks to both the public and the service providers

## Why directions for repair should not be issued

HC asks govt to explain in four weeks, demands report in three months

The High Court yesterday asked the government to explain in four weeks why it should not be directed to quickly repair dams which were damaged due to cyclones Sidr and Aila in four southern districts of the country.

In a rule, the court asked the government to show cause why its inaction to reconstruct the damaged dams in Barguna, Bagerhat, Patuakhali and Pirojpur districts should not be declared illegal.

The HC also ordered the government to submit a report before it in three months on how many dams were damaged in the cyclones and their condition at the moment. The HC came up with the rule

## Missing man's family seeks PM's

"Salam had forcibly taken the charge of mosque management when BNP came to power after 2000," said Ambia.

The mosque, situated on a land of 19 decimals, generates Tk 10-12 lakh a month through the 44 shops set up on its premises to bear the maintenance expenses, she said.

Majed intervened last year after the mosque's water tank collapsed, killing two pedestrians, exposing to the residents the negligence in managing the mosque, Ambia said.

Majed owned a business of garment accessories and was not involved with the management body before, though his ancestors donated the mosque land, claimed the family.

But police initially denied Ambia her right to seek legal protection and justice by refusing to accept a case over his disappearance until the media brought it to light.

They finally recorded it three days into Majed's disappearance, but dropped four names from the letter of complaint submitted by Ambia.

At the news conference, Ambia was desperate to make the point that her husband was not involved in politics, at a time when the political turmoil is marked by disappearances allegedly at the hands of law enforcers for contain-

ing violence. Some innocents reportedly have

fallen victims to this move due to enmity.

"...I swear, my husband had never been involved in politics," Ambia wrote in the statement given to journalists during the conference.

The case investigator, Mominul Islam, sub-inspector at Paltan Model Police Station, defended police, saying the complainant was not confident about accusing the four. Nevertheless, the case was trans-

ferred to detectives for investigation yesterday, taking into account the The Daily Star has a copy of the names of the four, he said.

In an air-conditioned VIP room, next to the one where the family sweated to hold the conference, a protest of pro-BNP cultural group Jatiyatabadi Sangskritik Jote was underway. They vowed to uphold democracy and prevent injustice, but uttered not a word relating to disappearances.
