Businesses to benefit from alternative dispute resolution methods: analysts

Businesses can derive benefit from alternative dispute resolution methods, particularly mediation, which is already available in the country, to resolve commercial and investment disputes, analysts said yesterday.

Mediation can be especially a good alternative to the costly and time-consuming judicial process, they said. The government has already brought about a number of amendments to laws to make mediation mandatory in civil and money loan cases, in keeping with established practices in the developed world.

"These provisions cannot be implemented in the absence of awareness about the benefits of alternative dispute resolution methods," said Mahbubur Rahman, chairman of Bangladesh International Arbitration Centre (BIAC). He spoke at a workshop jointly organised by BIAC and Dhaka Chamber of Commerce and Industry (DCCI) at the latter's auditorium in the capital.

The workshop aimed to create awareness about resolution of commercial disputes outside the court through mediation, accord-

This led BIAC to seek assistance from the government in popularising the alternative dispute resolution system.

The sponsors believe the system could cut the courts' burden of dealing with commercial and businesses disputes. It has called for making rules so people go to the centre to have their disputes settled before going to court.

The courts in Bangladesh, like in many other countries, are overburdened. There are as many as 2.4 million cases pending, of which roughly one million are civil cases, according to BIAC.

The BIAC has great potential but people do not know much about it, Finance Minister AMA Muhith said earlier.

Tofail urges G7 to help build sustainable garment supply chain

Bangladesh has urged G7 countries to provide greater support to build a sustainable global supply chain to uphold justice and give fair prices to local garment makers.

Commerce Minister Tofail Ahmed made the call for the G7 countries to impress upon retailers to help build a fairer and sustainable global supply chain.

He also spoke of the various efforts by the country and its garment sector in adhering to a range of international social and environmental standards over the decades, at the consultation programme on developing a sustainable global supply chain in Berlin, Germany.

Ahmed also spoke of the policy, legislative, regulatory, and administrative measures taken by the government in the past two years, following the country's worst industrial accidents in April 2013.

The government, owners and workers in Bangladesh are collaborating with global actors in stabilising the industry that employs over four million women and men in Bangladesh, he said.

He assured G7 stakeholders of Bangladesh's commitment to continue with necessary changes, as was agreed under the Bangladesh Sustainability Compact.

Even though many of the changes are unique compared to most other parts of the world, he assured the meeting that Bangladesh is a compatible and safe place to buy manufactured goods from.

Nobel Peace Laureate Kailash Satyarthi and Germany's Minister for Labour and Social Affairs Andrea Nahles and Economic Cooperation Minister Gerd Muller also spoke.

A sustainable global supply chain and decent work will figure high in the agenda at the G7 summit in Germany this summer.

Along with Manila-based International Rice Research Institute (IRRI), Bangladesh is now at the forefront in developing golden rice. However, crops derived through agricultural biotechnology and genetic engineering are often met with opposition from the anti-GMO lobbies.

The Allow Golden Rice Now campaign that began on March 4 will run in Bangladesh for four days and tour the Philippines and India up to March 20, as these are the few countries where vitamin A deficiency is a major cause of child mortality. "Two million children and many mothers die each year

from a lack of this essential vitamin. It is the greatest cause of child death today. Golden rice is the obvious cure, but because it was created with genetic science, Greenpeace and the anti-GMO movement fervently oppose it," Moore said. On August 8, 2013, Greenpeace instigated the destruc-

tion of golden rice scientific field trials at the IRRI in the Philippines. The Allow Golden Rice Society is actively campaigning for the approval of the rice so it can be delivered to the 200 million children who are deficient in vitamin A. "All we ask is that Greenpeace and their allies make an

exception for golden rice in their opposition to GM crops," he said. "Millions of lives are at stake." The members of the Golden Rice South Asia Tour also

include Horst Rehberger, a senior German politician; Uwe Schrader, a German expert in biotechnology, and Hans-Jörg Jacobsen, a German heading Plant Biotechnology at the Institute of Plant Genetics of Leibniz University in Hanover. "I want to seek solutions to different problems and not just

oppose one thing or the other," Moore told The Daily Star. He deplored that some 250,000 to 500,000 vitamin Adeficient children become blind every year, half of them dying within 12 months of losing their sight. "This tragedy can be eliminated with golden rice... but has been blocked by Greenpeace for over a decade. During that time over eight

million children have gone blind and then died." Moore and his campaign team lauded Bangladesh for being the first among all Asian nations in introducing GM vegetable - Bt Brinjal. "We will see Bt Brinjal fields on Friday," Moore said, adding that they also sought to meet Bangladesh's agriculture minister on Thursday.

France's Areva to cut 1,500 jobs in Germany

French nuclear group Areva, which incurred massive losses last year, is looking to cut around 1,500 jobs in Germany by the end of 2017, a company spokesman said Wednesday.

At a meeting between management and employees on Tuesday, Areva's chief Philippe Knoche said the company planned to slash 1,500 fulltime-equivalent jobs by the end of 2017 including 500 to be carried out this year, the spokesman said.

Wolfgang Niclas, representative for the IG Metall union, said earlier that 1,000 jobs were on the line in 2016 and 2017, confirming a report in the French business daily

Les Echos. Areva employs more than 5,000 people across eight sites in Germany.

Deutsche Post says e-commerce boosted profits in 2014

German postal and logistics giant Deutsche Post said Wednesday it met its earnings targets last year thanks to the strong performance of its international express and German parcel business and remains confident for the current year.

"Despite a still challenging environment we delivered a solid performance in 2014, by building on our strong market position in e-commerce and emerging markets," said chief executive Frank Appel.

Net profit slipped by 1.0 percent to 2.071 billion euros (\$2.2 billion) last year, the group said.

But underlying or operating profit climbed by 3.5 percent to 2.965 billion euros on a 3.1 percent increase in revenues to 56.63 billion euros. Sales growth was "supported by steady volume and

revenue gains in the international express and German parcel businesses in particular," the statement said. The former state monopolist has been able to make up

for the decline in its traditional letter delivery business expanding its online commerce and parcel delivery.

The group's Post-eCommerce-Parcel (PeP) division booked a 2.6 percent increase in revenues to 15.7 billion euros, and the express delivery division reported an increase of 5.7 percent to 12.5 billion euros.
