Fakhrul, Rizvi, Falu denied bail again

COURT CORRESPONDENT

A Dhaka court yesterday turned down separate bail petitions filed by three BNP leaders including the party's acting secretary general Mirza Fakhrul Islam Alamgir in connection with five arson cases.

The other leaders are: BNP Joint Secretary General Ruhul Kabir Rizvi Ahmed and Mosaddek Ali Falu, adviser to BNP Chairperson Khaleda Zia.

The order came after their lawyers submitted separate bail petitions against rejection orders from the lower courts on different dates. Among the five cases,

two were filed against Fakhrul on January 5 in connection with torching vehicles and exploding crude bombs in the capital's Motijheel and Paltan areas on January 4. On January 6, detectives

picked up Fakhrul as he came out of the Jatiya Press Club and later he was shown arrested in seven cases and was remanded for several days. Rizvi was denied bail in

two cases filed with Jatrabari police for arson SEE PAGE 5 COL 8

Asaduzzaman said persons who murdered the seven have been identified.

Talking about Nur Hossain, the case's prime accused, he said India has agreed to repatriate him and he would be brought back soon.

He also said the Taqi murder case would be handed over to Rab for a more transparent investigation.

TORTURE, CUSTODIAL DEATH (PREVENTION) ACT Publicly reject amendment

proposal from police

Ain o Salish Kendra urges govt

Expressing grave concern over a recent police proposal seeking amendments to the Torture and Custodial Death (Prevention) Act, Ain o Salish Kendra yesterday demanded that the recommendations, "which are in conflict with the constitution", be publicly rejected.

In a press release, the rights organisation said the government should clearly state that impartial and credible investigations would be conducted over torture allegations and that anyone found guilty would not be spared. Allegations of torture and deaths in custody, which are sheer human rights

violations, have arisen against law enforcers, it added. The police headquarters sent the recom-

mendations on the act's sections and subsections to the home ministry recently, seeking amendments to 14 and dropping of seven. It proposed scrapping Section 12 that says no excuses like war situation, threat of war, political instability, state of emergency, or orders of senior official or the government authorities will be acceptable for any crime under this law.

Jannati Hossain yet to be released

3 days past being granted HC bail

Young entrepreneur Jannati Hossain is yet to be released although the High Court granted her bail on March 12 in a case filed over the death of her business partner Mostamsir Ashraf.

Senior Jail Superintendent Farman Ali of Dhaka Central Jail told The Daily Star yesterday that they have not received any bail bond while the government informed them of a petition it filed with the Supreme Court seeking a stay on

the bail verdict. The petition will likely be moved before the SC chamber judge today, said Attorney General Mahbubey Alam, adding that his office was doing

so on government instructions.

Circumstances centring the bail bond could not be ascertained as the HC verdict's full text is yet to be released.

Jannati crashed Mostamsir's car

into a parked police van near the capital's Mohakhali flyover on July 11, 2014. Mostamsir, sitting beside her, died on way to a nearby hospital, police said. Tejgaon police sued her for reckless driving.

Ten days later, Mostamsir's family lodged a case against Jannati, her brothers Jubair and Junaid, father Delwar Hossain and husband Raymen Siddique, alleging it was a planned murder to take

over his business. Mostamsir is the son of Jannati Hossain Khan Mohammad Abdul Mannan, a former district court judge now serving as the inspector general of registration (land). Of the 15 people named as prosecution wit-

nesses, four are high-profile government officials. Jannati and Mostamsir launched Echo Sparks, a music cafe and gaming zone in Uttara, in December 2013. Her family says she has other businesses in partnership with

Raymen.

Judgment on Khaleda's challenge deferred again

The High Court yesterday for the second time deferred the date for delivering verdict to April 5 on a petition filed by BNP Chairperson Khaleda Zia for quashing the proceedings of Barapukuria coalmine corruption case against her.

The order came after hearing of a time petition filed by Khaleda.

Moving the petition, Khaleda's lawyer Bodroddoza Badal told the court that her senior counsel Khandaker Mahbub Hossain and her filing lawyer AM Mahbub Uddin Khokon failed to appear before the court for placing arguments due to their personal difficulties.

In the ongoing Supreme Court Bar Association election, Khandker Mahbub is contesting for the post of its president while

Khokon for the post of secretary, he said. Earlier on March 5, the court fixed March 10 for delivering the judgment after hearing arguments from Khurshid Alam Khan, a counsel for the Anti-Corruption Commission, which filed the case on February 26, 2008.

Later, the court deferred the judgement date to March 15 as Khaleda's lawyer
