BNP Chairperson Khaleda Zia and three members of her family are to face trial in a loan default case. The three family members are

Arafat Rahman Koko's wife Sharmila Rahman Sithi and her daughters Zafia Rahman and Zahia Rahman.

A Dhaka court yesterday granted a Sonali Bank petition to include the four as defendants in the case on behalf of Koko, who died on January Judge Roksana Begum Happy of

Artha Rin Adalat-1 passed the order after the state-run bank on March 8 filed a petition to include Khaleda and three others to contest the case. The court also fixed April 12 for

next hearing of the case. Koko was made a defendant in the

case filed for realising Tk 45.59 crore. On October 2 of 2012, Sonali Bank Ltd filed a money suit against

10 directors of Dandy Dyeing Ltd, including BNP Senior Vice Chairman Tarique Rahman, for defaulting on a loan amounting to

Tk 45.59 crore.

The company had borrowed Tk 12.16 crore from the bank's principal office in Dhaka on October 16, 2001, the case statement said.

As the company failed to pay it off, the principal loan plus interest accumulated over the last 11 years totalling to an amount of Tk 45.59 crore.

Nine other accused in the case include Arafat Rahman Koko, Giasuddin Al-Mamun and his wife

Shahina Yasmine, Nasrin Iskander, wife of late Sayeed Iskander, Shams Iskander, Shafin Iskander, Sumaiya Iskander, Mozaffar Ahmed and Kazi Galib Abdus Sattar. Nazrul Islam, senior executive

officer of the bank's principal office, filed the case with Artha Rin Adalat-1 while Hosne Ara Begum moved the suit for recovery of the loan.

and then be submitted to the Third Energy Ministers' Meeting in Kathmandu sometime this year for signing.

Bangladesh has already set up cross border electricity grid with India for importing 500-Megawatt power from India.

The country is also currently negotiating to import at least 3,500-Megawatt more electricity through bilateral, regional and sub-regional joint venture initiatives from India, Myanmar, Nepal and Bhutan by 2030.

Officials said power import would serve as one of the main sources of the country's energy security by 2030. According to the government's plan, Bangladesh would have 39,000MW of power, nearly six times the amount today.

Elaborating on the Bimstec MoU, they said this would provide a broad framework for the implementation of grid interconnections to promoting rational and optimal power transmission in the region.

Based on the principles of mutual cooperation and sustainable development, the member states aspire to build interconnections for reliable, secure and economic electricity supply in the region under the MoU.

The Bimstec deal is almost similar to Saarc Framework Agreement for Energy Cooperation signed in Kathmandu on November 27, 2014 to set up a South Asian regional grid for cross-border trade of electricity.

Foreign ministry officials said the Bimstec move would expedite the implementation of the Saarc deal.

Officials said the MoU was prepared based on the Declaration of First Bimstec Energy Ministers' Conference held on October 4, 2005. This covered trans-power exchange and grid interconnection, hydropower development and energy security of the region.

Once approved, the MoU will pave the way for all member countries to buy and sell energy as per their necessity through private or public companies. It will ease power generation, distribution and trading between the Bimstec states. The relevant Bimstec bodies wil

tion, transmission and power trade, including hydropower, natural gas, solar, wind and bio-fuel, and implement them with top priority with to meet the increasing demand for power in the region. According to a senior official at the Bimstec Secretariat, the seven member

states have the potential of generating around 260,000 megawatt o hydropower, including 150,000MW by India, 40,000MW by Myanmar, 30,000MW by Bhutan and Nepal each, 500MW by Bangladesh and Thailand each and 1,000MW by Sri Lanka.

Earlier, Monowar Islam, secretary o Power Division at the power, energy and mineral resources ministry, inaugurated the meeting.

Bimstec Secretary General Sumith Nakandala spoke on the occasion.

The last CCC election was held in 2010.

11 indigenous people sent to jail

A Khagrachhari court yesterday sent 11 indigenous people to jail in connection with Sunday's clash with security personnel.

They were arrested in a case filed by Israfil Majumdar, officer-incharge (Investigation) of Dighinala Police Station, for allegedly attacking and injuring on-duty security personnel during the clash. 56 persons, including leaders of United Peoples Democratic Front (UPDF), several local government representatives and 700-800 unidentified people are accused in the case.

Judicial Magistrate Muhammad Abul Mansur Siddique sent them to jail rejecting a bail prayer submitted by defence lawyers Advocate Gayano Jyoti Chakma and Advocate Somari Chakma, said court sources.

UN expert for int'l action on N Korea

A United Nations rights expert squared off with North Korea Monday by urging the global community to resolve the fate of 200,000 people allegedly abducted by Pyongyang, and refer perpetrators to the International Criminal Court.

"There is a real sense of urgency to solve this matter once and for all," said Marzuki Darusman, the UN's independent expert on the rights situation in North Korea.

Addressing the UN Human Rights Council in Geneva Monday, Darusman presented his latest report

on the human rights situation in the country, including a strategy aimed at keeping the issue of abductions in the international spotlight.

Later, the prime minister will address a children's rally and inaugurate a book fair on the premises of the grave. She is also expected to attend a cultural

and party flags at Bangabandhu Bhaban in the capital and party offices across the country. It will also place wreaths at the portrait of Bangabandhu in front of Bangabandhu Bhaban.

Television, private TV and radio stations will air special programmes, while the national dailies will publish special supplements highlighting the significance of the day.

try's all the important movements including the independence war, was born at Tungipara on this day in 1920.

He delivered the historic speech on March 7, 1971, which united and prepared the entire nation for the Liberation War.

On March 25 the same year, Pakistani army pounced on the unarmed Bengali people killing hundreds and later arrested Bangabandhu from his Dhanmondi residence.

The entire nation, except for few Pakistani collaborators, fought against the heavily-equipped Pakistani armed forces, and after nine months of bloodshed, the country was finally liberated. Throughout his life, Bangabandhu

struggled to ensure Bangladeshis' rights and freedom.

On August 15, 1975, the great leader was assassinated, along with most of his family members, by some disgruntled army personnel in the capital.

Upon an appeal by Hasina's lawyers, the HC had adjourned the hearing till yesterday.

As the court resumed hearing yesterday, Attorney General Mahbubey Alam read out from the reports submitted by five law enforcement agencies saying they were trying to find out the BNP leader.

The HC bench of Justice Quamrul Islam Siddique and Justice Gabinda Chandra Tagore did not pass any order other than adjourning the hearing yesterday, since the attorney general told it Salahuddin was not in the custody of law enforcers.

After the court proceedings, Mahbubey Alam told reporters at his office that Hasina Ahmed's statement about the law enforcers' reports was

misleading and baseless. The reports have been submitted to the HC through affidavits as they are true, he claimed.

In the middle of yesterday's hearing, Hasina's counsel Moudud Ahmed appealed for adjourning the hearing.

Moudud told the court that he would place arguments in detail on the issue and respond to the reports submitted by the law enforcement agencies about their actions to find out Salahuddin.

The offices of the inspector general of police, the director general of Rapid Action Battalion, the Criminal Investigation Department, the Special Branch of Police and the commissioner of Dhaka Metropolitan Police submitted separate reports to the HC on March 15, saying they did not detain the BNP leader.

Hasina's lawyers said law enforcers were still obligated to trace Salahuddin as the court did not dispose of the petition.

Emerging from the courtroom, Moudud told The Daily Star there were many false statements in the law enforcers' reports and that they would place their response before the court in this regard on April 8.

But Moudud, also a BNP standing committee member, would not say which parts of the reports were untrue. "The adjournment has been good

for us, as the petition will remain pending with the High Court and the government will feel a pressure and will try to find out Salahuddin," he said. After yesterday's hearing, Hasina

told reporters that the law enforcers' reports about her husband were false and fabricated.
