



BARISAL NURSING COLLEGE Students protest govt wish to set up SBMC dorm there

Students of Barisal Nursing College yesterday protested a request of the health ministry to allow female students of Sher-e-Bangla Medical College (SBMC) to live in the newly-built academic building of the nursing college.

The nursing students organised a rally on the campus of the medical college and later brought out a procession there urging the ministry to withdraw its request.

Speakers at the rally said female students of the nursing college also have accommodation problems, but the ministry, overlooking those, wants to give the college's new academic building to female students of Sher-e-Bangla Medical College for residential purposes.

The speakers said 560 female students of the nursing college have been living in a building that has only 200 seats.

They threatened to wage a tough movement if the building is given for residential purposes.

On Sunday, Director General of the Directorate General of Health Services (DGHS) Prof Dr Deen Muhammad Nurul Haque at a meeting with the authorities of the medical and nursing colleges made the request.

They urged the nursing college authorities to give two floors of the academic building to the students of the medical college temporarily.

Police yesterday started the process to bring back wanted criminal Mollah Masud, a day after Indian authorities informed them about his arrest for illegal stay.

Officials at the police headquarters said they had sent a letter to the home ministry and was waiting for the response.

Talking to journalists at his office, Inspector General of Police AKM Shahidu Hoque said they were hoping to bring him back under the extradition treaty between the two countries.

Mollah Masud, a top Bangladeshi criminal for whom the Interpol issued red notice, was arrested in West Bengal on February 8. He was the second-in-command of Moghbaraz-based "Seven Star" gang led by Subrata Bain. He came to the limelight after

Shanti Kabiraj and Motilal Roy and others to come rushing in, said the 10th prosecution witness, now aged 78 years.

She went to her father-in-law's house in the district the following day for security reasons and her family left for India four or five days later when the duo's condition improved, she added.

Forkan, Bellal, Shahjahan, Mannan and others, whom she had been acquainted with, had abducted them from their home in Mirzaganj

upazila's Subidkhali around 9:00pm on the third day of the Bangla month of Bhadra, she said.

"I witnessed the incident hiding inside our house," she said. Proceedings were adjourned until tomorrow, when she will be cross-examined.

An alleged Razakar commander of Mirzaganj, Forkan, 63, denies the five charges including murders committed in the southern district during the Liberation War.

low the accused when they abducted Bijoy Das from Ghanoshyampur village but had to turn back after being threatened.

"That night a friend of my maternal uncle who was a cobbler by profession told me that accused Siraj Master and his associates killed my father...the following day, I went to the spot but could not find my father's body but saw blood," said the 29th prosecution witness.

The defence counsel cross-examined Sukumar and proceedings were adjourned until March 18.
