Away in Habiganj, a mobile court fined two teenage boys Tk 10,000 for stalking a schoolgirl in Madhabpur upazila of the district on Sunday, reports our Moulvibazar correspondent.

In default, they are to suffer two months in jail, said court sources.

The stalkers are Rubel Miah, 17, son of Safigur Rahman, and Sagor Chandra Das, 16, son of Ranjon Das of Fatepur vil-

The two often teased the Class VII student on her way to school, said the victim's family.

Robber killed in 'gunfight' with cops in Faridpur

An alleged robber was killed in a 'gunfight' with police in Alfadanga upazila of the district early yesterday.

Muktar sustained bullet wounds during the clash and died instantly while the rest managed to flee, said Jamil Hassan, superintendent of police (SP) in Faridpur.

The body was sent to Faridpur Medical College Hospital morgue for autopsy.

After conducting postmortem examination on Muktar's body in the afternoon, police handed over the body to Sultan Sheikh, a relative of Muktar, Sub-Inspector Hasimuzzaman of Alfadanga Police Station said.

BSF detains 5 Bangladeshis for crossing border illegally

Indian Border Security Force (BSF) arrested five Bangladeshis after they entered the Indian territory illegally through Burirhat border in Kaliganj upazila of the district yesterday. The arrestees are Al-Amin

Sheikh, 25, son of Abdul Jalil, Palash Chandra Roy, 19, son of Subhas Chandra Roy of Nawdabash village in Hatibandha upazila, Sumon Chandra Roy, 18, son of Dhirendranath Roy, Anil Chandra Roy, 35, son of late Premananda Roy of Latabar, and Santosh Kumar Roy, 28, son of Manoranjon Roy of Gangagachh village in Kaliganj upazila.

A BSF team arrested the five in the morning on charge of crossing the border without valid documents, said Border Guard Bangladesh (BGB) sources.

Mahir Uddin, 45, a day labourer of Burirhat, said "A good number of workers of the bordering villages often go to India illegally in search of jobs in brick kilns and construction sites in New Delhi."

In the afternoon, BGB sent a letter to its Indian counterpart to return the five Bangladeshis.

Housewife stabbed to death

A young housewife, who was stabbed by a youth in Gowainghat upazila on Sunday, succumbed to her injuries at Sylhet MAG Osmani Medical College Hospital early yesterday.

The deceased, Sakera Begum, 22, wife of Ayub Ali was a resident of Lamasatain village in the upazila.

Police quoted victim's family members as saying that Kamal Uddin, 26, son Jamal Uddin of the village gave a marriage proposal to Sakera's family nearly two years back, which her family refused.

Later, Kamal went to Saudi Arab as a worker. He returned home a month ago and came to know that Sakera's family married her off to Ayub, a madrasa teacher from the same village.

In despair, Kamal stabbed Sakera with a sharp weapon while she was going to have a bath in a pond adjacent to their house on Sunday noon, said Abdul Hai, officer in-charge of Gwainghat Police Station.

Critically injured Sakera was rushed to Sylhet MAG Osmani Medical College Hospital where she succumbed to her injuries around 4:00am.

Taiyabur Rahman, victim's brother, filed a murder case with the police station yesterday morning, accusing Kamal, who went into hiding soon after the incident.

over 100 Hindus, torched around 200 houses and looted valuables. On December 14, Asaduzzaman Noor visited the villages, talked to the

their rehabilitation. While Noor along with his party men was returning to the district town at around 4:00pm, several

thousand Jamaat and BNP activists swooped on them at Ramganj Haat under Tupamari union of the upazila, leaving four activists of Krishak League, Chhattra League and Jubo League dead and many injured.

Officer-in-charge (investigation) Babul Akhter of Sadar Police Station filed a case at night, accusing 14 named and 150 unnamed BNP-Jamaat men. After investigation, the IO brought charges against 43 more people.

Of the identified accused, the bodies of three were found beside different roads in Nilphamari and Bogra districts in the first two weeks of the incident.

Kid murdered 3 days into abduction in Jhenidah

A madrasa student was murdered three days into his abduction in Kotchandpur upazila of Jhenidah district.

He was identified as Miraj Ali, 12, son of Mohar Ali of Bhomradanga village in the upazila.

Locals spotted Miraj's body at a cropland at the village around 9:00am yesterday and informed the

police, said Shahidul Islam Shahin, officer in-charge of the police station.

Police recovered the body and sent it to Jhenidah Sadar Hospital morgue for autopsy.

Bujruk Gorgori Darul Ulum Madrasa in Chuadanga, came home about five days ago. He attended a Waz mehfil (religious function)

at Bhomradanga Madrasa ground on Saturday afternoon and did not return home until 11:00pm.

At midnight, an unknown person phoned Atiqur Rahman, Imam of the village Mohar Ali said his son mosque, and demanded Tk 1 Miraj, a class III student of lakh ransom for Miraj's release. Being informed, Miraj's father Mohar, Mohar Ali lodged a general diary (GD) with Kotchandpur Police Station on Sunday.
