Google Translate to get 4 lakh Bangla words on March 26

BSS, Dhaka

The country is set to add four lakh Bangla words to Google Translate, a free online language translation service, on March 26.

"We are going to create a new record by contributing four lakh Bangla words to the Google Translate on the Independence Day," ICT State Minister Zunaid Ahmed Palak told a press conference.

He urged all Bangla speaking people living around the world to join the endeavour and fulfil the

The ICT Division and Google Developer's Group-Bangla (GDG-Bangla) jointly organised the press conference in the capital yesterday.

Palak also said, "Bangla word vocabulary in the Google Translate is not satisfactory. That is why the ICT Division and GDG-Bangla are jointly taking the initiative."

The move will remove inadequacy of Bangla content, he added.

The minister further said over 50 events would be held in different locations, including universities, and people would directly work at the points to add Bangla words to Google Translate.

Volunteers from Australia, Portugal, the USA, the UK and other countries will also join the effort on March 26, he added.

FROM PAGE 16 Abu Daooh was left without an income when her husband died while she was pregnant. The newspa per reports that her situation was made more difficult by the fact that working as a woman was frowned upon in her community in Luxor.

Faced with a lifetime of begging on the streets, she disguised herself as a man by wearing loose, full length robes and took on manual jobs making bricks, working in construction and polishing shoes.

"I preferred working in hard labour like lifting bricks and cement bags and cleaning shoes to begging in the streets in order to earn a living for myself and for my daughter and her children," she said.

"So as to protect myself from men and the harshness of their looks and being targeted by them due to traditions, I decided to be a man ... and dressed in their clothes and worked alongside them in other villages where no one knows me."

Her daughter Houda went on to marry a man who later fell ill and was unable to work, leaving Abu Daooh once again responsible for the family. She now works mostly polishing shoes, which she says earns her a "decent income".

Houda praised her mother for providing for the family and said she still gets up at 6:00 every morning to go to work.

Don't call hartal

Atia said the authorities concerned had earlier taken the tests at night in case of daylong hartal. But there was huge uncertainty over holding the tests this time due to continuous hartal, she added.

the tests on two days in Dhaka. The ongoing political unrest has been taking a heavy toll on about 5 crore students of schools, colleges

and universities as it has messed up their academic activities at the very beginning of the year.

The 15 lakh candidates of SSC examinations have been the worst victims of the situation. Not a single written test of the exams could be held on scheduled dates. The tests, which were supposed to end on

March 10, are still going on. All the tests have so far been held on weekends, thanks to the BNP-led

alliance's hartal. Similarly, the political unrest is also causing worries among around

12 lakh Higher Secondary Certificate (HSC) examinees and their guardians who apprehend the same fate as the exams are scheduled to begin in less than two weeks.

Replace all gates of Farakka barrage

Mamata writes to Modi urging New Delhi to stop free flow of water to Bangladesh

West Bengal Chief Minister Mamata Banerjee has written to Prime Minister Narendra Modi seeking his immediate intervention for phase-wise replacement Farakka barrage gates one of which had collpased recently leading to free flow of water to Bangladesh. State Irrigation Minister Rajib

Banerjee said in Kolkata today that in her letter to Modi on Wednesday, the chief minister has urged the federal Indian government to initiate phasewise replacements of all the 112 gates of the barrage. "The collapse of gate number 49 recently has led to free flow of water to

Bangladesh. The situation may worsen if other gates too collapse," Rajib Banerjee said. He said Mamata has written to Modi for ensuring a time-bound replacement to protect the interests of

lockgates the water was quite often flowing down to Bangladesh. The Farakka barrage is located 17

km from Bangladesh border.

Gate number 49 was washed away on March 15, leading to free flow of water down the barrage. Following this, Indian authorities had diverted excess water to a feeder canal and towards Bangladesh.

Bangladesh and India signed a landmark 30-year agreement in 1996 on sharing of Ganga waters.

"Most of these gates are damaged and need replacement. So far, only 22 have been replaced. So the chief minister has written to the Prime Minister seeking his immediate intervention," Rajib Banerjee said.

Rajib said that during his recent meeting with Indian Water Resources Minister Uma Bharti at Siliguri he had apprised her of the poor condition of all the lock gates at Farakka and that at least two of them had collapsed some time back.

Bharti had told him that all the lock-gates of the barrage needed to be changed phase-wise by 2017, Banerjee said adding she had also apprised the Prime Minister of the matter so that a time-bound programme in this regard could be initiated.

tion and said, "The allegation is absolutely false. I am not a loan defaulter. I have sufficient documents and proof to this end." According to Local Government

(city corporation) Act, 2009, if any person, who is either director or partner of any company that fails to repay loans of a bank or financial institutions within one year prior to filing nomination, will be disqualified from taking part in the elections.

Deputy Secretary Shamsul Alam of the EC told The Daily Star, "We have not taken the letter into consideration because the letter was received before announcement of the polls schedule and Sayeed Khokon is yet to file his nomination."

Plane crash in Uruguay leaves seven dead

A small Argentine plane carrying 10 people crashed shortly after takeoff Thursday from a resort in neighboring Uruguay, leaving at least seven dead, authorities said Thursday.

The other three people were missing but there were no signs of survivors, said fire department spokesman Leandro Palomeque.

The Beechcraft prop plane had just taken off from an airport near the Uruguayan resort city of Punta del Este when the aircraft went down.

targeted Avijit for long.

"I have always told investigators that the probe should look into every possible clue... so that the real murderers don't get away, making innocents the scapegoat," Ajay told The Daily Star after the meeting.

Prof Anizuzzaman who presided over the meeting reminded everyone that the murderers appeared to be fundamentalists.

"We must not forget that fundamentalism has very close ties with terrorism and intolerance to dissenting opinions," he said.

"We will be confused and make others confused if we forget this fact."

After the murder, police arrested Shafiur Rahman Farabi, operative of a banned militant outfit, who had issued at least a dozen death threats to Avijit for what he said demeaning Islam.

Though Avijit tried to play on logic to point out that Farabi was misquoting him, Farabi kept saying on Facebook that it was a Farz (must) for Muslims to kill Avijit.

Ansar Bangla 7, presumed to be an organisation of militants, celebrated the murder in a tweet and claimed responsibility for it.

The organisation evoked names like Ansarullah Bangla Team and Ansar Al Islam, which have claimed responsibility for two separate murders, including of another secular blogger, since 2013.

DU Vice Chancellor AAMS Arefin Siddique, politicians Mojahidul Islam Selim and Nuh Ul Alam Lenin, Deputy Speaker Shawkat Ali, prominent citizens Khandker Ibrahim Khaled, Dr Sarwar Ali and Fariduddin Ahmed also participated in the meeting.

Meanwhile, a Dhaka court yesterday placed Shafiur Rahman Farabi, the prime suspect in the killing of blogger Avijit Roy, on a fresh four-day

remand in a case filed under the

Information and Communication

Technology Act. The order came after investigators produced him before the court on

completion of his five-day remand. Wahiduzzaman, an inspector of Detective Branch (DB) of police and also the investigation officer of the case, had sought a seven-day remand for Farabi.

Earlier on Saturday, he was put on a five-day remand in the same case.

Fazlur Rahaman, Inspector of Detective Branch of police, filed the case against Farabi with Ramna Police Station on March 14 for issuing threats to kill Avijit through a number

of posts on Facebook. Farabi was arrested on March 2 and placed on a 10-day remand in connection with the Avijit murder case

the flowing day. During the remand that ended on March 14, detectives searched his blog and Facebook account and found that Farabi issued threats to many people, which is an offence under the ICT Act.

Farabi, however, denied his involvement in the murder.

Unknown assailants hacked Bangladeshi born American citizen Avijit to death and injured his wife Rafida Ahmed Bonya on the Dhaka University campus on February 26.

120,000 flee Philippines violence: UN

More than 120,000 people have fled their homes in the impoverished southern Philippines since fighting broke out between government troops and Islamic militants in late January, the UN refugee agency said Friday. "UNHCR is concerned about the

safety of civilians as the conflict spreads into local villages," spokesman Babar Baloch told reporters. The Philippines military launched an offensive earlier this year against the

Bangsamoro Islamic Freedom Fighters

(BIFF), a rebel group fighting for an

independent Muslim homeland in the

south. The offensive, including attacks with artillery and helicopter gunships, has taken place in poor farming areas on Mindanao island, where Muslim rebels have for decades fought for

independence. Baloch said an estimated 13 municipalities in Maguindanao and North Cotabato had been affected by the eight weeks of clashes.

More than 120,000 had been displaced and sought shelter in schools, public buildings and madrasas, he said.

But he acknowledged, "the estimated number of displaced could be higher, since it does not include people hosted by relatives and friends."

The DFO said, "Our officials can't properly check the forests due to inaccessibility and insecurity. Shortage of manpower is another problem. As a result, trees from the

British people of Pakistani and Bangladeshi origin are around three times more likely to be in poverty compared to their white counterparts while people of Indian descent have largely closed that gap, according to new research by Oxford University.

The report by the Centre for Social Investigation (CSI) at Nuffield College at the university also found that people of Pakistani and Bangladeshi origin were also more likely to be living in less comfortable conditions. "Rates of poverty are much higher

among two groups - 57 per cent for people of Pakistani and 46 per cent of people of Bangladeshi background compared with 16 per cent for the white British in 2009-11," the report entitled 'Ethnic Inequalities' found. "People of Pakistani and
