- This request for expression of interest follows the General Procurement Notice (GPN) for this project that appeared in the UN Development Business online on 25 February, 2013.
 - The People's Republic of Bangladesh has received a credit from the International Development Association (IDA) Cr. No. 5339-BD towards the cost of the Municipal Governance and Services Project (MGSP) and intends to apply part of this credit to eligible payments under the contract for Consultancy Services of Development and Implementation of a GIS-Based Property and Infrastructure Asset Management System (GIS-PIAMS) for Urban Local Bodies and the Local Government Engineering Department.
 - LGED is seeking a Consulting Firm to development and deploy a web GIS-based Property and Infrastructure Asset Management System (GIS-PIAMS) to improve local revenue mobilization and more effectively optimize the performance of infrastructure assets from a technical and economic point of view. This will be carried out under the capacity building component (component-3) of MGSP. The GIS-PIAMS will be piloted in 4 of the pre-identified 26 ULBs under MGSP. After successful completion of the pilot phase, the program will be rolled out to the remaining 22 ULBs.
 - The Local Government Engineering Department (LGED) now invites eligible consultants to indicate their interest in providing the services. Interested consultants must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, financial resources, availability of appropriate skills among staff, etc.).
 - The EOIs would be reviewed on the basis of the following:
