Hundreds of Afghans bury woman beaten to death by mob

AFP, Kabul

Hundreds of people yesterday attended the burial of an Afghan woman who was beaten to death and set on fire by a mob for allegedly burning a copy of the Koran.

The body of Farkhunda, 27, who was lynched on Thursday by an angry crowd in central Kabul, was carried to the graveyard by women amid crowds of men, an AFP reporter said, a rare act of protest in a male-dominated society.

The crowd, shouting "Allah o Akbar" (God is greatest), demanded the government bring the killers to

Footage of the attack on social media shows a number of uniformed police watching the crowd as they beat her to death, burn her body and then dump it into a river.

detained 20 people in last two and a half months but denied involvement.

Family members concerned alleged plainclothes law forcers had detained 20 people across the country between January 1 and March 16, ASK Executive Director Sultana Kamal.

Based on newspaper reports, the

leading rights body said whereabouts

of the missing people could not be known and law enforcers had not admitted any link. Expressing serious anxiety, ASK said most of the missing people were involved in opposition politics, adding that BNP Joint Secretary General

Salauddin Ahmed, who had been missing for 13 days, was one of them. The ASK said the families or near and dear ones of the missing people had alleged that plainclothes law enforcers picked up them [missing people], but law enforcers have

denied any detention in most cases. It further said law enforcers or responsible persons in the government were shrugging off their responsibility by claiming that they had not detained them.

The law enforcers and the government were responsible to find out any missing person and could not avoid their responsibility by saying that they had not picked up the missing men, the rights body added.

It said the National Human said in a statement signed by its Rights Commission (NHRC) had earlier sent a letter to the home ministry, asking it to instruct the law enforcers not to detain anybody by plainclothes cops.

The NHRC should follow whether its recommendations were being implemented, ASK said, adding that it was "evident" from the ongoing situation that the commission's

requirement was not executed. "We want to remind the government that its constitutional duty is to ensure security of every citizen. A person being missing and nobody getting his or her whereabouts are grave violation of human rights.

"We demand that the government play the highest level of responsibility in trying to find the missing persons. It's the government's responsibility to give acceptable interpretations in the investigations into these incidents," the statement added.

As per electoral code of conduct, no candidate is allowed to conduct electoral campaign before 21 days from the election day. Additionally, use of billboards for electoral campaign is prohibited. The EC on March 19 issued direc-

tives to the ROs to take necessary measures to remove such billboards, posters and leaflets by Saturday morning. But hundreds of electoral posters still remain. Any candidate or his/her supporter

may be awarded six months' imprisonment or fined Tk 50,000 or an aspirant's candidacy could be cancelled for violation of electoral code of conduct. Elections to the bifurcated Dhaka city and Chittagong will be held on
