Attack on Hindus at Bonogram in 2013

Court accepts charge sheets against 84 in two cases

A Pabna court yesterday accepted three charge sheets in two cases in connection with the gruesome attack on Hindus at Bonogram in Santhia upazila under Pabna on November 2 in 2013.

Spreading rumour about Prophet in Facebook. maligning Prophet Mohammad (pbuh) through a Facebook page allegedly posted by local boy Rajib Shah, a group of people attacked the Hindus in the area, leaving 33 houses, 10 shops and seven temples damaged in three villages of Bonogram

that day.

Three separate cases were incidents.

Rajib's father Bablu Shah filed a case for attacking and looting his house while police filed two cases -- one for attack on cops and the other for maligning the

"After investigation police submitted three charge sheets in two of the three cases. The Judicial Magistrate's Court-4 accepted the charge sheets today [Sunday]," said court sub inspector Md Borhan.

Md Monirul Karim Khan, sub inspector of the Detective Branch (DB) of

Demand for vc's Resignation

6 more BAU teachers resign from administrative posts

Six more teachers of Bangladesh Agricultural University (BAU) yesterday resigned from the administrative posts to press their one-point demand for resignation of the vice chancellor.

Additional registrar Md Sarwar Jahan confirmed filing of resignation by six more teachers, including proctor Prof Harun-or-Rashid and students' affairs adviser Prof Johirul Haque Khandaker.

On Tuesday, 53 teachers of the university resigned from the administrative posts that include hall provosts and house tutors and directors of different institutions.

League teachers under the banner of Ganotantrik Shikkhak Forum started agitation on March 19, demanding resignation of BAU Vice Chancellor Prof Md Rafiqul Hoque for his alleged irregularities and corruption in recent job recruitment and 'immoral acts'.

"We will continue our agitation until the demand is met," said forum president Prof AKM Shamsuddin.

However, the academic activities at the university are running properly, said BAU sources.

Meanwhile, an emergency meeting of BAU Teachers Association was held at the

> Islam in the chair. In the meeting, the association issued an ultimatum demanding resignation of the vice-chancellor by 5:00pm today. "We will launch a tougher agitation programme if our demand is not met," said association's president Prof

Shariful Islam. The association sought immediate intervention by the authorities concerned to resolve the issue

The BAU vice-chancellor said, "It is very unfortunate that a section of teachers are continuing their movement on false allegations against me."

Lightning kills 3 in 2 dists

Three people were killed and six others injured by lightning in Moulvibazar and Sunamganj districts on Saturday.

In Moulvibazar, an elderly woman was killed and her two children were injured by lightning in Kamolganj upazila around 6:00pm.

The deceased was identified as Tahera Khatun, 60, wife of Safique Ullah of the village.

Police said a thunderbolt struck their hut at Berachhara village during heavy rain leaving Tahera dead on the spot and her children- Monowara, 28, and Selim, 24injured. Both are undergoing treatment at Kamolganj Upazila Health Complex.

Away in Sunamganj, two people were his farmland at the village around 7:15pm.

The deceased are Sirajul Islam, 13, son of Chan Mia of Puranghat village, and Shahjalal, 40, son of Abdul Barek of Borogoptila village in the upazila.

M Shahidullah, officer-in-charge of Tahirpur Police Station, said Sirajul was struck by lightning and died instantly while

four others sustained injuries. The incident occurred when Sirajul along with some children were playing beside the

road at the village around 7:00pm. In another incident, lightning killed Shahjalal while he was returning home from

TEACHERS' CRUELTY

2 kids hospitalised with injuries

Two kids in Dimla upazila of the district got hospitalised with injuries as their schoolteachers beat them mercilessly for 'failure' to prepare lessons yesterday.

The victims are Nahid Hasan, 5, son of Shahin Alam, and Manosi Rani 4, daughter of Manik Chandra Roy, hailing from Dimla Sadar union of the upazila.

Nahid is a Class I student of Dakkhin Titpara Government Primary School, and Manosi is a playgroup student of Dilruba Mohikul Kindergarten.

Shefali Begum, head-Titpara Government Primary School, mercilessly beat Nahid with a bamboo stick at about 11:00am yesterday for not memorising lessons as directed by her, Nahid's

father alleged.

Manosi's father told journalists that Abu Raihan, assistant teacher of Dilruba Mohikul Kindergarten, beat his daughter so cruelly that she fainted in the classroom at about 9:30am.

Both the kids bore several injury marks and got fever, the guardians said.

Being informed from different sources, parents of the injured kids rushed to the respective schools and rescued them.

As they brought the victim kids to Dimla upazila nirbahi officer and sought justice, the latter immediately summoned upazila primary education officer Rabiul Islam and directed him to mistress of Dakkhin report within two days after investigating the incidents on an urgent

The two injured kids were admitted to Dimla Upazila Health Complex at noon.


Fish trader hacked to death


