

Death anniversary

Today is the 29th death anniversary of Justice Syed Muhammad Hussain, said a press release.

Born in 1928; he was the eldest son of Syed Tasodduque Hussain, the then district and sessions judge, and Begum Asma Hossain.

He was a judge of the Supreme Court and was removed under the martial law in 1984.

He was also chairman of the Bangladesh Chapter of International Law Association, Amnesty International and the International Commission of Jurists. He was awarded the Swadhinata Padak.

Missing HSC examinee found dead in Ctg

A missing HSC examinee was found dead in an under construction temple at Uttar Kattali in Chittagong city yesterday morning.

Sumit Dutta, 18, a student of Mostafa Hakim Degree College, had been missing since he went to a pond adjacent to his house to wash his hands and mouth around 1:30pm on Tuesday, said Sumit's brother Amit Dutta.

Officer-in-Charge Sadip Kumar Das said Sumit might have been murdered as the body bore marks of injuries on the head and waist.

Later, the victim's father Shyamal Dutta filed a general diary with Akhber Shah Police Station.

Workers of the under construction "Adwoitananda Temple" first noticed the body lying on the floor in a room, said police.

Petition filed to stay

FROM PAGE 3 the two city corporations should not be declared illegal.

Citing the petition, Eunus Ali told The Daily Star that not all citizens have the ability to deposit the security money and purchase the voter lists to contest the election adding that it was illegal as the constitution grants the right to every citizen to contest the election.

The HC may hold hearing on the petition today, he said. A mayoral candidate of Dhaka South City Corporation (DSCC) has to deposit Tk 1 lakh as security money to the election commission. The amount is Tk 50,000 for Dhaka North City Corporation (DNCC).

According to the returning officers' notices, each DNCC mayoral candidate has to buy a Tk 18,000 CDs of voter lists while a DSCC mayoral candidate has to pay Tk 27,500 for such CDs.

The law secretary, the secretary to parliament, the chief election commissioner, and the returning officers of the two city corporations have been made respondents to the rule.

launched in 2012 by Switzerland and Norway to build consensus on the development of a protection agenda addressing the needs of people displaced across international borders due to disasters and the effects of climate change.

Bangladesh is one of the nine countries that led this initiative. Swiss Ambassador Christian Fotsch said they would closely work with Dhaka on migration and displacement issues.

He said over 166 million people were globally displaced by sudden-onset disasters between 2008 and 2013, and this number was likely to increase due to global warming.

The consultation's outcomes will be presented at a global summit in Geneva in October for future actions, said Ate Solberg, head of Nansen Initiative Secretariat in Geneva.

Accused in 21 August grenade attack case on remand in another one

Hussain Ahmed Tamim, an accused in the August 21 grenade attack cases, was sent on a seven-day remand in a case filed against him for making an attempt to create subversive activities in Dhaka Central Jail.

A Dhaka court passed the order after Sub-inspector Sadequul Islam, also the investigation officer of the case, produced Tamim before it with a 10-day remand prayer.

Earlier on March 29, Chawkbazar police filed a case against Tamim and one of his relatives for their alleged attempted subversive activities in the makeshift courtroom where the trial of the two grenade attack cases is going on and the central jail.

On March 24, Tamim was carrying a court file which had a Samsung mobile handset, four SIM cards, a magnet, and a radio set. The police inspector seized the items when Tamim was getting out of a prison van in front of the court.

CRITICISING ICT VERDICT AGAINST BERGMAN 23 charged with contempt of court

International Crimes Tribunal-2 orders those in Bangladesh to appear before it on April 23, and to explain on appearance or before why they should not be punished

Unconvinced with replies over why they should not be charged with contempt of court, International Crimes Tribunal-2 yesterday initiated the proceedings against 23 of 49 eminent persons who had issued a statement expressing concern over Dhaka-based British journalist David Bergman's sentence for demeaning it.

It asked those currently in Bangladesh to appear on April 23 and reply on or before that day why they should not be punished.

If convicted, the 23 may face the highest one year's imprisonment or a fine of up to Tk 5,000 or both.

The tribunal also cleared of the charge another person, Rezaur Rahman, one of the remaining 26, whose unconditional apologies were accepted and who were exonerated earlier in four phases including yesterday's.

Justice Obaidul Hassan viewed it appropriate to charge the 23 "makers of the impugned statement..." for protecting authority and dignity of the tribunal and to keep the notion of administration of justice untainted in the mind of public."

The charge has been brought "under section 11(4) of the International Crimes (Tribunals) Act-1973" said Justice Hassan leading the three-member tribunal, including Justice Md Mozibur Rahman Miah and Justice Md Shahinur Islam.

The 23 are Masud Khan, Afsan Chowdhury, Ziaur Rahman, Hana Shams Ahmed, Anu Muhammad, Anusheh Anadil, Muktasree Chakma Sathi, Lubna Marium, Farida Akhter, Shireen Huq, Zafullah Chowdhury, Ali Ahmed Ziauddin, Rahnuma Ahmed, Shahdul Alam, CR ABRAR, Bina D'Costa, Mahmud Rahman, Zarina Nahar Kabir, Leesa Gazi, Shabnam Nadiya, Nasrin Siraj Annie, Tibra Ali and Delwar Hussain.

On December 2, 2014, the tribunal found Bergman, editor (special reports) of New Age, guilty of contempt for two of his blog posts of January 2013 on the verdict of Abul Kalam Azad, known as Bachchu Razakar.
