One killed, 15 missing

At least one person was killed and 15 others remained missing after a sandladen boat collided with a trawler in the Meghna river amid storms last night. The identity of the deceased could

not be known immediately. His body remained trapped inside the vessel, said police.

Although the collision took place somewhere in Chandpur or Comilla, both the vessels were spotted near Bhashanchar in the Meghna river at Gazaria, said Habibur Rahman, subinspector of Gazaria Police Station.

Pias, 25, of Narayanganj, who survived the accident, said the trawler left for Chandpur from Bauchia Launch Jetty near the Daudkandi Bridge in Comilla around 7:30pm yesterday. When the trawler reached the

confluence of the Meghna river amid heavy storm, the sand-laden boat hit it. The vessel, however, did not completely sink and kept floating near the shore, he said.

A number of passengers managed to swim ashore, but some 15 people, including Pias' three-year-old niece, remained missing, Pias said.

A rescue team of the fire service reached the spot around 12:00am, a fire service official said, adding that rescue efforts were on for the missing passengers.

Following the court order, Rab took Palash and Enamul Haque, who was also a security guard at the building, on remand for interrogation, said sources.

Sagar Sarowar, news editor at Maasranga TV, and his wife Meherun Runi, senior reporter of ATN Bangla, were killed at their rented flat in the capital's West Rajabazar on February 11, 2012.

Police have arrested nine people for their alleged involvement with the killing.

A trucker for four years, Imran came out of financial hardship barely a year ago and built a small house of his own, said his relative Fazlur Rahman. Earlier, he lived with his father and brothers in an extended

"With his death, his family will be in deep trouble," added Fazlur. He was the father of two -- a

daughter with the first wife whom he divorced around five years ago, and a son with the second. "Although his daughter lives with her maternal grandparents, Imran took great care of her," said the relative. Imran's brother-in-law Yadul, 25,

who received burn injuries in the same incident, died at the burn unit of the DMCH on March 25.

Earlier, Matin Biswas, Rawshan Ali, and Shakil Ahmed, who also suffered burns in the incident, died in the hospital.

A total of nine people received serious burns in the incident.

The rest four victims are taking treatment at the DMCH burn unit as their condition is still critical, said Partha Shankar Pal, resident surgeon at the burn unit.

With Imran, at least 95 people have so far been killed, mostly in arson attacks, since the BNP-led alliance called a countrywide indefinite blockade on January 5.

RAPE OF NUN IN WEST BENGAL

Indian cops arrest four Bangladeshis

Indian police yesterday said they have arrested four Bangladeshi nationals in connection with the rape of an elderly nun that sent shockwaves through the Christian community.

The nun, who is in her 70s, needed surgery after she was attacked last month when a gang of robbers broke into the convent school in the eastern state of West Bengal where she lived.

Deputy inspector general Dilip Kumar Adak said police tracked the suspects down to the northern state of Punjab after CCTV images and efit images were circulated nation-

"Four more Bangladeshi nationals resembling the photographs and sketches of the suspects in the rape and robbery at the Convent of Jesus and Mary High School in Ranaghat have been arrested," he said.

Two other suspects in the case are already in custody after they were arrested last week.

US sanctions to target foreign cyber criminals

President Barack Obama yesterday launched a new sanctions program to target individuals and groups outside the United States that use "malicious" cyber attacks to threaten US foreign policy, national security or economic stability.

In an executive order, Obama declared such activities a "national emergency" and allowed the US Treasury Department to freeze the assets and bar other financial transactions of entities engaged in destructive cyber attacks. The executive order gives the

administration the same sanctions tools it now deploys to address other threats - including crises in the Middle East and Russia's aggres sion in Ukraine - and makes them available for less visible cyber threats. It is the Obama administration's

latest effort to get tough with hackers, following indictments of five Chinese military officers and the decision to "name and shame" North Korea for a high-profile attack on Sony. Companies that knowingly use

stolen trade secrets to undermine the US economy would also be targeted.

"This is the first time in the history of cricket that the game has been insulted so badly. But, in the end, I don't think cricket ended up losing, because the person [responsible for the move] got booed by 90,000 people at Melbourne when his name was announced after the final.

"To me those 90,000 people in the stadium represented the views of the 16 crore people of Bangladesh. He was only saved when Sachin Tendulkar's name was announced after him. Things could have been different had Tendulkar's name not been announced," he added.

Kamal explained that his role was usurped during an 'informal' meeting, which included four to five directors of the ICC board, that was organised a day before the final. Following the Bangladesh-India quarterfinal, Kamal criticised the umpires, describing them as poor and also stated that they might have had 'an agenda'.
