Khaleda faces 13 cases

BNP Chairperson Khaleda Zia is facing 13 cases.

Of the lawsuits, two are Zia Orphanage Trust and Zia Charitable Trust graft cases in which she secured bail after appearing before a Dhaka

court yesterday. A High Court bench yesterday sent the BNP chief's four petitions, filed in 2008 challenging the legality of the proceedings of Barapukuria coal mine, Gatco and Niko corruption cases, to

the chief justice for "necessary orders". The cases were lodged by the Anti-Corruption Commission.

Khaleda stands accused in five other cases filed during the ongoing nonstop blockade called by the BNP-led 20-

party alliance. The investigation into the

cases is underway. On January 23,

two cases were lodged with Jatrabari Police Station in the capital against the BNP chief for "instigating" an arson attack on a bus in the area that killed three people.

Three days later, Khaleda was sued for "instigating" another arson attack on a vehicle at Chauddagram in Comilla. Several were killed in the incident.

She was accused as the mastermind

in another arson case filed with Phultala Police Station in Khulna in connection with torching a bus in Damodor in February. Police in the case statement men-

tioned that the BNP-Jamaat men set fire to the vehicle on the BNP chairperson's instructions.

Khaleda was named the prime accused in another case filed on February 16 for launching a crude bomb attack on a rally of Shipping Minister Shahjahan Khan outside her

office at Gulshan in the capital. The case was lodged with Gulshan Police Station. Besides, three defamation cases

were also filed with courts last year against the BNP chief. **PETITIONS**

An HC bench was set to deliver its verdict on Khaleda's petition against Barapukuria coal mine graft case yesterday.

Citing an order on the petition, ACC counsel Khurshid Alam Khan told The Daily Star that the bench sent the plea to the chief justice due to "unprofessional and unethical conduct of the lawyers for the petitioner [Khaleda]". He said the lawyers did not appear

On April 2, Khaleda had submitted an application to the chief justice through her lawyers, expressing her noconfidence in the HC bench. In the application, she also prayed for transferring

yesterday informed the HC bench about his client's no-confidence. Attorney General Mahbubey Alam said the chief justice might send the petitions to another bench or return

Following Khaelda's petitions, the HC issued rules upon the ACC and the government to explain why the cases should not be scrapped and why their initiations against her should not be declared illegal.

"We are very happy. Our strategy has worked," an AL central leader said, wishing anonymity. "A positive wind has started blowing in the political Khaleda had been staying in her

Gulshan office since January 3. The government had made several efforts so that she returned to her house, but those went in vain.

Asked, AL Presidium Member Nuhul-Alam Lenin said a positive political scenario was prevailing in the country for the last two days.

The government will now allow the

BNP to hold rallies and processions, said sources in the government.

On Saturday, the government allowed the BNP men to enter their party headquarters at Nayapaltan, which law enforcers had locked on January 3.

Contacted, Iftekharuzzaman, executive director of Transparency International Bangladesh, said the BNP took the city elections as an exit path from its ongoing movement, which apparently detached the party from people due to its violent nature.

"Now the question is how much the BNP will be able to utilise the opportunity, refraining itself from falling into the trap of provocation," he said.

On the other hand, Iftekhar said,

the challenge for the government was to prove that a free and fair election was possible under it.

"The prospect of this opportunity

depends on the extent to which the two sides are able to ensure peaceful democratic practices before and after the elections," he added. On the latest developments, Zahirul

Islam, a private service holder, said, "It is a positive step. It gave us some relief. We hope Khaleda Zia will call off the blockade. And the government will open talks to reach an agreement with the BNP."

Khaleda entered the court premises at Bakshibazar around 10:35am amid

tight security. She was accompanied by party Vice-

chairperson Selima Rahman and President of its women front Shirin Sultana. Before delivering the order on bail petitions, Judge Abu Ahmad Jomadar

said he was compelled to issue the arrest warrants for the sake of continuing the trial. He had no intention to send

Khaleda to jail, he added.

None of the three accused, including Khaleda, who were on bail, was present in the court on February 25, prompting the court to cancel their bails and issue the arrest orders, the judge said.

The prosecution did not oppose the bail considering Khaleda's status, social and political dignity and age, chief prosecutor Mosharraf Hossain Kajol told the court.

The court also granted bail to two other accused -- former BNP lawmaker

Sharfuddin Ahmed. At the beginning of the proceedings,

Khaleda's lawyers questioned the legality of the arrest warrants. The prosecutor objected to it and asked the defence to omit the phrases

questioning the "legality of issuance of the arrest orders". He said the arrest warrants were

absolutely legal, a view the judge supported. Khaleda's lawyers then deleted the

phrases from the bail petitions. The court allowed Khaleda's lawyers

to cross-examine the complainant of the cases, said Harunur Rashid, deputy director of the ACC.

The court adjourned the hearing until May 5.
