Go tough on militancy PM asks law enforcers, high officials

Prime Minister Sheikh Hasina yesterday directed the law enforcement agencies and local administrations to take tough measures against terrorism and militancy. "You will have to take appropriate

measures so that there are no militant activities in Bangladesh. There will be no room for militancy in the country," she said. The PM was exchanging views with

Risky, illegal

In many cases officials of the two Dhaka city corporations and ruling Awami League men "authorise" illegal billboards for money, said sources in both the corporations.

Some city officials are even running advertisement businesses when it is their duty to check the abnormal growth.

"The authorities don't dare take action because of some officials and ruling party's involvement," an official said, requesting anonymity.

Exact numbers are not available, but sources say Dhaka South City Corporation has about 900 legal billboards against some 1,500 illegal ones (of which 527 are privately owned). In Dhaka North City Corporation, there are about 1,500 legal billboards against some 1,200 illegal ones.

Of those illegal in the DNCC, 257 were permitted by the Cantonment Board, 173 by the Air Force, 147 by the Bangladesh Railway, 10 by Dhaka Wasa and 22 by Bangladesh Police, while 443 are owned by private citizens, said a city official.

In recent years, such haphazardly erected billboards proved fatal. On March 15, 2010, two people died and eight others were injured when an 800 square feet hoarding sitting wobbly atop a shopping complex in Gulshan-1 collapsed. On April 20 the following year, a giant billboard collapsed near Dhanmondi Road-8 during a storm, though there was no casualty in the incident.

Contacted, Ansar Ali Khan, chief executive officer of DSCC, said they could not conduct drives in many cases for a lack of logistics, manpower and police force.

Many illegal billboards are set up at night, and even if the city officials carry out a drive, they can pull down at best three of them in a day.

Ansar added they were serious about the illegal billboards and would carry out drives to take those down.

said they published a notice in newspapers in February, giving 15 days time for the illegal billboard owners to take permission from the city authorities by March 13. "We have got applications from 18

firms for authorisation of 36 billboards so far," he said, adding that they would conduct drives against illegal billboards soon. Under the law, prior permission of

the city corporation is a must for setting up billboards. It is also mandatory for ad firms and private owners to collect no-objection certificates from authorised engineers as a proof of safety. But most companies and private owners violate the rules, said Bipon. About the alleged involvement of

some city officials in corruption, he said they would take action against them if found guilty. Hoardings set up on high voltage

electric cables may cause heavy casualties during powerful storms, said Md Rashed, general secretary of Outdoor Billboard Owners Association.

He also stressed that the city corporation engineers should keep vigilance so that no firms can set up risky billboards.

"Also, the authorities should not allow billboards here and there and thus ruin the city's beauty," he added.

In the past, the united Dhaka City Corporation used to follow some rules before giving permission for billboards. Back then there was a ban on setting up hoardings near 14 buildings and monuments, including Pantha Kunja, the National Museum and different hospitals. Also, billboards over electric cables were prohibited. But these rules are not followed now, officials said.

"The advertisement business is not in the hands of businessmen anymore. It is now controlled by the ruling party men. Most of them don't care for the law or safety measures," said a businessman, asking not to be named.

"If Kamaruzzaman does not seek clemency or the president rejects his mercy petition, the jail authorities will allow his family members to meet him for the last time," Mahbubey said at a press briefing at his office.

Revised trade deal with India okayed

trade could only be done between the two neighbours. Besides, India could transport goods to its seven northeastern states.

Talking to The Daily Star, Commerce Minister Tofail Ahmed said the revised deal would be signed either during Indian Prime Minister Narendra Modi's visit to Dhaka or Prime Minister Sheikh Hasina's trip to New Delhi.

He termed the modified agreement a milestone in Indo-Bangla relations. Nepal and Bhutan have similar agreements with India, added the minister.

The deal would be in force for five years instead of the existing tenure

of three years.

Regarding fees and charges, the cabinet secretary said the fees would be fixed through discussions between the two countries. "Bangladesh and India would pay the same fees for transporting goods. It's a winwin situation for both sides."

The agreement will be renewed in every five years if there is no objection from either side. The extended tenure of the deal would boost the confidence of businessmen, said the cabinet secre-

through mutual agreement of the parties. In case of cancellation, the interested party would have to send

in a notice six months before the expiry of the tenure, mentioned Musharraf.

Cabinet members at the meeting hailed the revised deal saying it would benefit Bangladesh more than India. Manoj Kumar Roy, additional

secretary at the commerce ministry, said the officials of the National Board of Revenue, shipping ministry, and Roads and Highways Department of both the countries would sit soon to fix the transit fees.

Under the revised deal, trucks from It can be amended further Nepal and Bhutan would enter Bangladesh through the Indian corridor. Previously, they were parked at a specific point along the Indian border

where goods from Bangladesh were uploaded.

The governments of Bangladesh and India have taken different measures to increase bilateral trade. At present, the trade balance between the two neighbours is heavily tilted in favour of India.

According to experts, India exports goods worth over \$5 billion a year to Bangladesh through formal channels. But it is believed that products worth around another \$5 billion enter Bangladesh informally.

A minister said Bangladesh would earn a huge amount of revenue from India by allowing it access to Bangladesh territory.

The public administration ministry issued separate gazettes last night in this regard upon getting approval of Prime Minister Sheikh Hasina, who is in charge of

the ministry. According to officials at the secretariat, excessive promotion has already made the civil administration top-heavy. Posting and transfer of officials have become very difficult

as no vacancy is left in the civil bureaucracy. Such wholesale promotions, which have been going on for several years, are also responsible for making many officials OSDs

(officer on special duty). On March 24, the public administration ministry sent a summary to the PM seeking her nod for the promotions. The summary contained the names of the promotees.

There are 1,280 deputy secretaries against 830 approved posts, 869 joint secretaries against 350 posts and 229 additional secretaries against 120 posts. The Superior Selection Board, headed by

Cabinet Secretary M Musharraf Hossain Bhuiyan, went through the service records of the officials to prepare a list of the potential promotees. Sources in the public administration

ministry said an official is usually promoted to a higher post when it falls vacant. Since there is no vacant post, majority of

the promoted officials will continue in their current offices. Many officials who got promotion last year are still discharging duties in their previous offices.

Gazettes were issued yesterday for promoting 836 officials. Notifications about 37 others would be issued later as they are on leave.
