JU environment dept's shift to new building halts due to row JU CORRESPONDENT

Counter protest at Jahangirnagar University halted the process of transferring the environmental science department to a newly constructed building.

The university authorities had allowed the environmental science department to move into the new building on April 4 after the department staged demonstrations demanding the move, which they claimed was supposed to take place a year ago.

However, two other departments -- computer science and engineering and geological science -housed in the building, protested the move.


On April 4, they blocked the entrance to the new building barring the environmental science department access. They claimed the three-storey building is not big enough to house all three departments.

Meanwhile, at a press conference on the campus yesterday the environmental science department announced an indefinite sit-in from today if they are not allowed to move into the new building.

The university authorities will hold a syndicate meeting today to make a decision regarding the move.

Downpour pushes Ctg city under water again

Residents want problem to be major electoral issue

Chittagong city residents had to wade through waterlogged streets yesterday as most of the roads were submerged by rainwater exposing the city's poor drainage system. Only an hour-and-a-half of down-

pour submerged busy intersections like Probartak, Golpahar, Sholoshahar No-2 Gate intersection, and Chawkbazar and many other streets in knee-deep to waist-deep water. Moniruzzaman Hossain, a fruit

vendor at Probartak intersection, said the scenario is the same every rainy season for the last decade.

Ahead of the Chittagong City Corporation on April 28, voters

Manju had made solving the waterlogging problem of the city one of his electoral pledges, which voters believe had turned the tide in his favour and led to the defeat of the then ruling party-backed candidate ABM Mohiuddin Chowdhury with a huge margin of over 95,000 votes.

Roksana Akhter, who was commuting with her daughter to school in Outgoing Mayor M Manjur Alam Nasirabad area, said they had to wade through filthy water as the whole street in her area was submerged and they could not procure trans-

She said politicians can only talk and they take no action.

"Mayoral candidates will surely again promise to solve the crisis but they will forget their words once they have won the election," she said.

"One mayor comes after another promising the same thing, I have been suffering due to waterlogged streets for the last 15 years," said fruit vendor

According to CCC sources, Manju last year took an initiative to dig a three kilometre canal stretching from Boraipara of Bahaddarhat to the river Karnaphuli, with an estimated cost of Tk 289 crore, but the project is yet to be implemented.

However, CCC officials said the problem cannot be solved merely through digging canals and drains and blamed unplanned urbanisation and non-implementation of Chittagong City Drainage Master Plan as the root source of the waterlogging problem in the city.

Architect Zarina Hossain, general secretary of Forum for Planned Chittagong (FPC), said CCC alone cannot solve the problem.

Govt probe report doesn't identify rumour mongers

Nor does it clarify whether magistrates responsible for security were at their posts, but makes recommendations for avoiding recurrence

Though the Narayanganj district administration-formed committee's probe report cited rumours of a bridge collapsing to be one of the two core reasons for the March 27 Langalbadh stampede, there was no mention of who spread it or what the motive was.

Acknowledging this, one of the committee's seven members said, "It is law enforcers' job, not ours."

Moreover, there was no information on whether magistrates were at their respective posts and why the incident occurred despite monitoring by the district administration.

The seven-member committee convener, Ishrat Hossain Khan, also Local Government Division deputy director, submitted the report to Deputy Commissioner Anisur Rahman Miah yesterday afternoon.

Ten people were left dead and another 20 injured of the around 8 to 15 lakh devotees, as per locals, who had thronged the site for the annual "Maha Astami Snan".

Hindu leaders had blamed local criminals for spreading the rumours to rob devotees of valuables.

The other reason cited was a high turnout of devotees at Rajghat, the most revered of the 16 ghats there and lying at one end of the 50-yard stretch of the stampede till the bailey bridge, for several circumstances including that the event falling in a three-day holiday, a shorter window of time than yester years for the ritual holy dip in the Brahmaputra, and devotees' preference for Rajghat which is the junction of three roads. The report made a 15-point recommendation.

It includes building a ghat along a three-kilometre stretch, dredging two kilometres of the river, identifying owners of land adjoining the site and acquiring land if required, reserving space for fairs and shops, and a stop to the district administration leasing out land.

Moreover, it suggested barring roadside shops, connecting the ghat with the main road, doubling the road's width and erecting dividers; replacing the current bridges with concrete ones, deploying an "adequate" number of law enforcers and volunteers, increasing monitoring, and providing toilets, clean water, changing rooms, and sheds.

HC orders judicial probe, report in 30 days

Also wants setting up of police outpost; seeks explanation on cops' failure to investigate, take measures against perpetrators

The High Court yesterday directed Barguna's chief judicial magistrate to investigate a reported attack by local terrorists who forced 14 Hindu families off their houses and 40 acres of croplands in Taltoli upazila's Chandantala village, damaged the residences and looted goods

in March. In response to a writ petition, it also directed the magistrate to provide a report in 30 days mentioning what government measures had been taken afterwards and the

prevailing situation. The HC bench of Justice Quazi Reza-Ul Hoque and Justice Abu Taher Md Saifur Rahman ordered the government to ensure

security to the families by immediately

setting up a police outpost in Chandantala. It also issued a rule upon the government to explain why police failure to hold a fair investigation and take action against the perpetrators shall not be

declared illegal. Rights organisation Ain o Salish Kendra (ASK) submitted the petition yesterday, seeking necessary orders on the government to ensure security and rehabilitate the families and challenging legality of the police failure to provide

security. Petitioner's lawyer ZI Khan Panna told The Daily Star that ASK included with the petition a report based on its own inquiry. Two girls who had been raped cannot venture out of their homes, he added.

A house owner and his tenant died after being electrocuted beside their house in the capital's Khilgaon yesterday.

The deceased were house owner Anwar Hossain, 50, and his tenant Md Razzak, 20.

Police said around 6:00am Razzak came into contact with a live wire that fell from an electric pole due to heavy winds.

Later Anwar got electrocuted when he attempted to save Razzak with a wet wooden stick.

After three to five months, Latif was taken away by Razakars and the people fled as Razakars became active in the locality, he added.

Seven to eight months after victory was achieved, Amjad met Latif. "When I inquired about his capture by Razakars, he told me that I need not know about the matter," said Amjad, adding he did not ask anything further as Latif was elder to

Sardar Abdul Mannan's deposition was similar. During cross-examination by prosecutor Syed Haidar Ali, he said, "I do not know whether Latif was a Razakar but later I heard he had joined the Razakar force."

International Crimes Tribunal-1 adjourned proceedings until today. Latif is one of three alleged Bagerhat Razakars facing seven charges for their alleged involvement in crimes against humanity and genocide.
