Robber killed in 'shootout'

An alleged ringleader of a forest robber gang was killed in a "shootout" between law enforcers and his aides in Panirkhola area near the Sundarbans early yesterday.

The deceased, Billal Farazi, 35, son of Khokon Farazi of North Saralia village in Morrelganj upazila, was the chief of notorious Billal Bahini, police said.

Md Rezaul Karim, OC of Swarankhola Police Station, said acting on a tip-off a joint team of Rab and police conducted a drive at a garden of one Habib Hawlader around 2:30am.

He said they had information that a gang of forest robbers took position there to commit criminal activities.

Sensing the presence of law enforcers, the gang members opened fire on them, forcing the joint team members to retaliate with gunfire.

A furious gunbattle continued for around 20 to 25 minutes. The robbers retreated after finding that Billal and his accomplice Forhad Munshi, 37, were hit by bullets. Billal and Forhad, son of Mokbul

Munshi of Baruikhali village under the same upazila, were rushed to Swarankhola Upazila Health Complex where doctors declared Billal dead. The body was sent to Bagerhat

Sadar Hospital morgue for an autopsy. Forhad sustained bullet wounds in his right leg. Police recovered a double barrel

gun, a single barrel gun and 500 bullets from the spot.

Billal was an accused in a case filed in connection with abduction and murder, the OC added.

India to measure air quality in world's most polluted capital AFP, New Delhi

India's government launched a new air quality index yesterday, under intense pressure to act after the World Health Organization declared New Delhi the world's most polluted capital. **Environment Minister Prakash**

Javadekar said the government would publish air quality data for 10 cities, amid growing public concern over the impact of air pollution on the health of India's 1.2 billion people.

The government's website with the index went live yesterday morning but could not be accessed.

"The Air Quality Index may prove to be a major impetus to improving air quality in urban areas, as it will improve public awareness in cities to take steps for air pollution mitigation," Javadekar said as he launched the index at a conference on the environment.

But he gave little indication of what the government would do to improve air quality, except to say it would introduce new rules on disposing of construction waste.

He was executed the same day. The SC on September 17 last year commuted death penalty of Jamaat

leader Delawar Hossain Sayedee and sentenced him to imprisonment till death. The SC verdicts on Kamaruzzaman and Quader Mollah satisfied family

members of the war crimes victims,

justice seekers and war crimes trial campaigners, state counsels and investigators, but the judgement on Sayedee has frustrated them. However, the convicts' families, defence counsels and the party they

belong to were dissatisfied with the trial and verdicts. Kamaruzzaman, assistant secretary

general of Jamaat and a key organiser of the infamous Al-Badr force that was responsible for abducting, torturing and killing freedom fighters, intellectuals and pro-liberation people in 1971, is now in Dhaka Central Jail.

He was arrested in connection with a criminal case on July 13, 2010 and shown arrested in the war crimes case on August 2. The prosecution pressed formal

charges against him incorporating nine

charges of crimes against humanity on

January 15, 2012 and the International Crimes Tribunal-1 took the charges into cognisance on January 31. Kamaruzzaman's case was trans-

ferred to the International Crimes Tribunal-2 on April 16, 2012 for expeditious trial. On June 4, 2012, the tribunal

indicted Kamaruzzaman on seven charges of crimes against humanity including murder and torture of unarmed civilians and complicity in other crimes during the nine-monthlong war. On May 9, 2013, the ICT-2 sen-

tenced Kamaruzzaman to death for his crimes against humanity. He submitted his appeal to the SC

challenging the tribunal's judgement on June 6, 2013. On November 3 last year, the SC upheld the tribunal verdict dismissing

his appeal. On February 19, the prison authorities read out the death warrant to him after the ICT-2 had issued it the same day.

Kamaruzzaman filed the review petition on March 5, praying to the SC to scrap his conviction and acquit him

of the charges. Eminent jurist Shahdeen Malik yesterday told The Daily Star that it was satisfactory that trial of three war criminals had finally concluded and 14 had seen judgements at both the ICTs.

This was certainly a very importan achievement, he added.

"However, the trial and appeal process have taken a very long time, which is symbolic of delay in our judicial system," Shahdeen Malik observed.

He also said it would have been much better if the war crimes trial along with other judicial process would have been much more efficient and justice was delivered faster.

Attorney General Mahbubey Alam told The Daily Star that different countries had put pressure on the government for not holding the trial of war criminals and also tried to stop the proceedings. Many people, both at home and

abroad, had criticised the trial proceedings and expressed their confusion, although international standards were maintained, he said, adding, the Skype scandal was hatched to stop the trial. He added disposal of three war crimes cases had successfully taken

place due to sincerity of the government and its lawyers, judges and witnesses. Expected judgement in the case against Sayedee could not be achieved

due to neglect of investigators, he added. Law Minister Anisul Huq expressed satisfaction with the SC verdict on

Kamaruzzaman, saying justice had been delivered through it. Following the ICT-2 verdict of death sentence on Sayedee in 2013, activists of Jamaat and its student body Islami Chhatra Shibir resorted to violence across the country, leaving 65 people

dead and several hundred injured in just a week. Amid controversy over the leak of his Skype conversation with an expatriate Bangladeshi legal expert, the then chairman of ICT-1 Justice Md Nizamul Huq resigned on December

Following Justice Nizamul's resignation, Kamaruzzaman on January 2, 2013 sought retrial of the war crimes case against him.

Bangla daily Amar Desh also published "transcript of the Skype conversation" of Justice Huq with Ahmed Ziauddin, a law expert on international crimes. According to the attorney general,

those incidents were aimed at hampering the trial. Appeals filed by eight convicted war

criminals against their death sentences handed down by the two ICTs are now pending with the Appellate Division. The appellants are Jamaat Secretary

General Ali Ahsan Mohammad Mojaheed, BNP leader Salauddin Quader Chowdhury, Jamaat chief Motiur Rahman Nizami and its leaders Mir Quasem Ali, ATM Azharul Islam and Abdus Subhan, expelled Awami League leader of Brahmanbaria Mobarak Hossain and former state minister of HM Ershad's government Syed Mohammad Qaisar.

The attorney general expressed the hope that the SC would dispose of the eight appeals within one year.

While briefing reporters, Election Commissioner Shah Nawaz yesterday urged all candidates to conduct their campaign obeying the electoral code of conduct.

NOBODY WILL BE SPARED

Shah Nawaz also warned that nobody would be spared, whoever the person is, if he or she violates any electoral code of conduct.

Nawaz's statement came a day after today, said EC officials. the returning officer (RO) of

Chittagong City Corporation (CCC) polls sought directives from the EC about what action should be taken against some ministers who engaged in campaign, violating electoral codes of conduct.

a boxer dog called Kay.' Continental Giants are the largest breed of rabbit and can grow to around 4ft when fully grown but Darius - who is officially four foot four inches long and Jeff come from a bumper crop.

introduced Darius to one of her other rabbits Sally - another Continental Giant who measures 3ft 5 inches.

The family all live in her back garden but they are so big that they each require a dog crate that would normally house a pet as large as German shepherd.

Annette added: 'Darius was always big but Jeff is huge considering he's still a baby. I'm expecting him to grow

much bigger than his dad.

'As soon as I think he's made it, he'll be measured by his vet and then Guinness will certify that he is the biggest rabbit in the world.

STRANDED NATIONALS IN YEMEN

Dhaka, Delhi hold talks on evacuation

Bangladesh and India on Sunday night held a coordination meeting in Djibouti regarding evacuation of their citizens stranded in war-torn Yemen. "Gen VK Singh, Minister of State

[External Affairs] held coordination meeting with Bangladesh officials in Djibouti last [Sunday] night," the Indian High Commission in Dhaka posted on its official Twitter page yesterday. State Minister for Foreign Affairs

Shahriar Alam, who is now on an official visit to Oman, in a Facebook post yesterday said some 14 Bangladeshi reported near Al Mukalla of Yemen. "We have advised them to use the

Oman border near Salalah," he said. He added that the government of Oman had agreed to help bring

Bangladeshis back from Yemen through their border following his meeting with the Oman counterpart on Sunday. "We are also expecting over 100

Bangladeshi using Al Hudayda (Yemen city) with the help from Indian Navy," he wrote in Facebook. Shahriar also mentioned that the

Bangladesh government was seeking permission for Biman to fly either Djibouti or Sana'a. Earlier, an Indian ship had rescued

three Bangladeshis from Al

Hudaydah, a city of Yemen near its capital Sana'a. The rescued Bangladeshis are now in Djibouti and will be brought back

home by air soon. A two-member Bangladesh team from its mission in Kuwait is now in Djibouti and so far communicated with Bangladesh nationals in two cities -- Aden and Sana'a in Yemen.

Some 1500-3000 Bangladesh nationals are living in Yemen, accord ing to Foreign Secretary M Shahidul Haque.
