Guyanese envoy meets foreign minister

Bangladesh offers skilled manpower

Bangladesh has offered Guyana skilled manpower like physicians, engineers and agriculturists to play an important role in utilising its resources. Foreign Minister AH Mahmood Ali

made the offer when Jairam Ronald Gajraj, newly appointed non-resident high commissioner of the South American country to Bangladesh, called on him at the foreign ministry vesterday.

Guyana, officially the Co-operative Republic of Guyana, is a sovereign state on the Caribbean coast of South America.

During the meeting, the Guyanese envoy commented that the two countries can set up a joint commission for the benefit of the two nations.

In this context, the foreign minister proposed that the two countries can identify the areas of cooperation and explore new areas through holding regular Foreign Office Consultations (FOC).

The high commissioner, based in New Delhi, accepted the idea and said that his country would soon begin the FOC, a structured system for annual dialogue at the foreign secretary level.

Ctg battery-run rickshaw owners, drivers threaten tougher movement for legitimacy

Owners and drivers of battery-run rickshaws yesterday threatened to enforce a tough programme, including hartal, if their vehicles are not allowed on Chittagong city roads within 72 hours.

The demand came from a rally organised by Battery Rickshaw Owners-Drivers' League before Chittagong Press Club.

Speakers said they appealed to the authorities concerned and also to the prime minister but got no response. Jatiya Sramik League's Chittagong city unit general secretary also spoke.

Earlier, police gave an ultimatum to remove batteries from the vehicles or take those off the roads by March 22. The city has around 50,000 battery-run rickshaws.

Lumpur Shahidul Islam said the mission and the company have to work fast to meet the deadline. Of the seven lakh migrants in Malaysia, two lakh have received their MRPs as of March.

In the UAE, officials at Bangladesh embassy in Abu Dhabi said the Malaysian company is enrolling around 100 migrants a day. The mission is enrolling around 500 from Abu Dhabi and Dubai offices every day.

IRIS has eight APCs in the UAE and all of them were in remote areas, said a mission official. Of the 10 lakh migrants, around six lakh got MRPs.

Realising IRIS's poor performance, the foreign ministry took the initiative to increase enrolment capacity at its missions in Saudi Arabia, the UAE and Malaysia. But the MRP project authority is dillydallying, said foreign ministry officials.

Other cities to which Biman would have more frequent flights are Jeddah, Dammam, Riyadh, Bangkok and Singapore. Some of the cities are already seeing increased number of flight and the others would see it soon.

In his first press briefing since he took the job in January this year, Heywood yesterday said Biman suspended its operation on Dhaka-Rome route last week as it was incurring a loss of \$10 million a year.

"We will be looking for a very advanced plan for other destinations in South Asia, Far East and an option for China with the availability of two brand new aircraft later this year or early next year," Heywood, also the chief executive officer of Biman, told the briefing at Biman's headquarters Balaka Bhaban.

Two brand new Boeing 737s were supposed to join Biman in the winter, he added.

As part of a deal with Boeing to purchase 10 aircraft, the US plane maker is supposed to deliver the two 737s within this year. Biman has already received four Boeing 777-300ERs (extended range) aircraft from Boeing.

Supreme Court," says the statement Kamaruzzaman was meted out death penalty on charges of crimes against humanity by the Bangladesh International Crimes Tribunal.

The trial was reportedly marked by irregularities and failed to meet "international fair trial standards", says the statement received here from Geneva.

Raising questions about the fairness of Kamaruzzaman's trial, the statement says, "The UN Human Rights Committee, which interprets the International Covenant on Civil and Political Rights, which Bangladesh has ratified, has stressed that 'in cases of trials leading to the imposition of the death penalty, scrupulous respect of the guarantees of fair trial is particularly important' and that any death penalty imposed after an unfair trial would be a violation of the right to life."

Mentioning Kamaruzzaman's filing of an independent review of his death sentence to the Appellate Division of the Supreme Court on 5 March 2015, the statement alleges that "without hearing the application on its merits, the Supreme Court summarily rejected his petition."

It also points out that "the UN opposes the use of the death penalty, even in cases where stringent fair trial standards appear to have been met and even for the most serious international crimes."

The statement also urges the Bangladesh government to "join the growing number of States that have abolished this inhuman practice."

fied in the 1940s, yet their intricacies have gone largely unanalysed because they are so quiet and virtually indistinguishable to the human ear.
