In Chittagong, AL lawmakers MA Latif and Shamsul Hoque along with one of their personal secretaries went to the Returning Officer's office around 4:20pm yesterday with some applications for nomination withdrawal.

Seven mayor aspirants, including BNP leader Abdus Salam, former AL lawmaker Sarah Begum Kabari and sacked Jatiya Party chief's adviser Bobby Hajjaj quit the race for Dhaka city polls vesterday.

After their withdrawal, 36 mayor hopefuls are now in the race -- 16 in Dhaka north and 20 in Dhaka south.

Actress Kabari, who had submitted nomination papers to run in Dhaka north, told reporters that she quit on instructions of Prime Minister Sheikh Hasina.

Bobby Hajjaj, who too had intended to run in Dhaka north, withdrew his nomination, claiming he lost his faith that the Election Commission could hold a free and fair election.

"The election commission has failed to do anything visible to earn trust. My supporters are facing difficulties ... it's a pressure on me. That's why I've decided to quit the race," he told a press conference at his Banani office

Japan to pledge 20% green house gas cut: report

Japan will promise to cut its greenhouse gas emissions by 20 percent from 2013 levels ahead of a global summit on climate change this year, a report said yesterday, despite uncertainty over post-Fukushima energy policy.

The government will likely announce the new target at the Group of Seven (G7) summit in June in Germany, the leading business daily Nikkei reported, citing unnamed government sources.

In a separate report, Kyodo News said Tokyo will set a target of cutting gas emissions "by at least 20 percent by 2030, from 2005 levels."

Japan is one of the few leading polluters that has not yet declared a target on emission cuts, as the world works towards a new framework for combating climate change, to be finalised at December's COP 21 gathering in Paris.

3 suspected robbers beaten to death

Locals beat three alleged robbers to death in Meherpur Sadar upazila early yesterday.

The dead are Faruq Hossain, 36,

son of Abdur Razzak, and Rafiq Hossain, 42, son of Nazer Ali, of Chokshyamnagar in the upazila; and Shariful Islam, 33, son of Ayub Ali of Juginda village in Gangni upazila. A gang of five to six men entered Rajapur village around 12:00am.

Seeing the unknown faces, farmer Bhashan Ali, who was working in his paddy field, asked them to inform him about their identities. Following this, the gang became angry and beat up Bhashan, according to police. The farmer then informed his

family and relatives about the matter through his mobile phone. Bhashan's relatives along with other villagers surrounded the area and started to chase the gang. The "robbers" blasted five hand-

made bombs in order to escape. But the mob caught three of them, said police. The villagers then beat them up

mercilessly around 1:00am. One of the gang members died on the spot, and two others were critically injured. On information, police rushed to

the spot and took the two "robbers" to Meherpur General Hospital where on-duty doctors declared them dead. A pistol and a bullet were found in

possession of one of the dead, said Azbahar Ali Sheikh, Meherpur additional superintendent of police.

The three were involved in robbery in the district, the police official added.

Obama and Castro to break Cold War ice in person

US President Barack Obama and Cuba's Raul Castro will have a historic face-to-face encounter at the Summit of the Americas this week, breaking the ice after decades of glacial relations.

The image of US and Cuban presidents sitting across from each other at the 35-nation summit for the first time after decades of Cold War-era animosity will be the highlight of the gathering in Panama on Friday and Saturday.

While the meeting will mark a major milestone -- no Cuban leader has attended a Summit of the Americas -- the two sides have yet to reopen embassies and lingering differences have been evident at negotiations that started in January.

A major sticking point has been Cuba's inclusion on a list of state sponsors of terrorism.

The White House indicated this week that the State Department was in the "final stages" of deciding whether to recommend Havana's removal from the list, and that Congress would then have 45 days to decide whether to override the decision.

"We're trying to get it done quickly," a US State Department official told AFP on condition of anonymity. In another sign of warming ties, the US State Department said Secretary of State John Kerry could meet with Cuban Foreign Minister Bruno Rodriguez on the sidelines of the summit.
