WikiLeaks dumps Sony hack data

WikiLeaks published thousands of documents on Thursday from last year's Sony hacking scandal, calling them an insight into the inner workings of a "secretive" firm.

The website said the searchable data dump includes 30,287 documents from the US-based Sony Pictures Entertainment and 173,132 emails to and from more than 2,200 company email addresses. The same data was released online

after hackers attacked Sony Pictures last November and threatened the company over the release of the comedy film "The Interview," which depicts a fictional CIA plot to kill North Korea's leader.

The threats saw Sony cancel the public debut of the movie and led to the resignation of chairperson Amy Pascal. The leaks showed that Pascal had swapped racially insensitive jokes about President Barack Obama over email. Washington blamed North Korea

for the hack. "Now published in a fully search-

able format The Sony Archives offer a rare insight into the inner workings of a large, secretive multinational corporation," WikiLeaks said in a statement. It said the original release was not

searchable and was removed before the public and journalists could scrutinize them. WikiLeaks described Sony as an

influential corporation with ties to the White House, able to impact laws and policies, and with connections to the US military-industrial complex.

"It is newsworthy and at the center of a geo-political conflict," said WikiLeaks founder Julian Assange, who lives at Ecuador's embassy in London to avoid prosecution for alleged rape in Sweden.

"It belongs in the public domain. WikiLeaks will ensure it stays there," the Australian former hacker said.

Sony condemned the re-release of the data, saying the private information does not belong in the public domain and WikiLeaks is helping the hackers' efforts to harm employees.

"The cyber-attack on Sony Pictures was a malicious criminal act, and we strongly condemn the indexing of stolen employee and other private and privileged information on WikiLeaks," Sony said in a statement.

FROM PAGE 1 those who are administering them and participating in the elections to uphold their responsibility to ensure they are free, fair, and nonviolent," said Marie Harf, acting spokesperson of the US State Department.

"There could be no room here for violence or intimidation. That's the message we've been sending to the Bangladeshis as they go forward here," she told a daily press briefing in Washington, DC on Thursday.

In reply to questions on the polls, she said the US had encouraged the Bangladesh government and election commission to protect citizens' rights to free expression and association during the campaign, again, to ensure free, fair election on polling day.

"We also expect all parties to follow democratic practices, and really, there could be no room here for violence or intimidation. That's the message we've

been sending to the Bangladeshis as they go forward here." Responding to another question about the arrest of a councillor candidate and the split order on bail of BNP-blessed mayoral candidate

Mirza Abbas, she said, "I hadn't seen those reports today. Let me check with our team and see if there's more to say about this."

Former-right-hand man to Saddam 'shot dead'

Ezzat Ibrahim al-Douri, former righthand man to late Iraqi president Saddam Hussein and a leader of Iraq's Sunni insurgency, has been reported killed by Iraqi forces and Shia militias.

Douri was killed in a military operation, Raed al-Jubouri, the governor of Salahuddin province, told Reuters. The pan-Arab television network al-Arabiya showed images of a dead man who looked like al-Douri. Baghdad has mistakenly

announced al-Douri's death several times before, but this time photos are circulating showing a man with features and red hair like his. Al-Jubouri told Reuters DNA from the body would be tested and results released "very soon". His killing, if confirmed, would be a

big blow to the Sunni insurgency, an alliance of former Baathist officers and Islamic State. "The mastermind of terrorist opera-

tions has been killed and he is Ezzat al-Douri," al-Jubouri told Arabiya TV. "Al-Douri is the biggest mastermind behind all attacks that undermined Iraq. This news will have an impact on the morale of the fighters."

After the 2003 US-led invasion, Douri was ranked sixth on the US military's list of 55 most wanted Iraqis and a \$10 million reward was offered for his capture. Iraqi and US officials accused him of organising and leading the insurgency that swept Iraq in 2005-07.

He evaded capture during the long US occupation as other Saddam aides were killed or put on trial and sectarian civil war engulfed the country. Karim al-Nouri, a leader in the Badr

organisation and spokesman for Shia militias fighting Islamic State, said his forces had been involved in the operation although they thought the target was the leader of Islamic State, Abu Bakr al-Baghdadi. "We received intelligence from our

sources that a VIP was in the city of Hawija and we were waiting to ambush him. Based on our intelligence, it was believed that the man was al-Baghdadi, but it turned out to be al-Douri." "He was the second man after

Saddam Hussein and was the coordinator between the Baath party and IS. The body is now taken for identification, but we are certain it is al-Douri," al-Nouri added. Khdhayer Almurshidy, an exiled spokesman for Iraq's former Baath party, said in comments to Iraq's al-Hadath TV that the reports of al-Douri's death were false. Al-Jubouri however told Reuters that

"a group of security forces went and surrounded an area and those terrorists were killed. Three of them were suicide bombers and blew themselves up. Amongst the bodies was Douri's."

He said the operation was carried out in the Hamrin area near al Alam in Salahuddin province. Iraqi forces did not know al-Douri was there beforehand.

Bangladeshis were the largest group of victims among other nationals, he added.

In the last several days, foreign nationals including Bangladeshis were coming under attack by local goons.

Bangladeshi embassy in Pretoria, one of the capital cities of SA, did not give any direction to the expatriates in this situation.

The expatriates, however, kept their shops closed and took shelter in safer places in Pretoria.

Bangladeshis, living in fear of further attacks, sought help from the Bangladesh government in this regard, Mizan said.

Around 60,000 to 70,000 Bangladeshi expatriates now live in South Africa. Apart from legal expatriates, a group of Bangladeshis live there illegally, which often causes problems for legal migrants.

About 200 foreigners took refuge at

a police station, and 12 people were arrested over the attacks, reports BBC English Service.

The attacks were carried out despite Thursday's rally against xenophobia in the coastal city of Durban, and condemnation from President Jacob Zuma.

President Zuma condemned the recent xenophobic attacks terming them "shocking".

"No amount of frustration or anger can justify the attacks on foreign nationals and the looting of their shops," he told parliament on Thursday.

At least five people have died in xenophobic attacks in recent weeks.

A crowd began looting shops owned by foreigners in East Johannesburg on Thursday night. A car and a building believed to house foreigners were also set on fire.

Many jobless South Africans accuse foreigners of taking jobs in a country where the unemployment rate is 24 percent, reported BBC.

JU teachers and students under the banner of "Shikkhak-Shikkharti Oikya Mancha" yesterday announced that they would form a human chain on the campus today at 11:00am, demanding punishment of the culprits.

Meanwhile, the JU chapter of the BCL, the student front of the ruling Awami League, suspended the eight activists, accused of the sexual assault.

A press release signed by JU BCL President Mahmudur Rahman Jony and General Secretary Razib Ahmed Russel, stated that the decision was taken as their involvement in the incident was proved in primary investigations.

The faction of the BCL, who swooped on a cultural programme at the university auditorium, was led by Iftekharul Islam Real and Arun Kanti Roy, president and general secretary of the university unit BCL.

A pall of gloom descended on Zakaria's home as soon as the family heard the news of his death. Mostague Ahmed, father of

Zakaria, said all his dreams were shattered with his son's death. "He [Zakaria] said he would take

over the responsibility of the family once his education was complete. But everything is gone now," he lamented.

He blamed dirty politics for his son's death.

Zakaria's mother Jannatul Ferdous alleged that Iftekharul Islam Real was responsible for her son's death. Nothing could soothe Zakaria's

sister Meem who had been crying since she heard the news. Sadekur Rahman, assistant proctor

of the HSTU, said the clash was the result of expelled students trying to make a comeback. Arun Kanti Roy, Zahid Hasan and Aditya Dutta were expelled from the university in November last year for helping potential freshmen cheat in the admission test.

No one was arrested in connection with Thursday's incident, said ATM Khalequzzaman, officer-in-charge of Dinajpur Police Station.

A large contingent of police remains deployed on the campus.

Dolphin turns

While bottlenose dolphins are typically grey, the mammal is completely white -- apart from the quirky tendency to turn pink when it is feeling angry, sad or even embarrassed.

The phenomenon results from the animal's thin skin, which means its blood vessels can cause a change in skin tone depending on its emotiona state.

Essentially, they blush in the same way as humans.

The rare specimen is believed to be only the second one ever put on display in an aquarium after it was purchased from fishermen last year. The animal was controversially

captured during the annual dolphin hunt in the town of Taiji in January last year. The quirky colouration meant the

fishermen would get more selling it to an aquarium than as meat. The Taiji hunt was made notorious

by the 2009 Oscar-winning documentary 'The Cove,' which depicted fishermen capturing hundreds of dolphins for aquariums or to be killed for meat. Japan's Wakayama Prefecture, which includes Taiji, reported that

1,218 dolphins and small whales were captured there in 2011, though it did not specify how many of those captured were killed. Environmental activists filed a lawsuit against the Taiji Whaling

Museum in May 2014, claiming it had refused experts to check on the safety of the elusive dolphin. But the museum claims the creatures health has been monitored through periodic blood tests, and that
