Farmer Tarachand Mathur was one of millions of Indians who voted Narendra Modi into power last year, but the government's push to make it easier for big business to forcibly acquire land means he won't be back-

turned his back on the plight of farmers, many of whom have seen their crops devastated by unseasonal rains since the start of this year.

"I am on the brink of ruin," he said, close to tears, as he tended the wheat growing on his smallholding in Kanjhawala village around 15 miles (25 kilometres) northwest of New Delhi. "The rain gods don't hear us and Modi has also turned deaf to our cries."

India's poor but powerful farming lobby flocked to Modi's right-wing Bharatiya Janata Party (BJP) at the general election last May, when the Hindu nationalist premier won the biggest mandate in 30 years.

But anger in rural areas has been mounting over his government's bid to overhaul land purchasing laws, compounding woes over extensive damage to winter crops due to unseasonal rain across northern India.

Coca-Cola to buy Chinese protein drinks business AFP, New York

...... Coca-Cola has agreed to buy a Chinese plant-based drinks business, renewing its push into the China market after authorities in 2009 blocked its bid for a juice company.

CocaCola said Friday it would pay about \$400 million in cash to acquire Xiamen Culiangwang **Beverage Technology** Company, a producer of plantbased protein drinks sold in China.

"The proposed acquisition is in line with Coca-Cola China's strategy to continue providing a diverse range of beverage products to Chinese consumers with plantbased protein drinks representing a growing beverage category in China," the US beverage giant said in a statement.

The company's topselling products include green bean, red bean and walnut variants of plantbased protein drinks sold under the brand China Green Culiangwang, Coca-Cola said. It is based in Xiamen, Fujian province.

GE reports \$13.6b loss on finance sale charges

...... General Electric Friday reported a \$13.6 billion first-quarter loss on charges from its plan to sell most of GE Capital as profits rose in four of seven industrial businesses.

The big loss had been expected after GE said a week ago that it would take about a \$16 billion charge due to the GE Capital divestment. GE reported \$3 billion in profits in the year-ago period.

The plan to sell most of its finance operations is part of an overhaul directed by chief executive Jeff Immelt to emphasize the company's industrial and technological prowess.

In the first quarter, a big gain in aviation profits and smaller increases in transportation, appliances and lighting, and health care made up for lower profits from power and water, and oil and gas.

Overall industrial profits rose 8.6 percent to \$3.6 billion.

Chief financial officer Jeff Bornstein told an analyst conference call that GE is on track to meet its target of \$1.10-\$1.20

per share in 2015 industrial earnings.

The first quarter's earnings were also held back by the drag from the strong dollar, which dented revenues by \$950 million.
