Khaleda's adviser Dudu seeks bail again STAFF CORRESPONDENT

Shamsuzzaman Dudu, an adviser to BNP Chairperson Khaleda Zia, yesterday filed four petitions with the High Court, seeking bail in separate vandalism and arson cases.

The four cases were filed on November 5 last year and January 5, 8 and 10 this year for vandalising passenger vehicles and hurling petrol bombs at those during agitation programmes enforced by the BNP-led 20party alliance.

Shamsuzzaman's lawyer said the cases were filed to politically harass his client.

Police picked up Shamsuzzaman, also secretary of Jatiyatabadi Krishak Dal, from Mirpur-2 on January 10.

KHALEDA'S GRAFT CASES

HC starts hearing four petitions

Rejecting an adjournment prayer, the High Court yesterday started hearing four separate seven-yearold petitions of BNP Chairperson Khaleda Zia challenging the legality of three corruption cases against her.

Khaleda filed the petitions on different dates in 2008 challenging the legality of the proceedings of Barapukuria coalmine, Gatco and Niko corruption cases filed by the Anti-Corruption Commission.

Yesterday, the HC bench of Justice Md Nuruzzaman and Justice Zafar Ahmed adjourned the hearing of the petitions till 2:00pm on Wednesday, ACC's lawyer Khurshid Alam Khan told The Daily Star.

Earlier in the day, the bench rejected a prayer moved by Nazmul Huda, a lawyer for Khaleda, for adjourning the hearing of

the petitions till May 20. But, the bench rejected the adjournment prayer and asked the petitioner's counsels to place argu-

ments on the petitions. On April 7, Chief Justice Surendra Kumar Sinha assigned the bench led by Justice Nuruzzaman to deal with the petitions.

Earlier on April 5, another bench of Justice Md Moinul Islam Chowdhury and Justice JBM Hassan sent all her four petitions to the CJ due to "unprofessional and unethical conduct of the lawyers for the petitioner (Khaleda)".

Road crashes kill 2, hurt 2

In Pabna, Khokon Hossain, 40, of Pabna Sadar died and his two coriders were injured when a truck rammed into his motorcycle in Gaspara area of the upazila on Saturday.

Bangladesh-US talks on April 29

Mass Molestation of Females on Pahela Baishakh

Protests resound in capital five days into incident without any arrest

Fine arts students kept at bay as they try to enter Shahbagh Police Station to condemn cop nonchalance; Gowher Rizvi claims govt will spare none

The capital saw a plethora of protests for the fifth day yesterday against Pahela Baishakh's mass molestation of women at Suhrawardy Udyan but a group of Dhaka University's fine arts students was denied entrance to Shahbagh Police Station when they tried to protest on the premises against "the cops' gross negligence in duty on the day of the incident".

Addressing the on-duty policemen from outside the locked gate, the students threatened to wage tough movement if the sexual offenders are not brought to book within 24 hours. "How could the criminals assault women for over

an hour in front of you? Have you been wearing blinders?" Jayatu Jahan, an MA student, asked the policemen standing inside the gate.

"How long does it take you to understand that women were being assaulted?" asked another stu-

dent Zarin Tasnim. Asking the students to be patient, Officer-in-Charge Sirajul Islam replied that a high powered probe committee is working on the case.

The students and teachers of the Faculty of Fine her in doubt whether the perpetrators would Arts (FFA) also formed a human chain on its premises demanding immediate arrest of the assaulters.

Noted cartoonist Prof Shishir Bhattacharya and FFA Dean Prof Nissar Hossain drew large caricatures of sex offenders on the road which the students later completed.

Meanwhile, Prime Minister's International Affairs Adviser Dr Gowher Rizvi said the government will bring the perpetrators to book. It may take some time to complete the legal proceeding including the investigation but the government will not spare anyone involved in the incident, he said at BBC Bangladesh Sanglap in the capital yesterday.

Inam Ahmed Choudhury, an adviser to BNP Chairperson Khaleda Zia, said such incidents recur as the perpetrators go untried. He also blamed

moral degradation for such incidents. Syeda Rizwana Hasan, chief executive, Bangladesh Environmental Lawyers Association, said the comments of law enforcing agencies put

really be brought to book.

Meanwhile, quoting media reports, DU teachers, in a press statement, said it was an organised group that tried to sexually assault women in the presence of police. It is shameful for the whole nation that any of the criminal is yet to be arrested, added the release signed by over 50 teachers.

Samajtantrik Chhatra Front and Bangladesh Chhatra Federation also brought out separate processions and staged rallies on the DU campus.

Bangladesh Chhatra Federation also demanded resignation of DU Proctor AM Amzad, blaming him for his inaction in taking any step to nab the perpetrators.

During the joyous celebration of Pahela Baishakh, some 30 to 40 rowdy youths assaulted and sexually harassed around 20 women for about one hour at the Suhrawardy Udyan gate near the TSC area around 6:00pm on Tuesday, said witnesses.

The CCIV footage of that day also clearly showed multiple incidents of sexual assault on women.

successfully by different NGOs in the riverine char islands of ten northwestern riverine districts to achieve the goals.

He said more than 5.17 lakh people were being benefited now under the CLP phase-I during 2004-2010 and phase-II during 2010-2016 periods to improve livelihoods as well as life standards.

The things are changing fast following socioeconomic development in recent years helping the char people to overcome curses like child marriage, dowry and polygamy and arranging marriage of their children now with proper registration, he said.

Head of Programme Coordination Monjusree Saha of RDRS Bangladesh said the char people lived in utter poverty for decades, but they were now achieving socioeconomic uplift and eradicating social curses to lead meaningful life.

Couples -- Ramjan Ali, 77, and Ayesha, 65; Abul Hossain, 67, and Feroza, 56; and Majibar Rahman, 66, and Khatun, 57 -- of Khamar Banspatari char village in Chilmari upazila of Kurigram registered marriage at a ceremony after many years of wedding.

Like them four other couples said they felt themselves as worthy citizens by registering their marriage even after 10 to 22 years of wedding.

"Now, we understand about a better future, but earlier not," they said and vowed to stop marriage with dowry, child marriage or marriage without registration in building a happy and prosperous society through ensuring planned families.

Similarly, 15 couples registered their marriages at another recent ceremony in remote Arazi Kanua char village in Kawnia upazila of Rangpur after 20 to 35 years of beginning conju-
