## HARASSMENT OF FEMALE ADIVASI STUDENT JU teachers, students also demand proctor's resignation

Protesting the recent harassment of a female indigenous student, Jahangirnagar University's (JU) teacher-student platform Shikkhak Shikkharthi Oikya Mancha yesterday announced three days of agitation starting today with a rally around 11:00am with five demands including the proctor's resignation. JU suspended eight students and the Bangladesh

Chhatra League unit there five activists over allegations they sexually harassed the student, assaulted her male friend and snatched their belongings near Munni Shoroni road on the evening of Pahela Baishakh on April 14.

With some 22 students' social and cultural associations expressing solidarity, the platform at a press conference at the social science building around 4:00pm also demanded that the guilty be expelled and handed over to police, a case filed and measures to prevent recurrence.

They accused the proctor of refraining from taking punitive measures against BCL men in the past and misbehaving with victims, including the student who they said had been told to find the attackers' identities.

The 53rd death anniversary of Sher-e-Bangla AK Fazlul Huq will be observed with due respect today.

On the occasion, various sociopolitical organisations, including BNP, have chalked out elaborate programmes, including placing wreaths and offering Fateha at his grave.

His family will hold a milad mahfil in their Banani residence in the capital after Maghrib prayers. Sher-e-Bangla Smrity Academy Bangladesh will hold a milad near his mazar. A discussion will also be organised at Razpur upazila of Jhalakathi at 9:00am.

He served as the mayor of Calcutta (1935), chief minister of undivided Bengal (1937-1943) and of East Pakistan (1954), home minister of Pakistan (1955), and governor of East Pakistan (1956-58).

He founded Krishak Praja Party which championed the rights of the Bangalee peasantry. He established Bangla Academy in Dhaka in 1954.
