spectacled langur, Hoolock gibbon and golden langur, is spread across both the countries with the border fencing passing through it, and loss of habitat posing a major threat to the wildlife present in the forest, he pointed out. Spectacled monkeys have been

sighted here in large number, though a proper survey is yet to be conducted while several colonies of the Hoolock gibbon and some golden langur have also been sighted within the forest. "The primary focus of the conser-

vation effort will be to preserve the habitat for the survival of the primates and awareness campaigns would be conducted in the fringe villages to urge people not to destroy the forests for firewood," he said.

The BSF personnel, guarding the India-Bangladesh border along this sector, have also been urged to ensure that the forest is preserved so that it remains a safe haven for the primates, Gohain Boruah added.

The Patharia Hills Reserve Forest, spread over an area of 7647.30 hectares on the Indian side, is predominantly a natural forest on the western border of Karimganj and consists of two blocks Patheria 'A' and 'B'.

"The forest is dotted with several 'cherras' or springs which helps to drain out the stock water quickly and along with the alluvial soil present leads to quick growth and natural regeneration of the forests," divisional forest officer S Ahmed said.

There has been some plantation along the southern side of the forest of teak trees but the forest remains natural with bamboo, cane, reeds and shrubs mostly found in the forest, he added.

In Assam, this is the only forest where the spectacled monkey or the "Phayre's leaf monkey" is found while Mizoram and Tripura, where it is the state animal, are the other two states in the country where it inhabits, he said.

Eighty-six people were killed, 55 of them burnt to death in attacks carried out on buses and goods-laden trucks. It even showed no care for 14.79 lakh SSC examinees who were left to suffer with tests being either postponed or cancelled.

The country remained stuck in a sticky stew, even a temporary way out of which appeared impossible to pundits and politicians as Prime Minister Sheikh Hasina and BNP Chairperson Khaleda Zia have hardly any record of agreeing on issues of national interest.

But Hasina emerged shrewder of the two when she suddenly declared on February 16 her intention of holding the long-pending elections in the capital along with the one in the port city. She could read well the situation the BNP was in -- the party desperately needed an excuse to come out of its hartal groove. And Hasina's government needed a relief from the hartal spate. So, she killed two birds with one

Khaleda's decision to boycott the 2014 general election was suicidal and to continue the hartal and blockade in 2015 for three months was also a grave mistake for the party that ruled the country for 15 years. The BNP is not in parliament as it boycotted the national polls, and not on the streets for fear of the ruling party wrath. And they grew all the more fidgeted when Khaleda was literally directing the party towards its political funeral by indulging in targeted attacks on the poor people who had to defy non-stop hartal-blockade for a living.

However, some believe the BNP chief had no choice. She could see how her hartal-blockade programmes were becoming toothless, with traffic jams on the roads, educational institutions open, offices and industries vibrant during hartal hours. So, days after the Election Commission declared on March 18 election schedules, she agreed to let the BNP go into the polls following several rounds of meetings with party leaders and allies. Hartal was eventually called off officially, and Bangladesh heaved a sigh of relief.

But politics, as of now, is far from being fair. The government has made it sure that life becomes difficult for the BNP in the elections. Most of the BNP leaders have ended up either in jail or gone into hiding in the last one year. Criminal cases have also been piled up against aspiring ward councillors, who could not be seen in their campaigns as the Dhaka police made it clear they would arrest anyone wanted in criminal case.
