### UN chief's call to Hasina was with urge for political congeniality

Ban Ki-moon's spokesperson explains to media in New York

UN Secretary-General Ban Ki-moon called Prime Minister Sheikh Hasina on Friday to urge her to find a political way forward between all the parties in Bangladesh, the UN chief's spokesperson has said.

Addressing the daily press briefing at the UN Headquarters in New York on Monday, Stephane Dujarric said, "The Secretary-General, I think, expressed his opinion in the way we've been expressing it here, which is to call to find a political way forward between all the parties in Bangladesh."

He made the remarks following a query what the UN chief had exactly told Hasina after the recent city polls in Bangladesh.

"You know, we do not have a readout to share," he added.

During Friday's phone conversation, the UN chief said BNP's participation in the recently held Dhaka and Chittagong city polls was relieving, but expressed concern over the party's withdrawal from the election midway through the polls, reported news agencies.

In response, Hasina told Ban that there was no scope to raise any question over the credibility of elections, as an average of "44 percent of the votes were cast".

### Norway world's best place to be a mother

Norway ranks as the world's best place to be a mother, well ahead of the United States which dropped to the 33rd spot in the annual scorecard released by Save the Children.

Somalia is the worst place, just below the Democratic Republic of Congo and the Central African Republic.

Cities in Bangladesh, Cambodia, Ghana, India, Kenya, Madagascar, Nigeria, Peru, Rwanda, Vietnam and Zimbabwe have the highest gap for child survival, with poor children three to five times more likely to die than their affluent peers.

Save the Children released its 16th annual Mothers' Index, which rates 179 countries based on five indicators related to maternal health, education, income levels and the status of women.

## BPDB makes new record of daily power generation

A team of India's National Intelligence Agency (NIA) met top police officials in Dhaka yesterday and shared information on absconding JMB men charge-sheeted in the sensational Burdwan blast case.

"We also shared evidence of the three fugitive Jama'atul Mujahideen Bangladesh operatives' involvement in the blast," said one of the Bangladeshi police officials after the meeting at the police headquarters. He wished anonymity as he was not allowed to talk to the media about the outcome of the meeting.

Earlier, India's home and external affairs ministries had made formal requests to Bangladesh for handing over the information and evidence to them. The official at the police headquar-

ters said the evidence was important for the NIA to prove the charges, pressed against the accused, in the court which would conduct the Burdwan blast trial "soon".

Inspector General Sanjib Kumar Sinha, may meet the Rapid Action Battalion high-ups today, said a high official of the Rab, the elite force that leads the counter-terrorism operations

in the country.

On Saturday, the NIA officials came to Dhaka on a four-day visit.

Repression Prevention (Special) Act] 1995 was amended in 2000 under the title Prevention of Oppression against Women and Children Act 2000.

Section 34(2) of the 2000 act, which had allowed trial and punishment of the offenders under the Women and Children Repression Prevention (Special) Act 1995, has been cancelled following the apex court judgment, they said.

Sections 6(3) and 6(4) of the 1995 law were also declared unconstitutional by the top court.

The provision of section 6(3) said if multiple people in group rape a child or woman, they will be sentenced to death or life imprisonment.

Section 6(4) said if multiple people in group cause death of a child or woman after committing rape, they will be sentenced to death. Asked about the consequences of

the cases and sentences given to the accused under the scrapped provisions of 1995 law, the attorney general said it HC against the trial court verdict. But would be known after the SC releases the HC on February 25, 2004, upheld the full verdict.

The HC on March 2, 2010, also stayed the execution of death sentence of Sukur Ali, son of Hashem Mondal of Manikganj. He was given capital punishment under the section in a rape and murder case filed in 1999. Sukur was 12-year-old then. On July 12, 2001, the Women and

The bill's approval indicates the BJP government's resolve to get it cleared in parliament, bringing all parties on board, say analysts. According to diplomatic sources in

Dhaka and New Delhi, if the bill is passed, Indian Prime Minister Narendra Modi might visit Bangladesh sometime next month. Modi had earlier indicated that he would visit Dhaka when one of the two

Azad and Sharma then talked to Congress President Sonia Gandhi about it, after which the party decided to support the bill.

Contacted, Sharma said, "It is our bill. We supported it only when Assam was included. We had made it clear that we will oppose the exclusion of Assam from the bill tooth and nail. With Assam now included, we have no problem with the bill. We will support In her reaction, West Bengal Chief

Minister Mamata Banerjee said her government supported the LBA with Bangladesh as people wanted it. She sought a package from the Centre for rehabilitation of those to be

affected in exchange of adversely-held enclaves. "With [rehabilitation] package, we are supporting it [agreement]," Mamata told reporters in Jalpaiguri.

Meanwhile, the Assam government said it is going ahead with the LBA with full support of the residents of Karimganj and Dhubri districts where the protocol will be implemented. "If we do not have support of the

local people, we cannot get anything forcefully. But we have full backing of the people of Karimganj and Dhubri districts," Assam's Additional Chief Secretary (Revenue) Subhash Chandra Das told reporters in Guwahati.

The passage of the LBA will correct the haphazard drawing of the Radcliffe Line that separated West Bengal and then East Pakistan in 1947.

Following Bangladesh's independence, Bangabandhu Sheikh Mujibur Rahman and Indira Gandhi signed the

agreement on May 16, 1974. But its ratification has been due for more than 41 years.

Once ratified, it will bring an end to the miseries of the people living in the landlocked enclaves without citizenship over decades.

According to the LBA protocol signed during then Indian PM Manmohan Singh's Dhaka visit in September 2011, people living in border areas will not be dislocated and all areas of economic activity relevant to homestead will be preserved.

Recently, there was confusion and uncertainty after the BJP moved to exclude Assam from the LBA amid Assam BJP's strong opposition to the state's inclusion in it. The Assam BJP apprehended that the state's inclusion could ruin its chances in the next Assembly elections.

But the Congress Party opposed the move, and warned it would resist tabling the bill in Rajya Sabha if Assam is not included in the LBA bill. Congress is in power in Assam and has majority in Rajya Sabha, the upper house of Indian parliament. FACTS ABOUT LBA

The LBA has three components. One is

That helped get the first infrasound recordings ever taken at such altitudes, according to Daniel Bowman, the University of North Carolina student who captured the sounds.

Bowman described the


sounds as "like the X-Files", and scientists aren't sure where they came from. Current guesses include sound from a wind farm, the

ocean, wind or vibrations from cables on the balloon, according to Live Science. The scientists will be sending more devices up as part of the 2015 run of

the project, and hope that they can learn more then. "I was surprised by the sheer complexity of the signal," Bowman told Live Science. "I expected to see

a few little stripes."

Bowman hopes that the recordings will be able to revive interest in infrasound recordings, which haven't been made in the stratosphere for 50 years.
