

### Apex Footwear rebuts allegation of refusal to give maternity leave

Apex Footwear Ltd yesterday issued a press statement in relation to Saturday's incident when a female worker, allegedly denied maternity leave, gave birth inside a toilet of a factory in Gazipur's Kaliakoir.

According to the company, Hamida Akhter, a skilled worker, suddenly fell sick in the afternoon and contacted the factory's medical centre complaining of abdominal pain.

"When the doctor asked her about the cause of the abdominal pain, she did not inform about her pregnancy," read the statement, adding that she instead took rest as per the doctor's

## RE-VOTING FOR 3 DSCC WARD COUNCILLORS All winners are pro-AL

Two Awami League-backed candidates and one rebel contestant of the party were elected councillors in three wards under Dhaka South City Corporation where three centres saw re-voting yesterday.

Sultan Miah and Noor Hossain won in ward 8 and 53, while rebel candidate Mir Samir won in 34.

Polling at the three centres -- Kamalapur Sher-e-Bangla High School in ward 8, Jurain Ashraf Master Adarsha Uchcha Bidyalaya in ward 53, and Suritola Govt Model Primary School in ward 34 -- was suspended by the Election Commission on April 28, as the

chief election commissioner (CEC) claimed that the situation in those centres went out of their control on that day.

During a visit, no BNP men were seen in the first two centres except in Suritola.

According to presiding officers, 62.47 percent of the votes were cast in Suritola, 20.16 percent in Jurain, and 29.56 percent in Kamalapur.

Voting in these centres was held again for the post of only general councillor because the number of voters did not influence the results of mayor and reserved women councillor candidates, said EC officials.

No incident of violence was reported, and additional law enforcers were deployed to maintain law and order.

## Blogger Rajib killing case sent to speedy trial tribunal

A speedy trial tribunal will now try blogger Ahmed Rajib Haider murder case which was pending with a Dhaka court.

Rajib, an activist of the Shahbagh movement demanding death penalty for war criminals, was hacked to death in the capital's Pallabi on February 15, 2013.

In a gazette notification, the law department of the home ministry on May 5 ordered the authorities concerned to send the Rajib murder case to the Speedy Trial Tribunal-3 of Dhaka for its quick disposal.

The fourth additional metropolitan sessions judge's court sent the case to the tribunal yesterday.

Meanwhile, Rajib's father who is the complainant of the case, and two more witnesses yesterday appeared before the court to give their statements.

Earlier on March 18 this year, the Dhaka court framed charges against the chief of militant group Ansarullah Bangla Team and seven former students of a private university.

The seven students are Redwanul Azad Rana, Md Faisal Bin Nayem alias Dweep, Maksudul Hasan alias Anik, Md Ehsan Reza alias Rumman, Nayem Sikdar alias Iraj, Nafis Intiaz and Sadman Yasir Mahmud.

Of them, Rana is on the run and the charge was framed against him in his absence. In the charge sheet, Rana was shown as the mastermind of the killing.
