An Awami League leader was hacked to death in Ichhapur area under Patnitala upazila of Naogaon district early yesterday.

The victim is Shafiqul Islam, 40, son of Setabuddin of Boran village in the upazila. He was a joint secretary of Patnitala union unit of the ruling party.

Officer-in-Charge (investigation) Abu Bakar Siddique of Patnitala Police Station

quoted family members as saying that Shafiqul went out of his house, receiving a phone call at around 12:30am and did not return home.

Locals found Shafiqul's body in Ichhapur area in the morning and informed the police. Police went to the spot around 10:00am, recovered the body and sent it to Naogaon

The body bore stab wounds, police said, adding that they are trying to unearth clue to the murder and arrest the culprits involved.

MASSIVE IRREGULARITIES

HSC exam centre in Barguna cancelled

Probe body recommends legal action against 9 teachers

Barisal Secondary and Higher Secondary Education Board has cancelled a running HSC examination centre in Amtali upazila town of Barguna district as massive 'irregularities' were found there during the public examinations.

The decision was taken in a meeting of the examination committee at the board office on Monday afternoon.

They also decided to take the rest of the examinations at Patuakhali Government Women's College from tomorrow, said Liakot Hossain Jewel, college inspector.

Apart from this, the board authorities took decision to suspend nine teachers of different colleges from all kinds of examination related activities till further decision, he said.

The copy of the reports was already sent to the Ministry of Education and Directorate of Secondary and Higher Secondary Education to take further step over the matter, said Jewel, a member of a probe body formed to investigate into the irregularities.

Earlier, a three-member probe body, led by Abdul Motaleb Howlader, secretary for Barisal Secondary and Higher Secondary Education Board, visited the spot on Sunday.

They later collected pieces of evidence and documents in this regard and took statements from the upazila nirbahi officer, principals of different colleges, teachers, journalists, policemen and local people as well, said sources. According to the report

submitted on the same day, the examination committee took the decision. "We recommended to the

higher authorities for taking lawful steps against the nine teachers for their involvement in helping the students to adopt unfair means in the centre," said Jewel. From the beginning of

HSC examinations under the board held at Amtali College Centre, a group of teachers captured pictures of the question paper on their cellphones about 15 minutes before start of the examinations and sent it to outside where another section of teachers supplied answers to the examinees in the centre.

Later, various reports were published in different media over the issue.

A total of 931 examinees of all five colleges in Amtali upazila are taking part in the public examinations this year.

Minor girl strangled

A two-year-old girl was killed allegedly by her neighbour at Chhaikola Purbapara village in Chatmohar upazila yesterday.

The deceased is Humaira Akhter Jim, 2, daughter of Abul Bashar of the village.

Police also arrested Sabina Khatun, wife of Soleman Mia of the village, for her alleged involvement in the incident.

Quoting locals, police said Sabina took Jim in her lap and later took the baby girl to her living room. She strangled the kid and kept the body underneath a bed.

During a search, family members spotted the body of the girl in Sabina's room and informed the police, Subrata Kumar, officer-in-charge of Chatmohar Police Station, said adding that they are trying to unearth the motive behind the killing.

BGB, local admin work to ensure peace in Kurigram enclaves

Border Guard Bangladesh (BGB) along with the local administration are closely working with the people of 12 Indian enclaves in the district to ensure peace and control the law and order situation as the land boundary agreement (LBA) between Bangladesh and India awaits implementation. Earlier on May 6, Indian

Lok Sabha passed a bill to implement the LBA with Bangladesh, a move welcomed by thousands of people living in 162 enclave areas along the border of the two countries as it is expected to end their 68year-long captive life.

There are 12 Indian enclaves in Kurigram district of Bangladesh and 18 Bangladeshi enclaves in the

Cooch Behar.

Lt Col Jakir Hossain, commanding officer of Kurigram Battalion 45 of BGB, said he along with the district's Assistant Superintendent of Police Masud Alam has recently visited five enclave areas in Bhurungamari upazila under the district and found the people in a festive mood there. No untoward incident

has been reported so far and the administration has urged all the people for assistance in maintaining law and order in the coming days, he said. However, local people


