## Destiny boss Rafiqul Amin denied bail

The High Court yesterday denied bail to two Destiny Group high officials, including its Managing Director Rafiqul Amin, in two cases filed by the Anti-Corruption Commission.

The two--Rafiqul and Destiny Multipurpose Cooperative Society Ltd Chairman Mohammad Hossain--are now in jail in the cases on charge of misappropriating around Tk 4,200 crore through Destiny Tree Plantation project and the cooperative society.

The bench of Justice Md Moinul Islam Chowdhury and Justice JBM Hassan, however, directed the jail authorities to provide proper treatment to Rafiqul, as his lawyer Ajmalul Hossain informed it that he is seriously ill.

The court rejected their bail petitions considering the gravity of offences allegedly committed by the Destiny officials, ACC lawyer Khurshid Alam Khan told The Daily

On August 10, 2014, the HC issued two rules upon the ACC and the government to explain why Rafiqul and Hossain should not be granted bail in the cases.

# NEC likely to approve Tk 92,500cr ADP today

UNB, Dhaka

The National Economic Council (NEC) today is likely to approve a Tk 92,500 crore annual development programme (ADP) for the 2015-16 fiscal year's budget, giving highest priority to the transport sector considering the development of the communication sector and the implementation of the Padma bridge project.

NEC Chairperson and Prime Minister Sheikh Hasina will preside over the meeting at the NEC conference room in the capital's Sher-e-Bangla Nagar.

Out of the proposed ADP allocation, Tk 58,000 crore will come from the local sources while Tk 34,500 crore from project assistance, said a highly placed source at the Ministry of Planning. The proposed new ADP for FY'16 is Tk

12,185.48 crore or 15.17 percent higher than the original ADP size of Tk 80,314.52 crore in the FY '15 and also Tk 17,500 crore or 23.33 percent higher than the revised ADP allocation of Tk 75,000 crore in FY '15.

The official also said the proposed ADP would also have Tk 3,996.92 crore allocation against the ongoing self-financed projects funded by the autonomous bodies and corporations thus raising the overall ADP size to Tk 96,496.92 crore.

The planning ministry official said the transport sector would get the highest allocation of Tk 20,235.91 crore or 21.88 percent of the ADP allocation followed by the power sector with Tk 15,485.17 crore resource development, rural infrastructures or 16.74 percent of the allocation, physical planning, water supply and housing sector with 3rd highest Tk 10,458.89 crore or 11.31 percent, education and religious sector with Tk 10,039.03 crore or 10.85

percent, rural development and rural insti tution sector with Tk 8,433.91 crore or 9.12 percent, health, nutrition, population and social welfare sector with Tk 6,081.18 crore or 6.57 percent of the ADP outlay while the agriculture sector would get Tk 4,734.96 crore or 5.12 percent of the ADP The fresh ADP for the next fiscal year is

854 investment projects, 132 technical assistance projects, 12 projects from the Japan Debt Cancellation Fund and 125 projects from the autonomous bodies and corporation's own fund. The proposed new ADP also kept some 857 unapproved projects without alloca-

Besides, some 40 projects will be kept for implementation under the Public-Private-Partnership initiative.

A planning commission member wishing anonymity said with the implementation of the proposed ADP, it was expected that the target of socio-economic development and economic growth would be achieved through expansion of the economic activities, creating more employment opportunities, development in the transport and communication sector, power and energy sector development, improvement in health and education, human development, ensuring food security and poverty alleviation.

Earlier on May 7, an extended meeting of the planning commission recommended the Tk 92,500 crore ADP.

Saptashi Das, general secretary of Sylhet district unit Chhatra Union, suffered heavy bruises in the arms and legs, while the unit's treasurer Roni Das and Udichi's Sylhet unit joint secretary Shah Newaj Shohag sustained minor wounds in the arms, Roni told The Daily Star from MAG Osmani Medical College Hospital where all three were admitted.

He said the attack came 30 minutes after Chhatra Union activists stopped BCL's Sylhet district unit President Shahriar Alam Samad when he was driving his motorcycle speedily through the procession, which was headed towards the Central Shaheed Minar.

"We tried to stop him but he was defiant. Initially he didn't say anything. But he came with a gang and attacked us when we were about to end our rally at the Shaheed Minar," he said.

There were 15-20 attackers, and they were carrying iron rods, hockey sticks, and bamboo poles, said Paplu Bangli, president of Sylhet city Chhatra Union.

## 7 charges accepted against 5 'Razakars' of Kishoreganj

Tribunal also issues fresh arrest warrants against four of them, seeks report on their whereabouts from IGP by May 31; sends three Jessore war crime suspects to jail

International Crimes Tribunal-1 yesterday accepted seven war crimes charges against five alleged Razakars of Kishoreganj's Karimganj upazila, issuing fresh arrest warrants against four who are absconding, and asked the inspector general of police to submit a report on their whereabouts by May 31. Gazi Abdul Mannan, 88, was the alleged commander

of Karimganj Razakar camp, while Nasiruddin Ahmed, 62, his brother Shamsuddin Ahmed, 60, who is now in jail, Hafiz Uddin, 66, and Azharul Islam, 60, were alleged Razakar members. The prosecution on May 10 pressed the charges,

including mass killing, murder, confinement, torture, arson and looting committed in the upazila between August 25 and November 13 during the 1971 Liberation War.

#### THREE "RAZAKARS" SENT TO JAIL

Meanwhile, the three-member tribunal led by Justice M Enayetur Rahim sent three war crimes suspects to jail after law enforcers produced them.

Police arrested Billal Hossain, Akram Hossain and Ozehar Moral in Jessore yesterday, Prosecutor Rezia Sultana Chaman told The Daily Star. The tribunal on Tuesday issued arrest warrants against

11, including the three, alleged members of the Razakar Bahini, the Pakistani occupation army's auxiliary force, in Jessore during the Liberation War.

The suspects were allegedly involved in rape and killings in Jessore's Keshabpur upazila.

The others, Ibrahim Hossain, Sheikh Majibur Rahman, Abdul Aziz Sardar, Aziz Sarder, Kazi Oahidul Islam, Lutfar Moral, Abdul Khaleq Moral and Mushiar Rahman, are on the run, said Rezia. According to the investigator, the suspects were "asso-

ciates of Sakhawat Hossain", a former Jamaat-e-Islami and BNP lawmaker from Jessore now in jail over a war crimes case.

The prosecution said while investigating the war crimes allegations against Sakhawat in Jessore, the investigation officer found involvement of the 11 in several crimes.

The tribunal had earlier directed the prosecution to submit formal charges or a progress report into the investigation against Sakhawat on May 17.

## Youth kills cousin after abduction

The body of an abducted boy was found in a drum of his cousin's room at Bagadi Kandapara village in Araihazar upazila of Narayaganj on Tuesday night.

Police said Maksudul Islam Tuhin, 7, son of Nasir Uddin, went missing while he was playing before their house on Friday. Later, someone demanded Tk 20 lakh as ransom from the victim's father over the phone. Nasir lodged a general diary with Araihazar Police Station.

On suspicion, police detained victim's cousin Mahfuzul Islam from Narsindi after he claimed that he was also abducted by the same gang while he was trying to locate the "missing" boy.

During interrogation, Mahfuzul said he strangled Tuhin, also a student of class II at Khaira Brac School, and dumped the body in the drum in his room over a family feud, Alamgir Hossain, officer-incharge of the police station, told The Daily Star.

After the killing, Mahfuzul staged a drama of abduction of the boy and his own to conceal the crime committed by him, said the police official.
