## Gulshan, Niketan, Baridhara get 100 CCTV cameras

A total of 100 closed-circuit television (CCTV) cameras were installed in the capital's Gulshan, Baridhara and Niketan yesterday with an aim to tighten surveillance in the neighbourhoods. Dhaka Metropolitan Police will maintain the cameras, bought with funds from different businesses and organisations and at the initiative of Gulshan Society, Baridhara Society, Niketan Society, and Gulshan Youth Club. Commerce Minister Tofail Ahmed, Inspector General of Police AKM Shahidul Hoque, DMP Commissioner Md Asaduzzaman Mia, President of Gulshan Society ATM Shamsul Huda, Dhaka north's Mayor Annisul Haq, local lawmaker AKM Rahmatullah, and Director General of Rapid Action Battalion Benazir Ahmed were present on the occasion.

## Innocent student killed 'mistakenly' in clash over land

A college student was hacked to death in an attack launched "mistakenly" on him by a group of people thinking him "a member of their rival group" soon after their clash over a disputed land in the capital's Pallabi yesterday.

The deceased, Abdur Rahman Chanchal, 23, son of Harash Miah, was a first year degree (pass course) student of Bangabandhu College at Pallabi. He also ran a stationery shop with his brother near their house at Uttar Kalshi.

Locals said there had been a long standing dispute between Momin Baksh and Shainuddin over a piece of land in the area. About 9:30am, the two groups clashed near the stationery shop that left five people injured.

Locals said when Chanchal went to the stationery shop around 10:00am, one clashing group with local weapons chased him mistaking him as a member of their rival group.

## DOUBLE MURDER IN PALLABI Business partner remanded

The business partner of a man, whose wife and uncle were killed in Pallabi two days ago, was remanded by a Dhaka court yesterday.

Ashrafal Alam Chisti Shahin, managing director of electrical equipment supplying company Independent Power Ltd, will be interrogated in police custody for four days.

He was shown arrested in a murder case filed by Zahidul Islam, the widower of Sweetie Khatun, 25.

Sweetie, chairperson of Independent Power, and Zahidul's uncle Aminul Islam, 46, were hacked to death in her house on Wednesday.

The case statement says Zahidul, a sub-assistant engineer of Dhaka Electric Supply Company Ltd (Desco), also director of Independent Power, had disputes with Shahin over partnership of Independent Power.

Sources at Dhaka Medical College morgue said Aminul's body bore nine wounds, while Sweetie sustained one injury.

Police were trying to unearth the reason behind the murder and also suspect Zahidul.

coordination, errors and irresponsibility. The three-member tribunal led by Justice Obaidul Hassan also asked all the alleged contemnors living in Bangladesh to be present at court on June 10.

If convicted, the 23 may face the highest one year's imprisonment or a fine of up to Tk 5,000 or both. On December 2, 2014, the tribunal found Bergman, editor (special reports) of New Age, guilty of contempt for two of his blog posts of January 2013 on the verdict of Abul Kalam Azad, known as Bachchu Razakar.

It sentenced him to imprisonment "till rising of the court" that day and fined him Tk 5,000.

On December 20, 2014, the daily Prothom Alo ran a report titled "50 people express concern over Bergman's punishment" on the basis of the statement, which observed that the tribunal's order would restrict freedom of expression.

One signatory, Khushi Kabir, later withdrew her name. The tribunal exonerated 26 signatories who sought unconditional apology.

Yesterday the defence lawyer, Akhtar Imam

said the prosecution's allegation about the signatories was "very unfortunate."

"The prosecution should have thought (about it) before talking about them," said Imam.

The tribunal responded saying that they were also aware about the status of the signatories and their contribution to society and the newspapers published the statement as they were "very important persons".

"But they can also make mistakes," said Justice Hassan, adding, "No one is above law, and law will take its own course."

STATEMENT IN BANGLA AND ENGLISH

Following the tribunal's order, Hana Shams Ahmed, one of the signatories who sent the statement to the media, on Tuesday submitted the original statement, one written in Bangla and the other in English.

The tribunal found some discrepancies between the two versions. Prothom Alo published the report on the basis of that written in English.

Imam yesterday said most of the signatories gave their consent reading the statement written

in Bangla and his clients neither read the one in English nor gave consent to it.

"The matter involved 50 people. Some might not have read the whole thing," said Imam.

"You (signatories) are responsible persons. Why would you be irresponsible? Why would you not read (the statement) before giving a signature?" said Justice Hassan.

"They should have done that," admitted Imam.

Hana said, "All the signatories gave their consent to the one written in Bangla. I did not take anyone's consent over the one written in English."

"You all behaved irresponsibly...Why have you taken the matter lightly," asked Justice Hassan.

ADMITTING IRRESPONSIBILITY Shahidul Alam, one of the alleged contemnors, said, "However, we cannot disown the English one."

"There are some lack of coordination, errors and irresponsibility...However, only Hana or a single person is not responsible (for it). We all are responsible for it," he added.
