On information, a firefighting unit from Companiganj upazila headquarters went to the spot and extinguished the blaze after an hour of frantic efforts. By this time, fuel trader Abdul Halim was burnt to death and the shops were gutted.

Fourteen people were sued yesterday on charge of killing Abu Sadat Khaled Mosharraf, a student of Mawlana Bhashani Science and Technology University in the district.

Mosharraf's father freedom fighter Shahidul Islam filed the case with Tangail Model Police Station in the evening, said Mostafizur Rahman, officer-in-charge of the PS.

"We do not want to disclose the names of the accused for the sake of investigation," said the OC, adding that soon after filing of the case, it was shifted to the Detective Branch (DB) of police in the district.

Earlier on Friday, Shahadat Hossain, registrar of the university, lodged a complaint with the police station, accusing 10 identi- upazila of Mymensingh fied and 20 unidentified people in this connection, said police.

Mosharraf, a master's student of criminology and police science department, was seriously injured in a clash between two rival groups of students on the university campus on May

Two other students also sustained stab injuries during the incident, said campus sources.

The clash took place between the two rival groups of students--one led by Monir and another by Mosharraf-- in the Cafeteria area over establishing supremacy on the University Sharif campus.

Under various pretexts, Principal Riazul Islam forced the 13 students of the madrasa to pay him Tk 1,000 each from their stipends on the following day, alleged education officer

Shamser Ali Mandal. He would forward the application to his district officer for necessary action, said Shamser Ali.

Contacted, the principal declined to make any comment on the issue.

Schoolgirl killed after rape, two arrested

A schoolgirl was killed after rape at Char Talpatti-Narashing village in Gangachara upazila on Thursday.

The victim, Shaheena Khatun, 14, was a Class III student of Ananda School in the area, and daughter of Ayub Ali of the village.

Family sources said Abujer Rahman, 20, son of Shamsul Alam of the village, used to stalk the girl on her way to school for long.

As Shaheena refused to his love proposal a few days ago, Abujer became very furious.

In absence of her parents, Abujer along with his friend Nazir Hossain, 22, son of Motiar Rahman of the same village, picked up the girl from

her house on Thursday night.

They took the victim to a nearby bamboo cluster,

raped her and slit her throat. Locals found the throatslit body in the bamboo cluster on Friday morning and informed the police. They also caught Abujer, suspecting his involvement in the incident and handed him over to police.

The law enforcers recovered the body and sent it to Rangpur Medical College Hospital morgue for autopsy. The victim's father filed a

rape and murder case with Gangachhara Model Police Station on Friday night.

During primary interrogation, Abujer confessed to killing Shaheena after rape, said Md Abdul Mannan, officer-in-charge of the police station.

According to his confessional statement, police later arrested Nazir Hossain, said the OC.
