EU wants restriction, Dhaka for protection

With a series of deadly trafficking incidents across the Mediterranean and Southeast Asian coasts coming to the fore, nine European Union envoys in Dhaka yesterday asked the government to effectively check illegal and risky migration, especially to Europe.

EU Ambassador and Head of Delegation Pierre Mayaudon led the meeting with Foreign Secretary Md Shahidul Haque at the ministry yesterday morning.

The envoys said it was not possible to host the illegal migrants as many of the EU countries were facing serious economic crisis, meeting sources told The Daily Star.

However, the Bangladesh side stressed for a permanent solution to the issue concerning Rohingyas, the Myanmar citizens who comprised the majority of the illegal migrants opting for the risky journey following persecution at home, added the sources.

ISI suspect arrested in Gazipur

A Pakistani citizen was arrested at a garment factory in Gazipur last night by police who say he is a member of Inter-Services Intelligence, the largest of Pakistan's three intelligence services.

Khalid Niyamot, 50, hid his identity to enter in 2014 and take a job in the factory of Unilance Textile Limited in Bhangna Hati in Sreepur and continued his stay although his visa expired recently, said Inspector Mominul Islam of the Special Branch at the Gazipur superintendent of police's office.

Khalid was taken to the district intelligence office for interrogation after being detained around 7:00pm, he said, adding that a press briefing would be held today.

Enamul to stay press minister in New Delhi for one more year

Univ Teachers' Demand for Equality with Govt Bureaucrats Movement spreading

Teachers' associations at Dhaka and Chittagong universities yesterday rejected the proposed pay scale for public servants, saying it had downgraded, disgraced and discriminated against them and demanding that their scale be that recommended for government bureaucrats.

Dhaka University Teachers Association (Duta) announced an emergency meeting with representatives of fellows in 36 public universities at the DU teachers' club on June 5 at 5:00pm to fix their next plan of action.

Chittagong University Teachers Association (Cuta) declared holding a protest rally and forming a human chain in front of the CU administrative building at 11:00am today.

National Pay Commission handed over the recommendations on December 21, 2014 to Finance Minister AMA Muhith, who says it would be finalised by July or August.

Several hundred teachers joined a human

chain Duta organised at the base of Aparajeya Bangla, reports our DU correspondent.

They demanded a separate pay scale for teachers, upgrading the vice-chancellor's rank to that of principal secretary or cabinet division secretary, withdrawal of the recommendation to abolish selection grade and time-scale, provision to be provided cars like secretaries and allowance for books and research.

Duta President Farid Uddin Ahmed accused bureaucrats of only ensuring their personal benefits.


