## ASSAULT ON JOURNOS AT JU Victims seek punishment for BCL activists

Demanding punishment for the Bangladesh Chhatra League activists who allegedly assaulted several journalists recently, the victims, Jahangirnagar University teachers and students formed a human chain on the campus yesterday.

The programme was organized under the banner of Jahangirnagar University Journalists Association.

Prof Khabir Uddin, president of JU teachers' association, and Prof Mafruhi Sattar, secretary; Jony Alam, president of Juja, and Mamunur Rashid, secretary; and Prof Rasheda Akhtar, director of JU student welfare and counseling centre, among others, addressed the programme.

Later, they handed over a memorandum to Vice Chancellor Prof

Farzana Islam also seeking security for journalists on the campus.

On Tuesday, at least three reporters were assaulted and three BCL men were injured during a factional clash on the JU campus allegedly over sharing the money one group obtained out of a bidding process.

BCL insiders said two expelled BCL leaders, Abdur Rahim Jewel and Sanowar Hossain, helped a wood trader of Savar win a Tk 1.45 lakh contract for removing the trees destroyed by storms on the campus, but actually the two used the trader's name to get the work for themselves.

## Maheshkhali war crimes suspect dies in DMCH

A war crimes suspect died around 2:45pm yesterday after being admitted to Dhaka Medical College Hospital on Monday with old-age complications.

Arrested at Cox's Bazar's Maheshkhali upazila on Sunday, Moulavi Samsuddoha, aged around 100 years, fell sick after being produced on Monday before International Crimes Tribunal-2 which then asked the jail authorities to provide immediate treatment.

The body will be handed over to family member today after an autopsy.

Samsuddoha is among seven arrestees of Maheshkhali against whom the tribunal issued warrants over crimes committed during the 1971 Liberation War.

Police say arrest warrants have been issued against 12 others on the run.

## HUMAN TRAFFICKING 7 divisional spl tribunals to be formed

Says law minister

Law Minister Anisul Huq yesterday said the government will form seven special tribunals at seven divisional headquarters of the country to try and punish the offences of human trafficking, and curb such crimes.

District and session judges concerned will conduct the tribunals, which will be established under the Human Trafficking Deterrence and Suppression Act 2012, the minister said while talking to reporters after a meeting with Swedish Ambassador Johan Frisell at his Secretariat office.

The minister said there were 557 cases, filed on charges of human trafficking, pending with different courts across the country. Charge sheets were submitted in 257 cases and trial proceedings of 12 cases have been finished, he said.

Meanwhile, a writ petition filed by the National Forum for Protection of Human Rights was moved before the High Court seeking its order on the government to immediately take steps to rescue the Bangladeshis stranded in sea and detained in different camps abroad.

## KISHORI UNNAYAN KENDRA IN GAZIPUR Guard jailed for sexual harassment of females

A Gazipur mobile court yesterday jailed a security staff of Kishori Unnayan Kendra for one year on charges of physically and sexually harassing the inhabitants of the centre.

The convict is Kawser Bhuiyan, 30, son of Harish Bhuiyan of Kishoreganj's Abdullahpur village.

Executive Magistrate in Gazipur Snigdha Talukder passed the order.

Snigdha told The Daily Star over the phone that Additional District Commissioner SM Mostafa Kamal along with other senior administrative officers went to the centre yesterday morning on a regular visit when a number of girls complained to them about the mistreatment by the guard.

A mobile court was immediately set up there and the accused confessed to his crime.

On Tuesday, Chief Justice Surendra Kumar Sinha at a programme said after a recent visit to the shelter home he found that a number of girls had been getting sexually assaulted for years and awaiting trials.

government for strict enforcement of House Rent Control Act 1991 to prevent the capital's house owners from arbitrarily raising and taking in advance rent.

The next month, the court issued a rule asking the government to explain why it should not be directed to enforce the law properly.

During the hearings, Manzill prayed for HC directives on the government so that the transactions took place through banks so as to ensure the government can collect due revenue.

The house owners arbitrarily increase rent and evict tenants without notice defying the law, he argued.

The attorney general's office opposed the petition saying there were several government rent controllers for disposing of the allegations.

at the maintenance, repairing and overhauling (MRO) plant and work for completing the MRO unit for the Mi series helicopter overhauling was at the final stage.

"I hope such establishments would help the air force achieve self-reliance and create scope for earning foreign currency through conducting overhauling activities of the aircraft and helicopters of foreign air forces."

She also asked the air force personnel to be careful in flying and maintaining the L-410 aircraft which were procured with taxpayers' money.

According to the air force, the government approved the procurement of L-410 on June 26, 2014.

Consequently, 103 Air Transport

Training Unit (ATTU) started its journey from April 15, 2015.

This unit will operate Czech Republic made three L-410 aircraft. Four pilots and 23 airmen were trained.

The aircraft will be primarily utilised for conversion, instructor, airmen, aircrew and air movement procedure training and air navigation.

Besides, the aircraft can be used for SAR mission, aerial survey and photo reconnaissance, paratroopers and aerial delivery. With two pilots and capacity of 19 passengers, the aircraft has a maximum range of 1,400 kilometres.

Hasina said a contingent of Bangladesh Air Force comprising 110 members and three helicopters would soon join the United Nations peacekeeping mission in Haiti.

Demanding immediate arrest and the highest punishment for those who gang raped a Garo woman in the capital, Bangladesh Adivasi Chhatra Sangram Parishad rallied on the Dhaka University campus yesterday.

It also demanded that the government ensure security for all the indigenous people of the country.

If the government does not investigate the rape incident properly and fails to ensure justice, they will go for tougher movement, said Ananta Dhamai, president of the parishad.

Nine student organisations, including Garo Student Union and Pahari Chhatra Parishad, expressed solidarity with the rally.

Bangladesh Chhatra Front also brought out a procession on the campus protesting the incident.

### Main accused in Savar gang rape case held

Police last night arrested the prime accused in the gang rape of a female garment worker in Narayanganj 16 days ago from Dhaka. Bus driver Chand Miah alias Chandu, 45, was held from Savar Bus Stand area, said Sonargoan police.

On May 11 night, the garment worker was raped allegedly by Chandu, his helper Rubel and two others inside a moving bus while she was returning home. The following day police arrested Rubel. The other two are still on the run.

### Dudu of BNP gets bail

The High Court on Tuesday granted ad-interim bail to Shamsuzzaman Dudu, an adviser to BNP Chairperson Khaleda Zia, in four separate vandalism and arson cases.

The cases were filed on November 5 last year and January 5, 8 and 10 this year for vandalising passenger vehicles and hurling petrol bombs at those during agitation programmes enforced by the BNP-led 20-party alliance.

Shamsuzzaman cannot get released since he is arrested in several other cases, said his lawyer.
