Land claimant produces HC bar postponing two-day drive STAFF CORRESPONDENT

Bangladesh Inland Water Transport Authority (BIWTA) along with the Dhaka district administration yesterday demolished 10 makeshift structures of a private business, Agrovita Limited, to free the river Turag in Deur Mouja in the capital.

The land claimant encroached upon around two bighas of the river beyond the foreshore demarcation pillars with 10 semi-concrete structures meant for a picnic site and a reinforced concrete wall, said Shaid Ullah, an acting BIWTA joint director at the Dhaka port.

They could not remove the wall and had to postpone the second day of the two-day drive due to a court ruling, he said. "The land claimant

brought a High Court ruling barring the eviction," said Faruq Hossain, Savar assistant commissioner for land, acting as SEE PAGE 5 COL 2

# Making other people happy is super-happiness

Nobel winner Prof Yunus tells Social Business Academic Conclave in Dhaka; urges participants at Social Business Youth Summit to become entrepreneurs rather than employees

"Making money is happiness; making other people happy is superhappiness."

Nobel laureate Prof Muhammad Yunus made the simple statement when explaining the concept of social business, his brainchild, to a dominantly young audience in the capital yesterday.

Money and profit for one's own development cannot be the sole incentive for doing business but rather there can be joy in solving people's problems, the economist told the Social Business Academic Conclave 2015 at Eastern University.

Separately, the Nobel peace prize winner called on the youth to unleash their untapped entrepreneurial skills to create businesses instead of running after jobs.

"All human beings are born entrepreneurs without exception. But the society has erased the entrepreneurial skills from them. We have to undo it," the founder of Grameen Bank told the Social Business Youth Summit 2015 at the capital's Krishibid Institution.

#### EMPLOYMENT CREATES UNEMPLOYMENT

At Eastern University (EU), Prof Yunus started off with the story of microcredit and how he linked it to solve sanitation problems in villages through social business ventures.

Social business is one that solves

problems, he said. The micro-lender said the present financial system based on the theory of pursuing self-interests would not be sustainable. It destroys the creative employee, he added. "It is employment which created unemployment."

He urged the youth to be jobcreators not job-seekers. "If the 85 lakh uneducated women of Grameen Bank can become entrepreneurs why can't the educated youth become entrepreneurs?" he asked. "You need to come up with small ideas to solve big problems."

## Islamic Foundation fatwa incorrect

Prime Minister Sheikh Hasina tells cabinet meeting, says she herself offers prayers in chairs during flights

Prime Minister Sheikh Hasina yesterday termed incorrect as per religious guidelines the recent Islamic Foundation fatwa stating it was illegal to offer prayers in mosques by sitting on chairs.

There is no such bar in Islam, sources quoted her as saying to ministers at the weekly cabinet meeting at Bangladesh Secretariat. She added that during flights she herself offered prayers on chairs.

When she wanted to know more about the fatwa from Religious Affairs Minister Matiur Rahman, he stated to have no idea and that he had arrived straight from Mymensingh.

He assured looking into the matter consulting officials of Islamic Foundation, which is under the ministry.

The fatwa, comprising 12 points, was issued through a press statement on May 31. It was dated May 19 and signed by Mufti Mohammad Abdullah of the research wing.

Abdullah categorically stated that even bringing chairs into mosques was illegal as it spoiled the formation of prayer congregations and the mosque's interior beauty.

### BNP to go for protest if no Teesta deal

Otherwise, we will raise our voice," BNP vice chairman Abdullah Al Noman told a programme at the capital's Jatiya Press Club, marking the 34th death anniversary of party founder Ziaur Rahman. Referring to recent media reports that BNP has changed into a pro-India political party now, he said, "BNP is a liberal political party that always upholds people's interests."

BNP wants a due share of the
