to gang-raping Garo woman STAFF CORRESPONDENT

One of two men, arrested over the recent gang rape of an indigenous woman in the capital, gave a confessional statement before a Dhaka court yesterday in the case filed with Bhatara Police Station.

In the deposition, Ashraf Khan alias Tushar said he and Jahidul Islam Lavlu, now on a 10-day police remand, lured the woman offering jobs. They forced her into a

microbus in Kuril bus stand area and took turns in committing the crime in the moving vehicle, he said, adding that there was no other person. The victim in her statement said there were five perpetrators.

The two were drivers of a garment buying house at Gulshan.



Court orders re-investigation COURT CORRESPONDENT

A Dhaka court yesterday ordered further investigation into the death of fouryear-old Jihad who died after falling into a deep

well last year. It also asked detective police to submit a complete report after the victim's father Fakir filed a noconfidence petition against the investigation.

Fakir alleged that Shahjahanpur Police Sub-Inspector Abu Zafar left out four Bangladesh Railway officials from the chargesheet despite having evidence of their culpability in primary investigation.

The officials are the general manager of Bangladesh Railway and its three engineers.

Jihad fell into the abyss, some 40 yards from his house at Bangladesh Railway Colony in the capital, while playing with friends. His body was pulled out by a band of indomitable volunteers the following day, around 15 minutes after the fire service called off a near 23hour search in the 17-inch diameter abandoned shaft.

Two people -- Jahangir Alam, a senior sub-assistant engineer of the railway, and Abdus Salam, a railway contractor who installed the well -- were charged with negligent homicide of Jahid on May 21. Jahangir is on the run and Salam is in jail.

Human traffickers must get harsh punishment

Victim families, survivors, experts demand at consultation of National Alliance for Migrants' Rights, Bangladesh

Migration experts, development workers, and families of trafficking victims and survivors yesterday demanded that the government identify the human trafficking gangs immediately and ensure harsh punishment for them through trial to stop the heinous crime.

The law enforcement agencies concerned must be sincere in arresting traffickers overcoming all barriers and bringing them to justice; otherwise the criminals will remain unscathed, they said.

"There are many good laws in Bangladesh to protect the victims of trafficking in the country. Unfortunately, there is no coordination among our government and civil society, politicians and law enforcers to deal with the issues," said Mohammad Harun Al Rashid, regional coordinator of CARAM Asia, a regional network working on migration and health issues.

It is urgent to raise a voice concurrently to stop trafficking, he told a national consultation, "Irregular Migration to Malaysia", organised by the National Alliance for Migrants' Rights, Bangladesh (NAMR,B) at the capital's Brac Centre. "There are allegations that brokers have close connections with politicians and law enforcers," he said.

Referring to Prime Minister Sheikh Hasina's recent remarks on trafficking victims as "unfortunate", Harun said she should clarify her speech; otherwise the victims or their families would feel unsafe in seeking assistance of law enforcement agencies.

At a meeting with labour and employment ministry officials on May 24, the prime minister described those who go abroad illegally to find work "mentally sick" and said these people were tarnishing the country's image, reported state-run BSS news agency.

Harun, a migration expert, said the

government should take practical steps to stop trafficking, which was occurring mainly due to a lack of rule of law, good governance and social justice. Shaheen Anam, executive director of

Mentioning that at least 88,000 migrants from Myanmar and Bangladesh embarked on sea voyages between 2014 and March 2015, Stina Ljungdell, country director of UN refugee agency UNHCR in Dhaka, said the illegal journey across the

"It is urgent to make a regional agreement so that people don't cross the sea illegally. To address the root causes of this problem, it is essential to attack criminal gangs in a comprehensive manner," she said, adding that a regional taskforce needed to be created to check the crime.

The UNHCR representative also mentioned that it was crystal clear that people from Malaysia were also involved in the crime as they hired illegal workers for cheap labour.

Two trafficking survivors -- Md Siraj from Cox's Bazar and Rezaul Karim from Sirajganj -- and family members of some other victims shared their stories.

Mokabbir Hossain, director (finance and admin) of the Bureau of Manpower, Employment and Training (BMET); Asif Saleh, a senior director of Brac; and Syed Saiful Haque, chairman of WARBE Development Foundation, also spoke.

AL-led govt revitalised Indo-Bangla relations Say Sector Commanders

India-Bangladesh relations suffered many conflicts and bitterness for decades but have been revitalised in recent years under the leadership of the ruling Awami League-led government, said Sector Commanders Forum (SCF) leaders yesterday. Although the two neigh-

bouring countries had an inseparable relationship during Bangladesh's birth, relations deteriorated after Bangabandhu Sheikh Mujibur Rahman's assassination in 1975, they added. The SCF leaders were

SC lifts HC stay on Rajshahi Mayor Bulbul's suspension

The Supreme Court yesterday stayed a High Court directive that halted the government's order on the suspension of Rajshahi City Corporation Mayor Mosaddek Hossain Bulbul.

Chamber Judge of the Appellate Division Justice Hasan Foez Siddique passed the order following a government appeal moved by Attorney General Mahbubey Alam seeking a stay on the HC order.

The appeal has also been forwarded to the full bench of the apex court for its hearing on June 14.

Earlier on May 28, following a writ petition, the HC had stayed the suspension order issued after police had charged him in some criminal cases.

Deputy Attorney General Khandaker Diliruzzaman told The Daily Star that Bulbul cannot function as the mayor following the SC

order. The Local Government Division on May 7 suspended Bulbul under section 12(1) of the local government (city corporation) act, 2009 saying that the court accepted charges against him in three cases after police pressed the charges.
