TV reporter, host sued over defaming ex-minister Hasan

Former environment and forests minister Dr Hasan Mahmud yesterday sued a reporter and a host of Jamuna TV for defaming him by disseminating "false" information.

According to the case statement, staff reporter Sazzad Parvez and anchor Mir Ahsan falsely claimed in a report aired on June 5 that the minister is chairman of Shukhi Bangla Foundation and he embezzled climate fund through this NGO. The report titled "Jalabayu Tahobil Nay Chhay" (misap-

propriation of climate fund), part of the television's "Investigation 360 Degree" programme, also said the minister spent Tk 35 crore only on 200 caged birds under the "Sheikh Russel Aviary and Eco-park" project in Rangunia upazila of Chittagong, added the complaint.

The court of senior judicial magistrate, with which the defamation case was filed, asked the two people accused to appear before it one month later.

Dr Hasan Mahmud said he had not had any relation with

the NGO since 2006 and he did not embezzle any fund. Meanwhile, Sukhi Bangla Foundation's General

Secretary Salah Uddin lodged another case against the two with the same court over the same allegations.

Jamalpur gets three police helpdesks for female victims

Ananta Murder

to jail after remand

A Sylhet court sent photojournalist Idris Ali to jail yesterday, after a seven-day remand in connection with the murder of blogger Ananta Bijoy Das.

Idris Ali, 30, a photojournalist of local daily the Sobuj Sylhet and The Daily Songbad, was brought to Sylhet from Dhaka on Sunday night.

Mirza Abdullahil Baqui, special superintendent of Criminal Investigation Department (CID) in Dhaka, said in remand, they have gleaned new information from Idris regarding the murder which needs to be investigated.

Inspector Arman Ali of CID, Dhaka said they have found evidence that links Idris to the murder of the blogger.

He added that CID suspects that Idris is a member of banned radical Islamist outfit Ansarullah Bangla Team.

Ananta Bijoy Dash was hacked to death by men armed with machetes in Sylhet town on May 12. The following day, Ananta's brother Ratshawar Das filed a case with Sylhet Biman Bandar Police Station accusing four unknown assailants of the murder.

SEXUAL ASSAULT ON FEMALES

Photojournalist sent DU sees another day of protests

Dhaka University (DU) yesterday saw another day of protests against recent countrywide incidents of sexual assaults on females with demonstrators ending up having a scuffle with police and submitting a memorandum at the prime minister's

Since April 14, when some 20 females faced the assault during Pahela Baishakh celebrations, around 70 socio-political and cultural organisations, either independently or in separate groups, have staged

demonstrations nearly every single day. The protests led to confrontations with

police using truncheons, tear gas and allegedly rubber bullets though yesterday's one, organised by Bangladesh Nari Mukti Kendra and Bangladesh Samajtantrik Chhatra Front, was limited to a scuffle.

There have been around five attempts to lay siege to the home ministry, with one by Bangladesh Chhatra Union on May 10 ending up leaving 34 activists and leaders injured and a female activist harassed.
