

RADAR PURCHASE GRAFT CASE Trial of Ershad resumes after one year

After a year of adjournment on different excuses, the prosecution yesterday again started placing argument in the Radar purchase graft case against Jatiya Party Chairman HM Ershad and three others.

A Dhaka Court fixed July 13 for the next hearing of the case after hearing arguments of Public Prosecutor Mir Ahmed Abdus Salam from the first information report (FIR) of the case.

Earlier on June 11, 2014, Dhaka Divisional Special Judge Abdur Rashid refused to hear the argument and transferred the case to the yesterday's court for its disposal.

During the hearing, Ershad was not present in the court as his lawyer represented him while two others—former air chiefs Sultan Mahmud and Mamtazuddin Ahmed—were in the dock. Another AKM Musa, director of United Traders Ltd, has been absconding.

The now-defunct Bureau of Anti-Corruption filed the case against the then military dictator Ershad and four others on May 4, 1992. The court framed charges against Ershad, Sultan, Mamtazuddin and Musa on August 12, 1995.

According to the case statement, Ershad in collusion with others had allegedly caused a loss of Tk 64.04 crore to the state exchequer by purchasing radars from the US instead of France for the air force while he was in power.

ARSON CASES Ex-lawmaker of BNP Papiya sent to jail on surrender

Former BNP lawmaker Syeda Asifa Ashrafi Papiya was sent to jail after she surrendered before a Dhaka Court yesterday in nine arson cases filed against her and several other party leaders during the BNP-led 20-party alliance's anti-government movement in January, February and March this year.

Three metropolitan magistrates rejected her all the bail petitions in the cases and ordered to send her to jail.

Earlier on May 25, Papiya got four weeks ad-interim anticipatory bail from the High Court that directed her to appear before the lower court on expiry of the bail period.

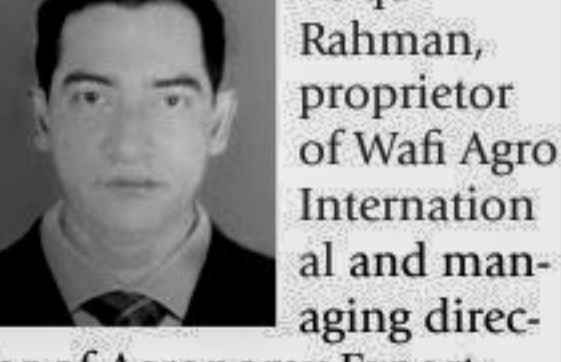


Rahima Khondoker, mother of Sadharan Bima Corporation Director AK Mizanur Rahman, FCA, died on Friday. She was 77.

CURBING CUSTODIAL DEATHS Law enforcers should send details of victims to NHRC

70pc complaints against them, says Prof Mizan

The number of deaths in custody will come down to near zero if law enforcers submit pictures and papers of the deceased to the National Human Rights Commission (NHRC) immediately after their deaths, the commission chairman said yesterday.

"We are yet to realise how contemptuous and shameful the custodial deaths are for the state," Prof Mizanur Rahman told a discussion on the Torture and Custodial Death Prevention Act 2013. He said custodial deaths would continue to happen as long as politicians viewed extra-judicial killings as something acceptable.

"About 70 percent of the complaints of violation of human rights received by the NHRC are against law enforcers and about half of all complainants raise allegations of torture by law enforcers," he said. The NHRC will look into the complaints and submit its findings to the home ministry, he said. "We would like to see what action the ministry takes against them."

None of the law enforcement agencies sent representatives to the seminar, organised by the NHRC at The Daily Star Centre in the capital. "We repeatedly contacted high officials of both Rab [Rapid Action Battalion] and police and invited them to join the discussion," he regretted.

Prof Mizan recommended that the home ministry should stop custodial torture and deaths and ban arrests by law enforcers in plainclothes.

Director and legal adviser of Bangladesh Legal Aid Services Trust (BLAST) SM Rezaul Karim said the general people were not aware of the Torture and Custodial Death Prevention Act. "Even if they are, victims of torture often do not have the courage to sue law enforcers," he said, adding human rights groups should be allowed to file cases on the victims' behalf. He also pointed out that investigations into such cases would not be impartial, as police personnel would be investigating their colleagues' crimes.
