## Dhaka, Colombo for freeing media of religious militancy

Agree to sign MoU on sharing state-owned media content

UNB, Dhaka

Information Minister Hasanul Haq Inu and Sri Lankan Mass Media and Information Minister Gayantha Karunathilaka yesterday stressed the need for keeping the mass media free from religious militancy and inappropriate contents to uphold democracy.

At a meeting in Colombo, they also agreed to conclude a memorandum of understanding on sharing contents between state-owned news agencies and electronic media, and producing cinema in joint ven-

Inu is heading a delegation in his two-day visit for enhancing cooperation between the two countries' mass media and sharing technical experiences in related fields, said a media release.

The two ministers laid emphasis on training of the officials engaged in institutions of information and media, and holding regular film festivals in each other's country. The Sri Lankan counterpart expressed interest in learning from Bangladesh's experience of implementing right to information act, and introducing community radio.

It is the first ministerial- level bilateral visit between the two countries after the incumbent government assumed power in Sri Lanka in January 2015.

Inu reached Colombo on Tuesday and is expected to return home tomorrow.

Defence counsel SM Shahjahan yesterday read out before the Supreme Court the statement Prof Anisuzzaman made during the trial of war crimes convict Salauddin Quader Chowdhury about the killing of Nutun Chandra Singha during the country's Liberation War.

It was the second day of hearing on the appeal filed against the death penalty given to Salauddin by the International Crimes Tribunal-1 on October 1, 2013 for committing crimes against humanity during the war.

Meanwhile, convicted war criminal Mahidur Rahman filed an appeal with the Supreme Court on Tuesday challenging a verdict of the International Crimes Tribunal-2 that had sentenced him to jail till death. SC will now fix a date for hearing the appeal.

The tribunal on May 20 this year sentenced Mahidur and Ashraf Hossain Chutu of Shibganj upazila under Chapainawabganj to jail until their death for committing crimes against humanity during the Liberation War. Chutu is yet to file an appeal against his verdict.
