UN seeks to eliminate peacekeeping sex scams

To eliminate sex abuse from UN peacekeeping missions, the first major review of operations in 15 years recommends that countries which flout children's rights be barred from blue helmet missions.

A panel headed by Nobel Peace Prize winner Jose Ramos-Horta was tasked with rethinking peacekeeping at a time when UN missions are increasingly under threat and increasingly asked to manage conflicts.

out the mission last year before recent allegations implicated UN peacekeepers in sexual abuse in Haiti and Liberia, and French troops in Central African Republic.

On Tuesday, he submitted his report to UN Secretary General Ban Ki-moon.

A summary of the report, obtained by AFP, recommends that troops from countries that flout the rights of children in armed conflict be excluded from UN peacekeeping missions.

The United Nations publishes annual lists to shame countries with questionable records on children and armed conflict, and on conflict related sexual violence.

The report also recommends that disciplinary action -- or the lack of it taken by troop contributing countries be disclosed.

Six-month deadlines should also be imposed on investigations, compared to an average 16 months, and an effective and adequately resourced victim assistance program" set up.

Peacekeepers' immunity from prosecution must not mean impunity, and should not be extended to UN personnel alleged to have committed sexual exploitation and abuse, the summary recommended.

Dhaka Metropolitan Magistrate's Court that he along with Bakhtiar and two other friends were going to Dhanmondi from Moghbazar by a black Prado jeep of Bakhtiar's mother, said court sources.

There was a traffic jam on the road on the eve of Pahela Baishakh. As the vehicle got stuck in a tailback at New Eskaton, Bakhtiar, who was in a drunken stupor, became annoyed. He lowered a window of the vehicle, and shot five times from his firearm, Kamal said in his testimony. Kamal, also business partner of

Bakhtiar, said he didn't hear anyone scream or moan in pain after the shots were fired. Magistrate Aminul Haque recorded Kamal's statement at his

chamber after the witness was taken there by the investigation officer of the case filed in connection with the shooting and the killing of two per-Rickshaw-puller Abdul Hakim and auto-rickshaw driver Yakub Ali were critically wounded after shots

were fired at random from the jeep around 1:30am on April 14. Hakim died 16 hours after the shooting, while Yakub died on April

Meanwhile, Bakhtiar's brother

Ahmed Tanvir Alam appealed to the court for permission to take back their mother's black Prado jeep seized by police.

The court directed the investigation officer to report within five days on whether the vehicle should be handed back to its owner.

The Criminal Investigation Department of Police is carrying out a ballistic test to find out whether the bullets found inside the bodies of the two victims were fired from Bakhtiar's licensed pistol, said police.

Briefing reporters at the DMP Media Centre yesterday, DMP spokesperson Monirul Islam said, "If the ballistic report proves that the shots were fired from Bakhtiar's licensed pistol, we will ask the authorities concerned to cancel his firearm licence.'

An official of the Detective Branch of Police said they were looking into whether Bakhtiar had obtained the licence with valid documents.

Seeking anonymity, the official involved in the probe said they had collected a copy of the licence, and sent it to the authorities concerned on June 13 for scrutiny.

Bakhtiar obtained the licence in March 2010 from the Dhaka District Administration on grounds of "personal security".

section of the city wall is believed to have been uncovered at the Sanxingdui site in Sichuan province, dating back more than 3,000 years to the Bronze

A complete picture of the city has now come to light, as the east, south and west parts of the wall had already been uncovered, reported the People's Daily Online.

Three Neolithic tombs, including a complete human skeleton, believed to predate the walls have also been unearthed.

Even the finger bones of the skeleton, thought to be that of an ordinary civilian, remain.

Experts say the discovery of the city walls means they have finally been able to confirm that the site was indeed a former city, rather than simply a sacrificial site.

Sanxingdui is believed to have once been the largest city in southern China during the Shang Dynasty between 1600 BC and 1046 BC, and may have had its own emperor.

The ancient Chinese city is even older than Rome, which was founded in 753 BC.

But Sanxingdui remained hidden for thousands of years, and was only discovered again in 1929.

Archaeologists found two large thousands of Bronze Age artefacts.

Experts warn of possible famine in North Korea

North Korea's food supply faces a gloomy forecast this year due to a damaging drought which has sparked fears of worsening shortages in the impoverished communist country, experts said yesterday. Concern grew after Pyongyang's

official Korean Central News Agency (KCNA) reported Tuesday that North Korea has been hit by its worst drought in a century. "The worst drought in 100 years continues in (North Korea), causing

great damage," it said, adding more than 30 percent of paddy fields across the country were "parching up". The North's main rice-growing provinces -- South Hwanghae, North

Hamgyong -- have been badly damaged by a severe drought, KCNA said. It is hard to get reliable information on the reclusive state, but South Korean weathermen said this year's

"It is true that the northern part of the peninsula has been battered by a severe drought so far this year," Kim Young-Jin, an official at the Korea Meteorological Administration, told

"The North's traditional rice belt encompassing South and North Hwanghae provinces has been hit hard, receiving less than half the rain of an average year," he said.

Last week the South's unification ministry predicted North Korea's food production this year could fall by as much as 20 percent from last year if the shortage of rainfall lasts until early

distinctly gloomy, given a prolonged drought and lack of fertiliser, it said.

North Korea has imported a large amount of fertiliser from China each year but fertiliser imports this year have dwindled significantly from a year ago, said Kwon Tae-Jin, a

researcher at GS&J Institute, a Seoulbased think tank on agriculture. "I don't think the North's exaggerating ... The situation looks pretty serious," he said, adding drought has already damaged the spring harvest of wheat, barley and potatoes, which

In the past two years, North Korea has managed to avoid a food crisis despite a damaging drought, largely because of no summer flood and a favourable weather ahead of the main

He claimed that the relations between the two sides were fine. Meanwhile, State Minister for

Home Asaduzzaman Khan Kamal told journalists at the Secretariat yesterday that it was not a case of abduction, rather a result of a misunderstanding.

"Probably their [BGB] transport [boat] got stuck in the fishing nets and crossed over into their [Myanmar] territory which led to the misunderstanding and some exchange of fire," he said.

The BGB fired nine to 10 bullets, he

added. He also said after finding out the reasons leading to the misunderstanding, the BGB and the BGP would be more alert to avert such incidents in

On May 28 last year, the BGP without any provocation shot at a BGB patrol team at Naikkhangchhari border in Bandarban, leaving BGB nayek Mizanur Rahman dead.

The Myanmar force then intruded into Bangladesh and took away his body, his firearm and ammunition, creating tension at the border.
