Charge framing hearing July 6

A Sylhet court has fixed July 6 for the charge framing hearing in the murder case of former finance minister Shah AMS Kibria.

Acting judge of Sylhet Speedy Trial Tribunal Monirul Islam Patwary, also district and sessions judge, set the date yesterday. Among the 32 accused in the case,

20, including Habiganj Municipality Mayor GK Gous, were present in the Speedy Trial Tribunal Public Prosecutor Kishor Kumar Kar said: "Court fixed July 6 for the next hear-

ing. The charge will be framed the

same day." On June 11, Habiganj District and Sessions Judge Md Atabullah sent the case to the tribunal. On June 2, Judicial Magistrate's Court of Habiganj transferred the case to the District and Sessions Judge's Court.

On January 27, 2005, Kibria, among five, was killed in a grenade attack during a public meeting in Habiganj.

Govt asks them to move by Nov 30

UNB, Dhaka

As part of the implementation of the Land Boundary Agreement (LBA), interested people living in enclaves will have to go to their mainland either in Bangladesh or India after selling their immoveable assets by November 30. Those want to go either to

Bangladesh or Indian mainland will be able to carry their moveable assets, said a PID handout yesterday. If anyone wants to continue with

Indian and Bangladeshi citizenship, he or she will have to complete all the formalities by November 30 and will have to go to either Bangladesh or Indian mainland.

Travel pass will be issued for moving from one country to another at that time, the official release said.

It also mentioned that a joint team will take opinions from the people living in the enclaves in the first and

second weeks of July. The LBA will be implemented with effect from midnight of July 31.

3 killed as clashes grip Ukraine

Ukraine yesterday reported the death of two soldiers, while pro-Russian rebels accused Kiev's forces of killing a civilian as fresh clashes preceded peace talks aimed at ending the 15-month

Kiev military spokesman Andriy Lysenko said two government troops were killed and six wounded in mortar fire and shelling across swathes of the eastern separatist Donetsk province over the past day.

Lysenko told reporters that "activity had especially picked up" around the industrial Sea of Azov port of Mariupol that the rebels have been trying to seize to establish an export gateway for the steel and coal mines they now control.

Insurgency commander said that shells from Kiev-held positions around the city of Donetsk had killed a civilian and wounded two others in the rebels' main stronghold.

Separatist negotiator Denis Pushilin called the reported attack "a grave violation of the Minsk agreement" that Russia and Ukraine signed in mid-February during talks involving the leaders of Germany and

France. The four countries' foreign ministers are due to meet in Paris tomorrow to try to salvage the accord.

June has witnessed an upsurge in violence that has killed more than 50 people after a three-month lull.

Kiev sounded a pessimistic note about the odds of diplomats being able to reverse that trend.

"Paris must not turn into another blathering session," Ukrainian Foreign Minster Paylo Klimkin said.

"Either we achieve concrete results, or we demonstrate clearly that Moscow does not want to fulfil the Minsk agreements," he said on Saturday.

Ukrainian President Petro Poroshenko will send his personal envoy to Minsk tomorrow to meet Pushilin and other rebels for their own round of European-mediated talks, after a similar meeting last week ended in deadlock.

"With progress like this, the chances of a complete political settlement of the conflict are in grave doubt," Pushilin said.

The two predominantly Russianspeaking provinces of Lugansk and Donetsk have been waging a war for independence from Kiev's new pro-

Tribunal recalls arrest order

Earlier on June 10, the tribunal found Zafrullah guilty of contempt of court and imprisoned him at the courtroom for an hour for criticising punishment of Bangladesh-based UK journalist David Bergman. The tribunal also ordered him to pay Tk 5,000 in fine within seven days, in default of which he would have to serve one month in prison.

However, the Supreme Court on Tuesday stayed the tribunal's verdict until July 5 following a petition moved by the convict. Justice Hasan Foez Siddique, chamber judge at the Appellate Division of the SC, also sent the petition to the full bench of the court for hearing on

Meanwhile, the three-member Tribunal-2 led by Justice Obaidul Hassan on Thursday issued an arrest warrant for Zafrullah after the deadline for payment of Tk 5,000 expired on Wednesday.

Neither Zafrullah nor his lawyer informed the tribunal about the SC

found Bergman, editor (special reports) of English daily the New Age, guilty of contempt for writing two blog posts in January 2013 on the verdict in the case against Abul Kalam Azad. The journalist was sentenced to imprisonment till rising of the court that day and fined Tk

The daily Prothom Alo on December 20 last year ran a report headlined "50

people express concern over Bergman's punishment". The signatories of a statement said the order would curb freedom of expression, according to the report. One of the signatories, Khushi Kabir, later parted from the

statement. When the tribunal asked the other 49 to explain their statement, 26 of them apologised unconditionally. The court exonerated them from the charge but initiated contempt proceedings against the rest as it was not convinced with their replies.

On June 10, the tribunal pardoned 22 signatories as they regretted their action and "were not well aware of the consequences of the action". But the court punished Zafrullah as he committed the same offence twice.

Earlier, the International Crimes Tribunal-1 had found his comment on the war crimes trial contemptuous but pardoned him with a serious caution.

Under the International Crimes (Tribunals) Act, 1973, a contempt convict cannot challenge the order of a tribunal. But the High Court has recently observed that a convict can do so.

DHAKA SURPRISED

According to sources at Bangladesh's foreign and home ministries, the government is surprised at the Myanmar authorities' unusual delay in sending back Razzak.

Dhaka is showing a high degree of tolerance with intent to maintain friendly relations with its neighbour.

It is making diplomatic efforts to bring back the BGB man, but the Myanmar government was yet to say clearly when he would be sent back, they said.

However, State Minister for Home Affairs Asaduzzaman Khan Kamal told reporters yesterday that Razzak might be released any time.

The Myanmar authorities and the BGP have conveyed to the BGB that they would return Razzak any day, he said.

Seeking anonymity, a government high-up in Dhaka said, "The Myanmar authorities' attitude is simply unacceptable, and not that of a good and friendly neighbour."

BGB's tough stance against smuggling

The nondescript house in the remote Tetulia village had assumed a carnival-like atmosphere ever since Mustafizur grabbed a five-for on his debut on Thursday. The carnival only got bigger and more joyous as the young boy grabbed a six-for yesterday to etch his name in the record books. Mustafizur's father Abul Kashem Gazi watched the match surrounded by his family, relatives and

neighbours. "I am so happy that my son is playing so well. I always believed he would do something like this," said Gazi, who was panting in excitement as he spoke over phone while watching the match. "Everyone here, my relatives and neighbours who have come to watch the match with us, are all happy that our own Mustafizur is contributing so greatly to this victory over India."

The excitement and joy rang in a similar tone in Sonadanga, where Mustafizur's mother was visiting his elder brother Mahfuzur Rahman. When called for comments, Mahfuzur said he always had faith in his brother, but even he was completely taken aback by what transpired over the last few days. "We all knew Mustafiz was very

talented. Whenever any foreign team came to Bangladesh to play, Mustafizur was called to bowl at the nets and people came out with a good word or two about him. And then when he played for the under-19s or the Dhaka Premier League or National League, he always earned the

affection of his coaches, despite being very shy, due to the potential he

showed," said an elated Mahfuzur. "But the way my brother played holding his nerve and showcasing al of his guile to grab 11 wickets in two matches, even took me by surprise,'

added the proud brother. Mustafizur's mother, Mahmuda Khatun, said she was happy like everyone and hoped that her son would continue to serve the country

this way for a long time. Back here in Dhaka, losing captain Mahendra Singh Dhoni reserved the best praise, albeit a technical one, for the youngster at the post-match press conference.

"His [Mustafizur] hand speed is good and there is no difference between the slower one and normal delivery. The slower one travels to the keeper which does not happen in case of other pacers," analysed the India captain. Dhoni's analysis sums up the

reason the touring batsmen failed to get the better of Mustafizur yesterday, even after working on his deliveries thoroughly over the last couple of days.
