### PROTESTING VAT ON PVT UNIVERSITIES Cops foil march to finance ministry

Police yesterday foiled a procession of private university students, which was heading to besiege the finance ministry at Bangladesh Secretariat demanding withdrawal of the 10 percent value added tax (VAT) imposed on private universities.

Beshorkari Bishwabiddaloy Shikkha Adhikar Andolon formed a human chain in front of Jatiya Press Club before marching towards the secretariat.

Faced with barricades and some 200 armed personnel, they then staged a sit-in in front of Bangladesh Medical Association Bhaban, threatening to besiege the Prime Minister's Office.

The protesters said the 10 percent VAT, to be charged on admission and course fees, would make education a "product" rather than a "right".

They gave a seven-day ultimatum to fulfill their demand and threatened to march to the cabinet on June 30.

Later, some students of private universities and medical colleges held a human chain at Shahbagh, saying around four lakh students were studying in 160 private universities, medical and engineering colleges and claiming that it cost them Tk 18-25 lakh for studying at private medial colleges and Tk 4-17 lakh at private universities.

#### DEFAMATION CASE AK Khandker gets bail

MA Ihshaq Bhuiyan, a Mujib Bahini member, filed the case with a Brahmanbaria court on

September 10 last year. The court on March 23 this year summoned Khandker, who was the deputy chief of Staff of the **Bangladesh Armed Forces** in 1971, to appear before it on June 25 in the case.

### ICDDR, B'S THERAPEUTIC FOOD FOR INFANTS

# Government to form review committee

The government has decided to form a committee to review the newly developed therapeutic food for children suffering from severe acute malnutrition (SAM).

It will also form another committee to review the national guidelines for managing acute malnutrition in Bangladesh, said Nasreen Khan, an official of the health ministry, at a discussion on management of SAM children in the country yesterday.

The two committees would be formed within a week with relevant ministry representatives, experts concerned and other stakeholders, she said.

"We will sit to take a decision about the issues pending," said National Professor Dr MR Khan, a child health expert, addressing the programme as chief guest.

The move was made following a recent debate over ready-to-use therapeutic food (RUTF) Sharnali 1 and Sharnali 2 developed by icddr,b.

The two food items made of locally available ingredients -- rice, lentil, chickpea, milk powder, sugar and soybean oil -- are rich in energy and protein that have been proved successful in treating SAM children, icddr, b

said. Bangladesh Breastfeeding Foundation Chairperson Dr SK Roy and Adviser Dr MQK Talukder, meanwhile, opposed the idea of introducing any RUTF in Bangladesh and wrote to the health ministry to stop icddr,b from promoting it.

They argued that it would eventually lead to commercialisation of baby food, promote use of powdered milk and discourage breastfeeding.

Dr Makhduma Nargis, additional secretary at the health ministry; Dr Mohammad Shahidullah, president of Bangladesh Paediatric Association, and representatives from UN Food and Agriculture Organization, World Food Programme and World Health Organization also spoke.

### DU English masters students boycott semester final exam

The first semester masters students of English department of Dhaka University yesterday boycotted the semester final examination, claiming that they had not got adequate time for preparation and the admission process was incomplete. The exam was scheduled for 9:00am yesterday but none of the 150 students sat for it.

The students claimed that their honours final examinations were held in January and they were supposed to get the results within 21 days. But, their results were published on May 27 and they received the mark sheets on June 11, so they could not complete their admission process on time.

Earlier on Sunday, the students besieged the vice chancellor's office for about two and a half hours demanding postponement of the exam.

They said they were ready to start taking the exams on June 27. However, the university authorities said already the exam was postponed once. VC AAMS Arefin Siddique said they would not postpone the exam again.
