SI Belal suspended

The police authorities yesterday suspended Sub-inspector Belal of Detective Branch of police in Cox's Bazar for his alleged involvement in Yaba smuggling.

Confirming the suspension, Tofail Ahmed, additional superintendent of police in Cox's Bazar, told The Daily Star that Belal went into hiding soon after Rapid Action Battalion arrested ASI Mahfuzur Rahman of Special Branch (SB) of police, Dhaka, and his

driver Jabed Ali on Saturday night. Meanwhile, a Feni court yesterday placed ASI Mahfuzur on a three-day and Jabed on a two-day remand in connection with a case filed for smug-

gling Yaba. The Court of Senior Judicial Magistrate Alamgir Mohammad Faruqui placed them on remand after investigators sought a 10-day remand for each, reports a Feni correspondent.

Rab handed the duo over to the Feni police on Sunday night. Later, a Rab official filed a case with Feni Model Police Station, accusing the two for smuggling narcotics.

A team of Rab-7 arrested Mahfuzur, 35, and Jabed, 29, and seized around 6.8 lakh pieces of Yaba tablets worth Tk 27 crore from a car on the Dhaka-Chittagong highway in Feni on Saturday night.

They were carrying the Yaba pills in a black Toyota Allion car, believed to be owned by Mahfuzur's father, from Cox's Bazar to Dhaka, Rab officials said.

The elite force claimed Mahfuzur admitted to them that he was a member of a smuggling syndicate of several unscrupulous policemen, including SI Belal.

The syndicate members are from Special Branch (SB) of police in Dhaka, Chittagong district range police, and Detective Branch (DB) of police in Cox's Bazar.

They were using their professional dentity as shield for their illicit trade, Rab officials claimed.

18 more victims return home

Eighteen more human trafficking victims returned home from Indonesia early today, around four months after they were rescued from a boat in the Andaman Sea.

A flight of Malaysian Airlines carrying them landed at Shahjalal International Airport at 12:25am, Mohammad Shakil Mansoor of International Organisation for Migration (IOM) told The Daily Star.

The Bangladeshis were brought back home after confirmation of their

nationality by police. The Bangladesh foreign ministry in association with the IOM arranged their repatriation, added Shakil.

Foreign ministry officials and representatives of the IOM received the returnees at the airport. They had been at shelter homes in Indonesia. Eighteen more victims would return

home by another flight of Malaysian Airlines early on Wednesday and 24 others early on Thursday, said Shakil.

Over 100 Bangladeshi trafficking victims returned home from Thailand, Malaysia and Indonesia this month.

Somali troops stage raid on 'senior' Shebab leaders: official

Somalia's security agency said yesterday it carried out a night raid on key Sunday. targets inside a Shebab-controlled town in southern Somalia, targeting "senior" commanders.

Internal security spokesman Mohamed Yusuf Osman said that members of the US-trained National Intelligence and Security Agency (NISA) carried out the attack inside Bardhere town, a stronghold of the Somali-led Al-Qaeda affiliate in Gedo region. "The specially trained security forces raid.

have carried out a well orchestrated attack at key targets inside Bardhere district and they have returned safely after the operation," he said.

Osman said a police station and the district headquarters used by Shebab fighters and leaders were targeted in the raid.

"Our forces interrupted a very senior level meeting of (Shebab) leaders. The intelligence we had indicated the meeting was to plan for more attacks in Somalia and Kenya," NISA

said in an emailed statement, which described the raid as "retaliation" for a Shebab attack in Mogadishu on

NISA sources said that a Shebab leader known as Yusuf Haji was killed in the operation and they were working to confirm whether senior Shebab commanders, including intelligence chief Mahad Karate and Kenyan university massacre mastermind Mohamed Mohamud -- also known by the aliases 'Dulyadin' and 'Kuno' -were in the building at the time of the

Ethiopian ruling party set to take near total election victory

Ethiopia's ruling party and its allies are expected to celebrate a near total victory in parliament yesterday with the announcement of last month's election results.

Preliminary results of some 80 percent of seats released last month said the ruling Ethiopian People's Revolutionary Democratic Front (EPRDF) of Prime Minister Hailemariam Desalegn secured all parliamentary seats so far declared, 442 out of the 547 seats up for grabs. Final results are slated to be announced at 1230 GMT. The EPRDF, in power in Africa's

second-most populous nation for over two decades, is widely expected to secure a near clean sweep of parliament, and the outgoing chamber had just one opposition MP.

African Union observers said the polls passed off without incident, but the opposition alleged the government had used authoritarian tactics to guarantee victory.

Government spokesman Shimeles Kemal has said the party's success was the result of Ethiopia's economic advances.

"Voters have credited the ruling party for the economic progress it introduced

in the country," he told AFP. "They want the continuation of this policy. In view of the weak, fragmented opposition and the lack of viable alternative, it was very likely that the ruling party would win in a landslide."

According to the electoral board, the EPRDF also took back the only seat that was held by the opposition, securing all 23 seats in the capital Addis

Ethiopia, whose 1984 famine triggered a major global fundraising effort, has experienced near-doubledigit economic growth and huge infrastructure investment -- making the country one of Africa's top-performing economies and a magnet for foreign investment.

A Taliban fighter detonated a car loaded with explosives outside parliament gates, said Ebadullah Karimi, spokesman for Kabul police, raising questions about how the driver got through several security checkpoints.

Six gunmen took up positions in a building near parliament, he said, but never breached the compound's gates. Security forces killed the six after a gun battle lasting nearly two hours.

Kabul police chief Abdul Rahman Rahimi said all lawmakers were safe. TV pictures showed the speaker sitting calmly and legislators leaving the building, engulfed in dust and

smoke, without panicking. A woman was killed and around 30 civilians were wounded in the

attack, according to Rahimi. He said the assailants were armed with assault rifles and rocket pro-

pelled grenades. Some lawmakers' bodyguards fired sporadically during the attack, hampering the response by Afghan forces, he added.

Police will investigate how the attackers got so close to parliament.
