issued arrest warrants for 63.

Aek Angsananont, police deputy commissioner-general, called the probe the biggest human trafficking investigation in Thailand's history".

Around 1,000 police officers, many of them based in southern Thailand, took part in the investigation, Aek said, without elaborating on any ongoing or future

Police have sent 19 cases filled with more than 100,000 document sheets to the Office of the Attorney General which will have until July 24 to decide whether to file charges, Aek said.

"This government has shown its sincerity in solving this problem by seriously tackling human trafficking and by dealing with those involved," Aek told Reuters.

But rights groups, including the New York-based Human Rights Watch, said the investigation would not put an end to networks operating in the region.

"It is highly likely that if this investigation turns out to just be window dressing to defuse international pressure, then it will have no impact," Sunai Phasuk, Thailand researcher at Human Rights Watch, told Reuters.

"It will just put them under ground for the time being and then resurface again."

The crackdown in Thailand, a traditional transit point, made it too risky for traffickers to land migrants, Bangladeshis and Muslim Rohingya from Myanmar, prompting them to abandon thousands at sea with scant supplies of food and water.

The United Nations estimates 1,200 people are still at sea or unaccounted for while more than 3,000 have landed since May in Thailand, Malaysia and Indonesia.

Last year, Thailand was downgraded to the US State Department's lowest category - or Tier 3 - in its annual Trafficking in Persons Report, which assess how governments around the world have performed in fighting

human trafficking. The next TIP report is expected in mid-July.

"We hope the United States will consider to put our country, which is in Tier 3, to a better tier," Aek told Reuters.

Police in neighbouring Malaysia last month discovered 139 graves in jungle camps used by suspected smugglers and traffickers. They say some 12 officers are being investigated.

against Siraj alone for the killing of more than 600 people, two against all of them for the killing of 47 people, and one against Khan Akram and Abdul Latif for killing a person.

Wrapping up its arguments, the prosecution sought capital punishment of the accused, claiming that they were able to prove all seven charges.

However, defence counsels claimed that the prosecution "simply failed to prove" the charges and sought acquittal of their clients. A defence counsel also accused the investigation officer of the case of adopting "pick and choose" policy to implicate his clients, and requested the tribunal to launch a probe against the investigator.

After hearing the closing arguments from both the prosecution and the defence, the three-member tribunal, led by Justice M Enayetur Rahim, kept the case waiting for verdict. "PICK AND CHOOSE"

Prosecutor Syed Haider Ali placed rebuttal of defence arguments yesterday. When he was placing arguments on the seventh charge, the tribunal raised question over implicating Akram in said the charge.

The charge was related to the killing of a freedom fighter allegedly by Akram, Latif and other Razakars.

According to the charge, Justice Enayetur Rahim said, the incident took place in Kachua but the prosecution did not bring the charge against the Razakars of Kachua Razakar camp, including the save his life but did not commit any camp commander. He said the prosecution brought the

charge against Akram, who was allegedly the commander of Daibaggahati Razakar camp, which was far away from Kachua. "Wasn't there any probability of local

he asked. Justice Rahim said a defence counsel had already raised a question about "pick and choose" of their clients by the investigator,

which the prosecution could not deny.

Razakars' involvement in the incident?"

Refuting the allegation of resorting to "pick and choose" policy by the investigator, prosecutor Haider Ali said eyewitnesses had testified that Akram was involved in the incident. "So there was no scope of such probability here," he added.

Justice Rahim said several prosecution witnesses, during their testimonies, told names of people who were allegedly involved in the crime, but the prosecution did not bring charges against them for the crime. The tribunal also expressed discontent over the issue.

Haider Ali said investigation was

going on against them [whose names surfaced] and they would be brought under trail.

"When? After sending them [whose names surfaced outside the border?" asked Justice Rahim.

He said the tribunal recently received a complaint which stated that the investigation agency launched a probe against a person (a war crimes suspect) one and a half years ago. But investigators did not submit the probe report against him, rather helped him leave the country, and later sought the tribunal's intervention in this regard.

Justice Rahim, however, did not elaborate on the matter.

Sarwar Hossain, who represented Akram and Latif, said his clients were placed at 86th and 105th positions in a list of 106 Razakars in Kachua submitted to the tribunal.

Apart from Latif and Akram, the prosecution did not bring charges against anyone, although many listed Razakars of the Kachua Razakar camp, including its commander, are still alive. This means that the investigator had taken the policy of "pick and choose", he

Referring to Akram's SSC certificate, Sarwar said the prosecution alleged that Akram was the commander of Daibaggahati Razakar camp but it was not "practical" since he was only 15 years and three months old in 1971.

Latif joined the Razakar Bahini towards the end of the Liberation War to crime, Sarwar said, adding, "If Latif could be charged for this reason, every Razakar should then be charged." He requested the tribunal to apply its

"judicial activism" and carry out an investigation against the investigation officer of the case for his "pick and choose" policy. Abul Hasan, the state-appointed defence

counsel of Sirajul Haque, said the prosecution failed to prove the charges, and sought his client's acquittal. BACKGROUND AND CHARGES

son comes back from school and complains about the discriminations. Tell me, which mother could bear such a pain? I feel ashamed but I can't do anything.

"Aren'twe human beings?"

Children of the Rishi families get discouraged to go to school due to the discriminations. Two of them already dropped out.

"I stopped going to school as the teachers used to tell me to clean their toilets," said one of the dropouts.

The discrimination against children is just the tip of the iceberg. The Rishi families of the village have been dealing with such prejudices of the Hindu and the Muslim communities for ages.

About a hundred of the Rishis had shown up at the yard of a temple and every one of them had a story to tell.

Nearly 900 Rishi families are living in Jessore and Magura and of them 385 families live in eight villages of Shalikha upazila.

Ranjan (not his real name), a college student, said elderly people of the Rishi families also face severe discrimination from Hindus and Muslims.

No one invites them to any social

programmes, he said. Ranjan changed his last name fearing discrimination at the college he goes to in another district.

"They do not sell us tea, they don't sell us any food at restaurants of Hazrahati market ... even the local barber does

not want to cut our hair," said Ranjan. Following a news published in a newspaper, the local administration

instructed tea stall owners to sell tea to the Rishi people. "Some tea stall owners have arranged

'special' cups for the Rishi people but most of the restaurant and tea stall owners are reluctant to serve them since others would not go to their shop if they do," said Ranjan.

When asked, a tea stall owner said Rishi people usually do not come to his stall and if they do come, he serves them tea in separate cups. Otherwise, other people would not come to his stall.

"They [Rishi people] have set up two tea stalls in the market. Actually they don't need to go to another shop," he

Ratan Biswas said he sells sweetmeats to the Rishi people but he does not allow them to eat that at his shop. "If I allow this, my business will be ruined.

Sribas Das said since barbers do not want to cut their hair, he learnt how to cut hair and changed his profession.

Ashok Das, general secretary of Bangladesh Dalit Parishad, said the government should intervene and stop such discriminations. He called for an anti-discriminatory law where these things would be treated as a criminal offence.

Mahbubar Rahman, deputy commissioner of Magura, said the upazila nirbahi officer had intervened and talked to local public representatives and shopkeepers over the matter.

"If necessary, we would take more steps to do away with such discriminations," said Mahbubar.

Chimborazo, Ecuador's highest peak. He keeps going until he reaches the ice mine that has fed him and his family for generations.

Negotiating the steep 14,700-foot path is no joke, especially at Uscha's age. But he continues the family tradition of cutting ice from the cave and shaping it into blocks. He then transports the blocks, by mule, down to the nearest city of Riobamba, where they are sold. Despite his age and his short stature

(4ft 11in) Ushca can carry two 66-lb blocks of ice on his shoulders. And he's quite happy working on the mountain that he considers to be sacred. "This is a man's work," he said, proudly. "I am happy when I walk. Father Chimborazo looks after me."

Every Saturday, Ushca travels to Riobamba's markets to sell the ice at \$2.5 for an 80-pound block. He makes about \$25 a week selling ice. Interestingly, Ushca's 'natural ice'

it has healing properties, and it is still used to make traditional fruit juices and ice creams. Ushca is a local celebrity, especially at the La Merced market where

is still in demand. People claim that

he sells ice - people flock around him asking to take pictures with him. Ushca's proudest moment though, was when he got to meet President Rafael Correa.

"My family is envious that I am a friend of President Correa," the humble man said. "I tell them, just come and do my work."

able jobs for its people under the G2G Recruitment brokers and human traffickers have meanwhile started taking advantage of the government's failure and deceiving the poor

jobseekers and luring them into taking perilous sea journey. Although there are no accurate figures as to how many jobseekers have reached Malaysia through the Bay, more than one lakh Bangladeshis are believed to have crossed the sea since 2012, according to the UN agency

Several hundred have lost their lives in the sea and at the human trafficking camps in Thailand and Malaysia, it mentions. Bangladesh Association of

UNHCR.

International Recruiting Agencies (Baira) President Mohammad Abul Bashar told The Daily Star that the government could not resolve the human trafficking problem unless available jobs were ensured for the Bangladeshis.

"Around 50,000 Bangladeshis would be able to find jobs in Malaysia every month if private recruiters are involved," he observed.

Earlier in 2009, the Malaysian government imposed a ban on recruiting workers from Bangladesh, allegedly for massive irregularities by the recruiting agencies.

After four years of the ban, the governments of Bangladesh and Malaysia resumed the manpower export through the G2G system in
