No more walkover

Nasim says AL not interested in polls win without Khaleda and BNP

Health Minister Mohammad Nasim yesterday told parliament that they were not anymore interested in winning the national elections without BNP Chairperson Khaleda Zia and her party taking part.

"We want Khaleda Zia to remain safe and sound so that she can take part in the 2019 elections. The game will be held Insha Allah in 2019. Who will we contest if you [Khaleda] are not in the field? We are not interested in a walkover. We are players and want to score by playing," Nasim said while speaking on the proposed budget for 2015-16 fiscal year.

"We will whitewash you in that battle of ballots," he added amid thumping of desks by the treasury and the opposition bench.

He also noted that the next general election would not be held even a day before its scheduled date.

Commerce Minister Tofail Ahmed has meanwhile told the House that Khaleda would have to stand in the dock one day for killing innocent people including women and children in the name of hartals and blockades.

"Khaleda has conceded defeat in all fronts; she has been defeated in movement, election and politics as she had

earlier insisted that she would not leave her office until defeating Sheikh Hasina and her government. But, the entire world witnessed with surprise that she returned home after staying at her office for 92 days," Tofail said while taking part in the discussions.

Meanwhile, BNP yesterday alleged that the government had been hatching a conspiracy to make party chief Khaleda and other top leaders disqualified from contesting the next parliamentary polls.

"A blueprint is on to keep the BNP leaders including Khaleda Zia away from the elections by filing false cases against them," said BNP spokesperson Asaduzzaman Ripon at the party's Nayapaltan headquarters in Dhaka.

He also expressed concern over getting justice in the cases.

"If the government executes such a blueprint to keep the BNP leaders away from the polls, they [government] will have to face dire consequences," he warned.

The BNP leader also lambasted Information Minister Hasanul Haq Inu for his comment that "Khaleda Zia, the queen of arson, won't get any chance to contest the 2019 elections".

He also criticised the government for building a car park at the centuriesold Lalbagh Fort by demolishing a part

Counterfeit note gangs on the go again

According to law enforcement agencies, about 15-20 such gangs are active in Dhaka while many others are busy faking notes in other cities to cheat shoppers.

Over the last few weeks, at least seven gangs were busted in Dhaka, Chittagong, and Sylhet with a huge amount of fake money, of Tk 500 and 1000 denominations, and equipment used for printing those.

In the latest bust, Rab seized around Tk 1.05 crore fake notes and equipment used for making the notes in Banashree area yesterday.

The Rab also arrested five members of the gang which was planning to make fake notes worth Tk 10 crore and circulate them across the country.

Maj Maksud said they have already alerted all Rab units about the counterfeiters and asked them to launch

meeting with law enforcers recently and asked them to go extremely tough on the gangs. "We'll give 200 fake currency detect-

ing devices to the Federation of Bangladesh Chambers of Commerce and Industry (FBCCI) so it might put the devices at key points of monetary transactions," BB Executive Director and spokesperson Mahfujur Rahman told The Daily Star yesterday. Earlier this month, two more gangs

with spurious notes worth about Tk 1 crore were captured by detectives in separate drives in Dhaka. They were set to circulate the notes worth Tk 9 crore this Eid. The materials and equipment needed for producing the notes were found in the gangs' possession, DB officials said in separate briefings

Printing and circulation of fake notes

Bangladesh Bank officials held a take place in three phases, said law enforcers. One group prepares and supplies

the special paper while another group prints the counterfeit notes. A third group circulates them, according to DB investigators who quizzed the crimi-

The production cost of fake notes worth Tk 1 lakh ranges between Tk 3,000 and Tk 3,500, said DB Joint Commissioner Monirul Islam recently.

The fraudsters sell the notes to wholesale buyers for Tk 7,000 to Tk 10,000. The wholesalers then sell them to retailers across the country for Tk 15,000 to Tk 25,000.

The retailers circulate the notes when buying goods while some of them circulate the notes through a section of unscrupulous staff of banks and ATM booths, Monirul claimed.

YESTERDAY'S SEIZURE

Acting on a tip-off, a team of Rab-3 raided Banashree in the capital around 6:00am and detained Abdur Rahim Sheikh, 35, an alleged ringleader of the fake currency making syndicate, Rab officials said during a media briefing at Rab headquarters.

Following his information, the Rab team detained four of his alleged associates and seized fake notes worth around Tk 1.05 crore from them.

The arrestees were Rahim's first wife Fatema Begum, 24, his second wife Rubina Khatun, 19, Mohammad Asad,

22, and Tajim Hossain, 26. They also seized fake currency making equipment including 11 money making screens, three boards, two high performance colour printers, two laptops, four rolls of security threads to

put inside the notes, eight reams of special paper, two jars of ink, and a high-end scanner.

Police seek seven-day remand

Detectives yesterday sought a seven-day fresh remand for Bakhtiar Alam Rony, son of ruling Awami League lawmaker Pinu Khan, for gathering more information about the double murder in the city's New Eskaton on April 14.

The court, however, fixed June 30 for hearing the prayer and asked investigation officer of the case to appear before it on the day with the progress report on the probe.

The court also sent Rony to jail and asked the jail authorities to produce him before it on June 30.

Liquid cocaine

Revenue, a Bolivian company -- Import Export Vaiven SRL -- shipped the consignment from Montevideo Port in Uruguay.

Based on intelligence from a British agency, Chittagong police on June 6 detained Golam Mostafa Sohel, finance manager of a sister concern of Khan Jahan Ali Ltd.

On Sohel's information, they with the help of Customs Intelligence identified the container and sealed it that very night.

On June 8, the container was opened and primary tests were done by Narcotics Control Department. But it found no cocaine substance in the liquid.

Customs Intelligence later had the liquid samples tested at Bangladesh Council of Scientific and Industrial Research, and Drug Testing Laboratory in Dhaka. These tests on Saturday confirmed the presence of cocaine in the barrel.

ATTEMPTS TO GET THE CONSIGNMENT RELEASED

No letter of credit (LC) was opened for importing the consignment from Bolivia, said a top police official involved in the investigation.

This was perhaps one of the reasons why consignment could not be released in more than two weeks after its arrival at the port.

And it's then Bakul Mia his two relatives entered the scene, according to investigators. "Bakul first called me on May 31

and requested me to help release the consignment," Mostafa Kamal, Bakul's cousin living in Dhaka, told The Daily Star yesterday. "He [Bakul] told me that the con-

signment belonged to a friend of his and he didn't know about the contents of shipment." Kamal engaged his nephew Atiqur

Rahman, who works for an apparels company in Dhaka, in the job. However, Atiqur failed to do so as

necessary documents were not submit- tion with the ruling party has become the House by the consignee, Khan Jahan Ali Ltd, Atiqur told this newspaper a day after the seizure.

He then wrote to the shipping agent -- Cosco (Bangladesh) Shipping Lines Ltd -- either to "re-export the consignment to the port of origin or to forward it to any Indian port", according to an email correspondence between Atiqur and a representative of the shipping agent. The Daily Star has obtained a

copy of the correspondence. "Then I contacted my uncle Bakul Mia in England. He told me to get in

touch with Sohel of Khan Jahan Ali Ltd," Atiqur added.

Sohel told police that one of his relatives from the UK had sent the consignment to him. Instead of using his own name, he used the name of Khan Jahan Ali Ltd as the consignee, said SM Tanvir Arafat, additional deputy commissioner of the Detective Branch of Chittagong Police.

Police filed a case against Sohel; Nur Mohammad, chairman of Khan Jahan Ali Ltd, and some unnamed people on Saturday night in this connection.

However, Nur Mohammad claimed that his company was not involved in

importing the consignment. "We never had any trade with Bolivia. We do not import edible oil ... We want to know how our name came up," he told a private television chan-

nel yesterday. 'WORTH TK 300 CRORE'

Moinul Khan, director general of Customs Intelligence and Investigation Directorate, said about 60kg pure cocaine can be extracted from the barrel.

Price of cocaine varies between Tk 5 crore and Tk 6 crore per kg, according to him.

This means the cocaine consignment is worth at least Tk 300 crore.
