All the 26 arrested from the cars are said to be Nizam Hazari's men.

Nizam was once Joynal's close cohort. Before that he was involved with Chittagong Chhatra League, the ruling AL's student body, and thrived as a cadre of AJM Nasir Uddin, now Chittagong mayor, controlling Agrabad area in 1991-1992. After returning to Feni in 1997, he joined Joynal Hazari's group.

Then in 2000, Nizam landed in jail in an arms case but came out of prison in 2005 securing High Court bail by submitting fake documents. Subsequently, he joined politics in 2008 and became mayor of Feni municipality two years later.

He has been at the centre of controversy since last year's brutal murder of Feni's Phulgazi upazila chairman Ekramul Haque. All the accused in the murder are close associates of Nizam and there are allegations that the lawmaker had a hand in it, which he denies.

THE RETURN OF FEAR

When Nizam Hazari entered politics in Feni in 2008, he took a stance against Joynal Hazari, his former boss, to draw public support. It worked because people were looking for a break from killing and violence. But soon, he set his eyes on the so-called "steering committee members" through whom Joynal Hazari once ran the show. Today, most of them are with Nizam, allegedly extorting money from the transport sector and controlling the district's tender and sand business worth crores of taka.

The Daily Star recently spoke to about 50 people in Feni -- locals, businessmen, politicians, law enforcers, administration officials and journalists -- to get an idea of the workings of Nizam and his gang. Few dare to be quoted for fear of reprisal, but almost all of them said Nizam started to follow in the footsteps of Joynal after becoming the Feni municipal mayor in 2010. And after winning the January 5 elections unopposed, he made the district his "own property".

"Nizam has become all in all in Feni and he controls everything," Abdur Rahman, Feni district AL president, told this correspondent.

Asked about the difference between the Joynal Hazari and Nizam Hazari era, he said, "At least some difference of opinions was allowed within the party [AL] when Joynal Hazari was there, but now no one dares to challenge Nizam."

But why so much fear? A local journalist who spoke on condition of anonymity said, "When Ekramul Haque came under attack, Eakram's men were in his car with arms. Still, they could not save him. Now how come you expect people to speak against Nizam?"

During a June 10-12 visit to the district, this correspondent found scarcely any billboard, electric pole or establishment that did not carry posters or banners showing portraits of Nizam Hazari, in a sign of his authority.

Municipal officials alleged the

district BCL grabbed most of the billboards without permission from the municipality ahead of its conference held in May.

According to the BCL constitution, its office bearers must be elected through its council and a lawmaker has nothing to do with it.

Interestingly, the billboards also had portraits of Alauddin Ahmed Nasim, who does not hold any party post now. Nasim is a former member of the AL central working committee and also former protocol officer of Prime Minister Sheikh Hasina.

Locals claim Nasim and an influential minister are Nizam's source of power.

Police records show, the district saw 15 killings since January this year and most of them are political.

The June 2 murder of Jubo League leader Azizul Haque in Sonagazi and the recent recovery of 15 firearms by Rab are the outcome of the conflict between Nizam and Rahimullah, according to locals. After becoming MP, Rahimullah,

also president of Jeddah chapter AL, took control of tender bids in his constituency, making Nizam unhappy, they said. Contacted, Rahimullah said

the killing of Phulgazi upazila chairman Ekramul. "Feni people live in terror due to his [Nizam's] extortion and tender manipulation. He has positioned his hired goons in different areas.'

According to him, Nizam collects about Tk 1 crore in extortion daily.

"From vegetable vendors to jewellers, nobody is spared. He has turned Feni into his own property," he told this newspaper by phone on Wednesday.

"I have informed the prime minister about all his misdeeds," he said, adding that Nizam and his men were not allowing him to discharge his duties or hold any meeting and was trying to control everything in his constituency as well.

However, unlike in many other districts, violence over extortion and tender manipulation is rare in Feni. It is partly because of Nizam Hazari's firm control over everything and partly because he has distributed the jobs of extortion from transport sector, tender manipulation and sand

business among his followers. They include Jubo League leaders, AL leaders, BNP leaders and Jamaat men.

and tried to free them all after the news spread. Most of the arms are licensed under names of Jubo League leaders, but at the time of the recovery they were not being carried by their

owners, Rab officials said. Locals and politicians there believe the arms recovery was a result of the conflict between Rahimullah and Nizam.

They claimed Rab also nabbed district Jubo League Convener Didarul Kabir Raton and unit Joint Conveners Swapan Miyazi and Sushen Shil from the spot, but Nizam managed to have them released. Later, Nizam and some top district AL leaders went to the Rab office to secure the release of the others but failed.

Talking to The Daily Star, the lawmaker dismissed that people were living in fear.

"Feni is a quiet place now," he

He said Feni was rife with violence when Joynal Hazari was in town. "But now it is a place of coexistence. There is no violence here." He would not comment on the

allegation that he controls tender, sand business and extortion in the district and that he gets a share of the money. Pressed, he said, "You will have

to first identify those who made the allegation."

Asked about the arrest of his men with arms, he said, "They are not my men. Rather, they are Bangabandhu and Sheikh Hasina's men. As a representative of Sheikh Hasina, I went to the spot to have them freed. But they are not my men."

one does not necessarily mean one at all - because it can actually include anything greater than or equal to a half and less than one-and-a-half. In a patent dispute between two

pharmaceutical giants arguing over who owns the royalty rights to a lucrative wound-dressing solution, their lordships sat in judgment over an issue that would have tested the mettle of the finest mathematical logicians; and in the process coined a new legal definition of "one".

It may seem odd that their lordships dare question the meaning of one - it is after all the oldest number we have. Some 20,000 years ago, someone scratched a series of notches along the fibula bone of a baboon with a piece of quartz and in the process left the earliest known record of the number one.

But that was long before the legal argy-bargy between ConvaTec, a global medical products company, and Smith & Nephew, a specialist in "advance wound management" which questioned a patent owned by ConvaTec on a wound dressing involving silver and a salt solution.

The ConvaTec patent covered any salt solution "between 1 per cent and 25 per cent of the total volume of treatment". However, Smith and Nephew devised a competing product that used 0.77 per cent concentration, bypasspatent. A previous judgment in 2013 ruled

in Smith & Nephew's favour because of a mathematical quirk known among chemists as the "significant figures rule", which is a way of taking into account errors of measurement. This judgment ruled that the patent

covered any solution greater than or equal to 0.95 per cent and less than 25.5 per cent, which meant Smith & Nephew was free to flog its multimillion pound products without paying anything to ConvaTec. So in this earlier judgment "one"

meant anything greater than or equal to 0.95 and less than 1.5, which produced an uncomfortable asymmetry that did not go unnoticed in last week's judgment. How could "one" include something that is 0.05 less but also include something that is nearly ten times this figure more - for instance 0.49 more than 1?

To correct this, the three Court of Appeal judges used a mathematical approach, known as rounding. It exploits that convention of rounding up or rounding down to the nearest whole number if there are decimal

Their lordships concluded that "one" includes anything greater or equal to 0.5 and less than 1.5 - much to the chagrin of Smith &Nephew, whose 0.77 now fell within the realm of ConvaTec's patent.

Eurozone finance ministers blamed Greece for breaking off the talks, and the European Commission took the unusual step yesterday of publishing proposals by European creditors that it said were on the table at the time.

But Greece described creditors' terms as "not viable", and asked for an extension of its current deal until after the vote was completed.

"[Rejection] of the Greek government's request for a short extension of the programme was an unprecedented act by European standards, questioning the right of a sovereign people to decide," Tsipras yesterday said in a televised address.

"This decision led the ECB today to limit the liquidity available to Greek banks and forced the Greek central bank to suggest a bank holiday and restrictions on bank withdrawals." The Greek prime minister said he

had sent a new request for an extension to the bailout. "I am awaiting their immediate response to a fundamental request of

democracy," he said. The announcement comes after a particularly turbulent few days for

Greece. The current ceiling for the ECB's emergency funding -- Emergency Liquidity Assistance (ELA) -- is €89bn

(£63bn). It is thought that virtually all

that money has been disbursed.

The ECB was prepared to risk restricting ELA because the failure of the bailout talks cast new doubt on the viability of Greek banks - some of their assets depend on the government being able to meet its financial commitments, the BBC economics corre-

Gaza a year on after war

The shelling may have stopped, but there's little relief for those left behind

No human being is advised to go for more than 24 hours without water, especially in an area like Gaza where summer temperatures regularly climb above 30C. But during the 50-day conflict with Israel that erupted a year ago this week, to seek water was to risk death.

That was what killed Doha's parents. They went out at night at the

height of Israel's aerial bombardment. "It was dangerous on the streets," said the shy 17-year-old, "but they had to make the journey so that we had some water to drink. They were very near our house when the bomb hit them. They were both killed in a huge blast." Between 8 July 2014, when Israel launched Operation Protective Edge against militants in Gaza, and 26 August, when it declared a

ceasefire, more than 2,200 Palestinians - most of them civilians,

including 551 children, according to the UN - were killed. The toll on

the Israeli side was 73, six of them civilians, including one child. Some

11,000 Palestinians were wounded and 500,000 displaced. A year on, much of Gaza remains in ruins but nowhere is the destruction worse than around Rafah. There are whole streets where nothing moves except the Palestinian flags fluttering among the heaps of rubble. During the conflict more than 12,600 houses in Gaza were destroyed and another 6,400 rendered uninhabitable. One of them belonged to Doha's family. Now the schoolgirl lives in a single room of a relative's house with her brother Mohammed, 10, and a disabled woman who Doha looks after. "Life here is desperate," she said. "We have lost our parents and our house. We have very little."

One thing Doha and Mohammed do now have is clean water. The Catholic aid agency, Cafod, supports the work of the charity Islamic Relief in the region and has funded it to install a water filter in the home. "There was a time before the filter that we didn't have clean water for five days," she said. On top of all the other miseries inflicted by the Israeli blockade on

Gaza since 2007, water has declined in both quantity and quality. What supplies there are can be expensive or dirty. "The issue of water in Gaza is beyond what you can imagine," said an Islamic Relief worker. "There is high salinity and it is full of nitrates." But with a "reverse osmosis" filter fitted to the tap and connecting pipes, any water that a family can obtain can be purified for drinking and cooking.

Doha's story is just one of many in which the inhabitants of Gaza faced the choice last summer between mortal danger and going without water. On many occasions Israel warned residents to stay indoors or to evacuate certain areas, after which anyone on the streets would be a legitimate target.
