

JU marketing master's students demand removal of teacher

Master's students of Jahangirnagar University's marketing department have submitted a written complaint against one of their teachers, demanding that the authorities remove her from all academic activities of the batch.

About 33 students out of 47 met Vice Chancellor Prof Farzana Islam on Tuesday and handed over the written complaint against assistant professor Nigar Sultana, also assistant proctor.

The students alleged that Nigar Sultana abuses her power, misbehaves with students, interferes in personal and family affairs of the students, threatens to hamper their academic life, and humiliates students inside and outside the classroom.

They threatened to boycott all academic activities if their demand is not met.

Contacted, Nigar Sultana said all allegations against her are baseless and untrue.

Workplace accidents on rise countrywide

202 workers killed in 147 accidents in last six months while 158 in 129 incidents during same period last year, says report of Safety and Rights

UNB, Dhaka

At least 202 workers were killed in 147 workplace accidents across the country during the last six months, said a report revealed yesterday mentioning that about 158 workers were killed in 129 accidents during the same period last year.

Safety and Rights Society, an NGO, made the report based on monitoring 26 daily newspapers (15 national and 11 local newspapers) between January 1 and June 30 last, which did not include the deaths of workers outside workplaces or road accidents on the way to or return from workplaces.

The report says 76 workers were killed on construction sites while 61 in factories and 47 in service organisations like hotels, workshops, power supply organisations. Besides, five workers of agriculture and 13 of transport sector were killed during this period.

Similar to the previous years, the highest number of deaths involved electrocutions,

with 49 deaths. Around 29 workers were killed in fire incidents while 23 others died after being crushed under falling machinery or heavy load or hard objects.

Executive Director of Safety and Rights Sekender Ali Mina said the actual number of the workplace deaths is almost certainly to be more than the numbers set out in the report as many workplace deaths are not reported in newspapers.

He stressed the need for significantly greater efforts on the parts of employers and owners to take measures to reduce the level of risks that workers suffer.

The report mentioned that most of the electrocutions occurred when iron rods carried by construction workers came into contact with live electric wires passing near the under-construction buildings or when the workers were involved in construction work or worked as an electrician.

State wants SC to uphold SQ Chy's death penalty

The top state counsel yesterday prayed before the Supreme Court to uphold the death penalty of BNP leader Salaudhin Quader Chowdhury for committing crimes against humanity and genocide during the Liberation War.

Attorney General Mahbubey Alam made the plea on the 10th day of hearing on the Salaudhin's appeal against his verdict given by International Crimes Tribunal-1 on October 1, 2013. The BNP leader was also given 20 years of jail in three charges while five years in two other charges.

The four-member bench of Appellate Division led by Chief Justice Surendra Kumar Sinha fixed Sunday for further hearing of the appeal. The defence counsel of Salaudhin is expected to place their arguments on the day.

Mahbubey Alam yesterday told the apex court that Salaudhin

It says that the proportion of undernourished people has been halved from 32.8 percent in 1992 to 16.4 percent in 2014-2016.

Though making good progress in reducing the number of children underweight and affected by stunting, Bangladeshi diets are still heavily dominated by rice while the amount of animal-sourced food, fruits and vegetables consumed was not up to the nutritional needs, it says.

During queries afterwards on allegations that 2 lakh tonnes of wheat recently imported from Brazil was unfit for consumption, Qamrul only said the food department's director general would comply with a High Court order of Tuesday to submit a report in 72 hours.
